MIST COVE AND PORT ARMSTRONG SPECIAL HARVEST AREAS TROLL FISHERY ANNOUNCEMENT

Sitka. . .The Alaska Department of Fish and Game announced today the following information concerning the Mist Cove and Port Armstrong Special Harvest Areas (SHA):

The Mist Cove SHA and the Port Armstrong SHA will open to commercial trolling from 12:01 a.m., August 14 through 11:59 p.m., September 20, 2014.

Mist Cove SHA (109-13): waters of Mist Cove will be open west of a line from 56°31.70' N. latitude, 134°39.97' W. longitude to 56°31.27' N. latitude, 134°39.85' W. longitude, with the following restriction:

Waters south of a line from 56°31.07' N latitude, 134°40.20' W. longitude to 56°31.07' N, 134°40.12' W. longitude are closed to commercial trolling.

Port Armstrong SHA (109-11): waters of Port Armstrong will be open west of a line from Point Eliza at 56°17.73' N. latitude, 134°38.75' W. longitude to a point on the Baranof Island shoreline at 57°17.98' N. latitude, 134°38.35' W. longitude, with the following restriction:

Waters north of a line from 56°17.61' N. latitude, 134°40.27' W. longitude to 56°17.67' N. latitude, 134°39.64' W. longitude are closed to commercial trolling.

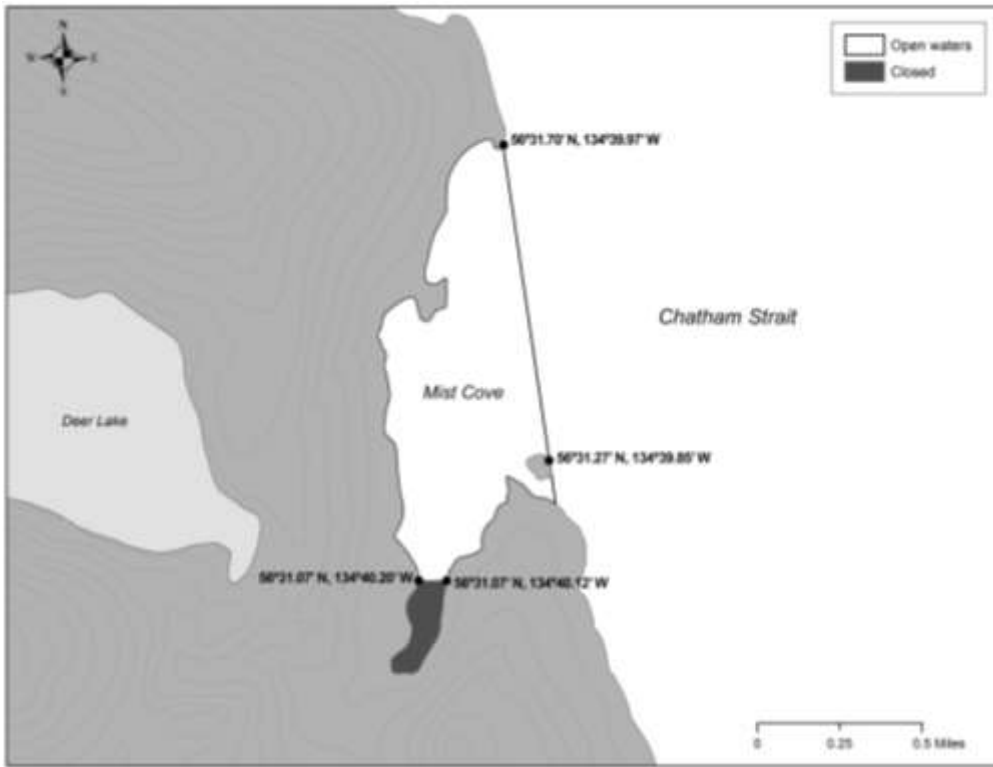

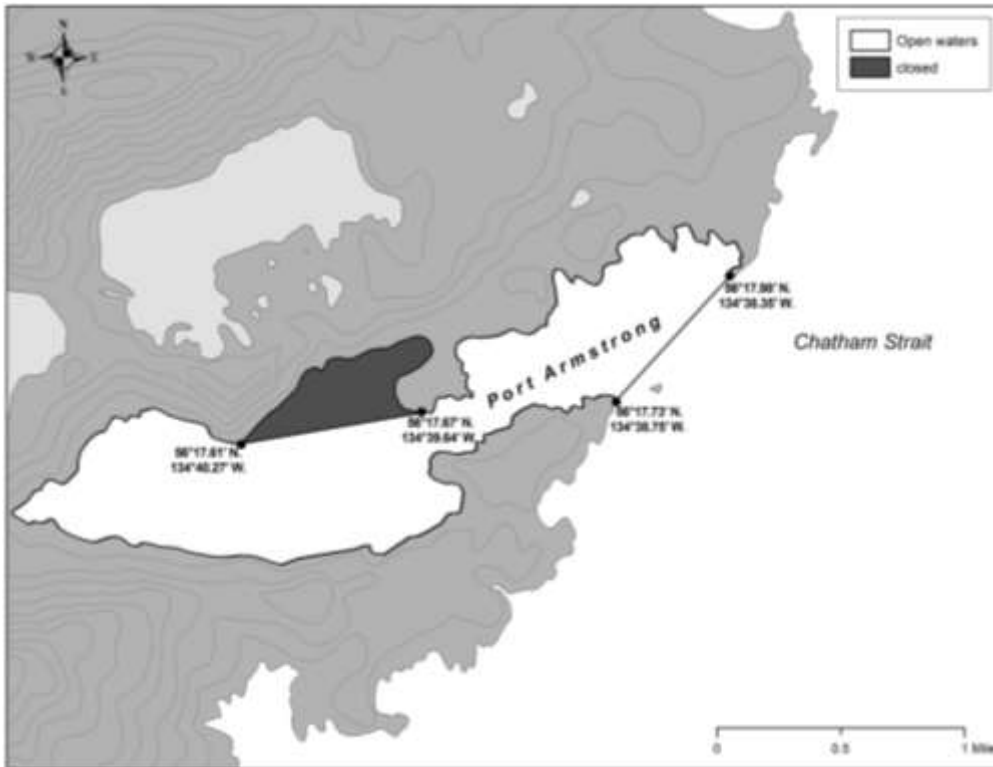
