Prince William Sound Salmon Fishery News Release #26

<u>SEINE FISHERIES:</u> This announcement will provide time and area specifics for commercial purse seine fishing opportunity in eastern PWS on Saturday, July 11. All other previously announced seine fisheries remain as announced. VFDA began its cost recovery sales program on June 30, and has collected approximately 91.7% of the assigned pink salmon revenue goal through July 7. VFDA reports pink salmon escapement at the head of Port Valdez that is adequate given all available fishery performance indications.

The 2015 PWS wild stock pink salmon run appears to have been early and strong. A total of 30,500 pink salmon have been passed at the Coghill River weir in the past three days, for a cumulative passage of 39,400 fish; this is the fourth largest cumulative passage on record for the date. Aerial surveys of eastern PWS flown this season have also indicated that early wild pink salmon returns are greater than anticipated for the dates flown; chum salmon escapements are within anticipated ranges. Aerial surveys of PWS streams will be flown today, and over the weekend.

Harvest reporting appears to be incomplete for the Wednesday, July 8 purse seine fishery in eastern PWS. However, it is estimated that at least 2.5 million pink salmon were harvested. Harvest reporting for the July 9 purse seine fishery in eastern PWS is unavailable at the time of this announcement. However, harvest should exceed 1.5 million pink salmon.

ADF&G sampling of CPF pink salmon harvested in Valdez Arm on July 8 resulted in 28.7% female (sample size of 1,971 fish). These sex ratios are low for the date. Historical ADF&G sex ratio sampling data for Eastern District on July 8 results in an average of 44.5% female for the date.

ADF&G sampling of the Eastern District CPF on July 6 resulted in a harvest composition of 81% SGH and 19% wild pink salmon.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Saturday, July 11.

Waters of Port Valdez east of a line from 61° 05.00' N, 146° 21.50' W to 61° 06.00' N, 146° 21.50' W and south of a line from 61° 06.00' N, 146° 21.50' W to 61° 06.00' N, 146° 15.10' W will be closed to commercial fishing during this period.

Waters within 200 yards of the AMHS Valdez Ferry Terminal are closed to commercial fishing when the ferry is arriving and departing. All waters of the Valdez small boat harbor and within 50 yards of the entrance to the harbor are closed to commercial fishing. Waters within the Alyeska Marine Terminal (Trans-Alaska Pipeline System) Security Zone are CLOSED to commercial fishing. Remaining regulatory closed waters and anadromous stream closures north of a line from Potato Point to Entrance Point will not be in effect during this fishing period.

Waters inside of the following Eastern District Salmon Harvest Task Force (SHTF) markers will be CLOSED for this period to ensure early season escapement:

- (1) <u>Galena Bay</u>: waters east of a line from a shore marker at approximately 60°56.87' N. lat., 146°39.87' W. long. to a shore marker at approximately 60°56.55' N. lat., 146°39.65' W. long,;
- (2) <u>Jack Bay</u>: waters south and east of a line from a shore marker at approximately 61°02.34' N. lat., 146°35.27' W. long. to a shore marker at approximately 61°02.17' N. lat., 146°39.77' W. long.;
- (3) <u>Sawmill Bay</u>: waters north of a line from a shore marker at approximately 61°02.71' N. lat., 146°46.44' W. long. to a shore marker at approximately 61°02.58' N. lat., 146°47.07' W. long.

NORTHERN DISTRICT: Waters of the Northern District east of Granite Point will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Saturday, July 11. Waters of Long Bay north of a line from a shore marker at approximately 60°57.63' N. lat., 147°13.50' W. long. to a shore marker at approximately 60°57.01' N. lat., 147°15.47' W. long. will be closed to commercial fishing during this period.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 14hour period, from 6:00 am until 8:00 pm, on Saturday, July 11.

The next scheduled purse seine salmon fisheries announcement is anticipated to occur by 2:00 pm Saturday, July 11. The next scheduled gillnet salmon fisheries announcement is anticipated to be at 2:00 pm Saturday, July 11.

Permit holders are advised that unscheduled announcements based on current escapement data may occur at any time inseason either establishing an additional period or extending an open period.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does not exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).

 If so requested, take an observer aboard your vessel.
Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form. Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. All MMPA category fisheries are liable for

incidentally taking ESA listed species

Please reference http://www.nmfs.noaa.gov/pr/pdfs/esa factsheet.pdf for a list of marine mammals currently listed under the ESA (you should periodically check with the National Marine Fisheries Service for any changes in listed species). Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an

"intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

- To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:
 - Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals. Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals
