Prince William Sound Salmon Fishery News Release #29

GILLNET FISHERIES: This announcement supersedes the Eshamy District portion of the Saturday, July 11 announcement. The MBH barrier seine is still in place and closed area is being expanded to protect hatchery equipment. All other previously announced gillnet fisheries remain as announced.

ESHAMY DISTRICT: Waters of Main Bay Subdistrict, including the MBH THA and SHA **up to a line of buoys in front of the barrier seine**, will open for a 60-hour period starting at 8:00 am on Monday, July 13. The AGZ will open to DRIFT GILLNET permit holders only during this fishing period. The Coghill Weir sockeye salmon count is below anticipated and fishing area is being adjusted to reduce wild sockeye salmon harvest and focus fishing effort on enhanced sockeye salmon.

SEINE FISHERIES: This announcement will provide time and area specifics for commercial purse seine fishing opportunity in eastern PWS on Monday, July 13. All other previously announced seine fisheries remain as announced. VFDA began its cost recovery sales program on June 30, and has collected approximately 91.7% of the assigned pink salmon revenue goal through July 7. VFDA has recommended some additional area restrictions at the head of Port Valdez to provide sanctuary for hatchery escapement.

Aerial surveys of eastern and northern PWS flown this past week indicated that early wild pink salmon returns are greater than anticipated for the dates flown; chum salmon escapements are within anticipated ranges. A total of 65,300 pink salmon have been passed at the Coghill River weir through July 11; this is the fourth largest cumulative passage on record for the date.

ADF&G sampling of CPF pink salmon harvested in Valdez Arm on July 10 resulted in 31.8% female (sample size of 936 fish); this sex ratio is low for the date.

Local processing capacity has been exceeded in recent days, resulting in some haul out of pink salmon to Kodiak and Southeast Alaska. It is estimated that between 1.75 and 2 million pink salmon were harvested in eastern PWS on Saturday, July 11. The cumulative PWS pink salmon harvest to date is at least 9.07 million CPF and 1.75 million VFDA cost recovery fish, for a total of at least 10.82 million fish.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Monday, July 13.

Waters of Port Valdez east of 146° 30.62' W. longitude will be closed to commercial fishing during this period. Regulatory closed waters and anadromous stream closures north of a line from Potato Point to Entrance Point and west of 146° 30.62' W. longitude will not be in effect during this fishing period.

Waters inside of the following Eastern District Salmon Harvest Task Force (SHTF) markers will be CLOSED for this period:

- (1) **Galena Bay:** waters east of a line from a shore marker at approximately 60°56.87' N. lat., 146°39.87' W. long. to a shore marker at approximately 60°56.55' N. lat., 146°39.65' W. long.;
- (2) **Jack Bay:** waters south and east of a line from a shore marker at approximately 61°02.34' N. lat., 146°35.27' W. long. to a shore marker at approximately 61°02.17' N. lat., 146°39.77' W. long.;
- (3) **Sawmill Bay:** waters north of a line from a shore marker at approximately 61°02.71' N. lat., 146°46.44' W. long. to a shore marker at approximately 61°02.58' N. lat., 146°47.07' W. long.

NORTHERN DISTRICT: Waters of the Northern District east of Granite Point will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Monday, July 13. Waters of Long Bay north of a line from a shore marker at approximately 60°57.63' N. lat., 147°13.50' W. long. to a shore marker at approximately 60°57.01' N. lat., 147°15.47' W. long. will be closed to commercial fishing during this period.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Monday, July 13.

The next scheduled purse seine salmon fisheries announcement is anticipated to occur by 2:00 pm Monday, July 13. The next scheduled gillnet salmon fisheries announcement is anticipated to be at 2:00 pm Wednesday, July 15.

Permit holders are advised that unscheduled announcements based on current escapement data may occur at any time inseason either establishing an additional period or extending an open period.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All** MMPA category fisheries are liable for incidentally taking ESA listed species.

Under the ESA, “take” means to “harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct.” (16U.S.C. 1532(19)); and “harass” means an “intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering.” (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals
