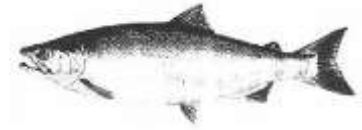

Prince William Sound Salmon Fishery News Release #43

COPPER RIVER DISTRICT: Copper River District will open at 7:00 am, Thursday, July 30 for a 36-hour commercial fishing period.

Cumulative sonar count through July 28 was 1.35 million fish, whereas the anticipated count for this date is 707,000 fish. Effective at 12:00 am this morning both north and south bank sonars were pulled for the season. For the week ending July 11, the actual Copper River delta survey count was 45,960 sockeye salmon versus an anticipated range 30,055 – 71,040. Hatchery contributions from the period that closed on July 17 were 39% Gulkana Hatchery. Harvest from the fishing period that closed Tuesday, July 28 is not yet available.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent with commercial periods until the Copper River District is closed at the end of the season. Subsistence users may obtain subsistence permits during regular business hours. The Cordova ADF&G office is open to the public Monday – Friday, 8:00 am – 12:00 pm and 1:00 pm – 5:00 pm. **Subsistence permits are not available outside of regular office hours.**

BERING RIVER DISTRICT: Bering River District will open at 7:00 am, Thursday, July 30 for a 36-hour commercial fishing period. For the week ending July 11, the actual Bering River District survey count was 20,920 sockeye salmon versus an anticipated range of 11,051 – 24,313. No harvest was reported for the fishing period that closed Tuesday, July 28.

ESHAMY DISTRICT: Waters of the Eshamy District north of Loomis Creek (60° 29.44'N., 147° 58.42'W.), will open for a 12-hour fishing period starting at 8:00 am, Thursday, July 30. Waters of the Main Bay Subdistrict will open for a 60-hour period starting at 8:00 am Thursday, July 30. **The AGZ will open to SET GILLNET permit holders only during this fishing period.** Eshamy River video weir counted 398 sockeye salmon between July 11 and July 27 versus a minimum anticipated count of 1,710 fish. Harvest from the fishing period that closed Saturday, July 25 was 30,300 sockeye, 36,600 pink, and 248 chum salmon with 176 deliveries reported.

MONTAGUE DISTRICT: Port Chalmers Subdistrict will close to drift gillnet harvest for the season at the end of the current fishing period, 12:00 am, Wednesday, July 29.

SEINE FISHERIES: This announcement will provide time and area specifics for commercial purse seine fishing opportunity throughout PWS on Thursday, July 30. All other previously announced seine fisheries remain as announced. It is expected that opportunity targeting the SGH pink salmon run in Port Valdez and Valdez Arm will be provided on Friday, July 31, with time and area to be announced on Thursday, July 30. It is expected that there will be a broad area commercial purse seine fishing period taking place throughout PWS on Saturday, August 1, with time and area to be announced by 2 pm on Friday, July 31.

VFDA began its cost recovery sales program on Tuesday, June 30, and reached its cost recovery goal on July 24. VFDA reports that they have secured sufficient broodstock at SGH, and has recommended continued fishing opportunity in Port Valdez and Valdez Arm.

PWSAC began its pink salmon cost recovery program on July 25, and has collected approximately 497,000 pink salmon for cost recovery through July 28.

ADF&G sampling of the July 23 Eastern District CPF resulted in a harvest composition of approximately 54% SGH, 45% wild, and less than 2% WNH pink salmon; sampling of the July 26 Eastern District CPF resulted in a harvest composition of approximately 58% wild, 40% SGH, and 2% WNH pink salmon.

ADF&G sampling of the July 23 Southwestern District CPF resulted in a harvest composition of approximately 41% AFK, 27% SGH, 20% wild, 8% WNH, and 4% CCH pink salmon; sampling of the July 26 Southwestern District test fishery catch resulted in a composition of approximately 33% WNH, 25% AFK, 22% wild, 15% SGH, and 5% CCH pink salmon.

It is estimated that 2.9 million pink salmon were harvested in PWS on Monday, July 27. Harvest totals for the July 28 CPF in Port Valdez and Valdez Arm were unavailable at the time of this announcement. The cumulative PWS pink salmon harvest through July 27 is estimated at 42.5 million CPF and 2.4 million cost recovery fish (VFDA and PWSAC), for a total of 44.9 million fish; this is a record cumulative total for the date.

COGHILL DISTRICT: Waters of the Coghill District, **excluding waters of the WNH SHA**, will open to commercial purse seine and drift gillnet fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30.

Waters of Port Valdez east of 146° 23.00' W. longitude will be closed to commercial fishing during this period. Regulatory closed waters and anadromous stream closures north of a line from Potato Point to Entrance Point and west of 146° 23.00' W. longitude WILL BE IN EFFECT UNTIL FURTHER NOTICE. Security zones in Port Valdez (in front of the Valdez Marine Terminal) and in the Valdez Narrows will continue to be enforced as detailed in Prince William Sound Salmon Fishery News Release #24, which was distributed on Wednesday, July 8. Waters inside of the following Eastern District Salmon Harvest Task Force (SHTF) markers will be closed during this period:

- (1) **Galena Bay:** waters east of a line from a shore marker at approximately 60°56.87' N. lat., 146°39.87' W. long. to a shore marker at approximately 60°56.55' N. lat., 146°39.65' W. long.;
- (2) **Jack Bay:** waters south and east of a line from a shore marker at approximately 61°02.34' N. lat., 146°35.27' W. long. to a shore marker at approximately 61°02.17' N. lat., 146°39.77' W. long.;
- (3) **Sawmill Bay:** waters north of a line from a shore marker at approximately 61°02.71' N. lat., 146°46.44' W. long. to a shore marker at approximately 61°02.58' N. lat., 146°47.07' W. long.

MONTAGUE DISTRICT: Waters of the Montague District, **excluding the Port Chalmers Subdistrict**, will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm on Thursday, July 30.

NORTHERN DISTRICT: Waters of the Northern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30. Anadromous stream closures within the CCH THA will not be in effect until further notice. Waters inside of the following Northern District Salmon Harvest Task Force (SHTF) markers are closed to commercial fishing during this period:

- (1) **Long Bay:** north of a line from a shore marker at approximately 60°57.63' N. lat., 147°13.50' W. long. to a shore marker at approximately 60°57.01' N. lat., 147°15.47' W. long.;
- (2) **Granite Bay:** north and east of a line from a shore marker at approximately 60°55.02' N. lat., 147°27.61' W. long. to a shore marker at approximately 60°54.66' N. lat., 147°26.72' W. long.;
- (3) **Cedar Bay:** north and east of a line from a shore marker at approximately 60°56.46' N. lat., 147°27.03' W. long. to a shore marker at approximately 60°56.03' N. lat., 147°26.39' W. long.;
- (4) **Wells Bay:** north of a line from a shore marker at approximately 60°56.75' N. lat., 147°29.92' W. long. to a shore marker at approximately 60°57.08' N. lat., 147°28.14' W. long.;
- (5) **Siwash Bay:** west of a line from a shore marker at approximately 60°58.26' N. lat., 147°37.32' W. long. to a shore marker at approximately 60°56.96' N. lat., 147°36.02' W. long.;
- (6) **Jonah Bay:** west of a line from a shore marker at approximately 61°01.17' N. lat., 147°35.07' W. long. to a shore marker at approximately 61°00.40' N. lat., 147°35.93' W. long.;
- (7) **Eaglek Bay:** north of a line from a shore marker at approximately 60°50.66' N. lat., 147°40.27' W. long. to a shore marker at approximately 60°50.56' N. lat., 147°44.57' W. long.

NORTHWESTERN DISTRICT: Waters of the Northwestern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30.

SOUTHWESTERN DISTRICT: Waters within 1 nautical mile of Latouche Island east of Pt. Grace and east of the southern tip of the Latouche Island, waters of the Elrington Subdistrict, waters of the San Juan Subdistrict, and waters of the AFK THA **excluding the AFK SHA**, will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Thursday, July 30. **All waters of the AFK SHA are closed to commercial fishing during this period.**

The next scheduled purse seine salmon fisheries announcement is anticipated to occur by 2:00 pm Thursday, July 30. The next scheduled gillnet salmon fisheries announcement is anticipated to be at 2:00 pm Saturday, August 1.

Permit holders are advised that unscheduled announcements based on current escapement data may occur at any time inseason either establishing an additional period or extending an open period.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All** MMPA category fisheries are liable for incidentally taking ESA listed species.

Under the ESA, “take” means to “harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct.” (16U.S.C. 1532(19)); and “harass” means an “intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering.” (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals
