Prince William Sound Salmon Fishery News Release #56

COPPER RIVER DISTRICT: Copper River District will open at 7:00 am, Thursday, August 13 for a 36-hour commercial fishing period.

For the week ending August 1, the actual Copper River delta survey count was 38,180 sockeye salmon versus an anticipated range 32,568 – 76,979. Hatchery contributions from the period that closed on July 24 were 46% Gulkana Hatchery. Harvest from the fishing period that closed Tuesday, August 11 is not yet available.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent with commercial periods until the Copper River District is closed at the end of the season. Subsistence users may obtain subsistence permits during regular business hours. The Cordova ADF&G office is open to the public Monday – Friday, 8:00 am - 12:00 pm and 1:00 pm - 5:00 pm. Subsistence permits are not available outside of regular office hours.

BERING RIVER DISTRICT: Bering River District will open at 7:00 am, Thursday, August 13 for a 36-hour commercial fishing period. For the week ending August 1, the actual Bering River District survey count was 10,680 sockeye salmon versus an anticipated range of 8,409 – 18,499. No harvest was reported for the fishing period that closed Friday, August 7.

ESHAMY DISTRICT: Waters of the Eshamy District north of Loomis Creek (60° 29.44'N., 147° 58.42'W.), will open for a 12-hour fishing period starting at 8:00 am, Thursday, August 13. Waters of the Main Bay Subdistrict will open for a 60-hour period starting at 8:00 am Thursday, August 13. **The AGZ will open to SET GILLNET permit holders only during this fishing period.** Eshamy River video weir counted approximately 1,700 sockeye salmon between July 11 and August 7 versus a minimum anticipated count of 3,500 fish. Harvest from the fishing period that closed Saturday, August 8 was 600 sockeye, 180 coho, and 9,900 pinks with 17 deliveries reported.

SEINE FISHERIES: This announcement will provide time and area specifics for daily commercial purse seine fishing opportunity throughout PWS on Thursday, August 13, Friday, August 14, and Saturday, August 15. Time and area for commercial purse seine fishing opportunity beyond Saturday will be dependent upon hatchery escapement progress, and updated fishery performance indicators.

PWSAC began its pink salmon cost recovery program on July 25, and reached its goal on Monday, August 10. PWSAC reports hatchery escapement estimates at AFK, CCH, and WNH that are good for the date, and has provided area recommendations for these fisheries.

Pink salmon eggtakes are underway at SGH, with approximately 43% of the final goal completed through August 11. VFDA reports inadequate broodstock collection at SGH, and has recommended that Port Valdez and Valdez Arm north of Rocky Point remain closed to commercial fishing.

It is estimated that 3 million pink salmon were harvested in PWS on Sunday, August 9; at least 2.3 million on Monday, August 10; and 2.3 million on Tuesday, August 11.

<u>COGHILL DISTRICT:</u> Waters of the Coghill District, **excluding all waters of the WNH Hatchery Escapement Exclusion Zone** (**HEEZ**), will open to commercial purse seine and drift gillnet fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15. The WNH HEEZ consists of the waters of the WNH SHA north of a latitude line at 60° 47.78′ N.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15. All waters of Port Valdez and Valdez Arm north of Rocky Point will be closed to commercial fishing during these periods.

MONTAGUE DISTRICT: Waters of the Montague District will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15.

NORTHERN DISTRICT: Waters of the Northern District, excluding waters of the Cannery Creek Subdistrict north of 60° 58.00′ N., and excluding all waters of the CCH THA and CCH SHA, will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15.

NORTHWESTERN DISTRICT: Waters of the Northwestern District will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15.

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August

SOUTHWESTERN DISTRICT: Waters of the Southwestern District, excluding all waters of the AFK Outer Hatchery Escapement Exclusion Zone (HEEZ), will open to commercial purse seine fishing for daily 14-hour fishing periods, from 6:00 am until 8:00 pm, on Thursday, August 13, Friday, August 14, and Saturday, August 15. Waters north of the latitude of Squire Point and west of the longitude of Herring Point will be CLOSED to commercial fishing during these periods. The AFK Outer HEEZ consists of the waters of the SHA west and south of a line from 60° 03.398' N., 148° 03.326' W. to 60° 03.017' N., 148° 02.547' W.

The next scheduled purse seine salmon fisheries announcement is anticipated to occur at 2:00 pm Saturday, August

The next scheduled gillnet salmon fisheries announcement is anticipated to occur at 2:00 pm Saturday, August 15.

Permit holders are advised that unscheduled announcements based on current escapement data may occur at any time inseason either establishing an additional period or extending an open period.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift eillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or
- Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.

 Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. All MMPA category fisheries are liable for incidentally taking ESA listed species

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals
