**2015 Yukon River Fall Salmon Fishery News Release # 37
Fall Announcement # 33, Yukon River District 2 Commercial Period 11**
Districts Affected: Lower Yukon Area

The 2015 fall chum salmon inseason run projection is on track for a run size between 700,000 and 800,000 fish. This level of abundance should be sufficient to provide for escapement, an above average subsistence harvest, and a surplus available for commercial and personal use purposes.

The estimated passage of fall chum salmon at the mainstem sonar near Pilot Station through August 26 is 483,000 fish, which is below the historical median of 551,800 fish for that date. A third group of fall chum salmon finished passing the mainstem sonar near Pilot Station on August 23 and was approximately 50,000 fish in size. The coho salmon run appears to be average to above average. As of August 26, the estimated coho salmon passage at the mainstem sonar is 75,300 fish, which is below the historical median of 99,300 fish for that date.

District 2 Commercial Period:

Commercial fishing will be open for one period in District 2 on Friday, August 28 from 2:00 p.m. until 8:00 p.m. This will be a 6-hour commercial fishing period with gillnets restricted to six-inch or smaller mesh size.

Preliminary reports from the District 2 commercial opening on August 26 indicate a harvest of 4,374 fall chum salmon and 5,776 coho salmon from 98 permit holders. The preliminary cumulative commercial harvest for District 2 is 58,425 fall chum salmon and 35,636 coho salmon.

District 2 Subsistence Fishing Schedule:

Subsistence salmon fishing in District 2 is open during the fall season 7 days per week, 24 hours per day with gillnets restricted to a maximum mesh size of 7.5 inches, except for 12 hours before, during, and 12 hours after each commercial fishing period. In District 2, subsistence salmon fishing will close at 2:00 a.m. Friday, August 28, and reopen at 8:00 a.m. Saturday, August 29.
