## 2015/16 SOUTHEAST ALASKA COMMERCIAL SEA CUCUMBER FISHERY ANNOUNCMENT

Sitka.... The Alaska Department of Fish and Game announced today the following information concerning the commercial harvest of sea cucumbers in Southeast Alaska during the 2015/16 season:

The following area will be open from 8:00 a.m. to 2:00 p.m., Monday, October 12, 2015:

#### District 13:

Salisbury Sound and Peril Strait – (Subdistricts 113-62, 63, 64, 65, and 66).

The following areas will be open from 8:00 a.m. to 3:00 p.m., Monday, October 12, and from 8:00 a.m. to 12:00 noon, Tuesday, October 13, 2015:

#### District 1:

Tree Point – (Subdistricts 101-10, 11);

West Behm Canal – (Subdistricts 101-90 and 101-95;

#### District 2:

Lower Clarence Strait – (Subdistrict 102-20);

Kasaan Bay and Skowl Arm – (Subdistrict 102-60);

Cleveland Peninsula – (Subdistrict 102-80);

#### District 3:

Long Island and upper Cordova Bay – (Subdistricts 103-21 and 30);

Hetta Inlet, Nutkwa Inlet, and Keete Inlet – (Subdistricts 103-23 and 25);

San Christoval Channel, western San Alberto Bay, and Trocadero Bay – (Subdistricts 103-60 and 103-70-002);
