Prince William Sound Salmon Fishery News Release #2

COPPER RIVER DISTRICT: The 2017 Copper River king salmon forecast of 29,000 fish is the smallest since 1985 and continues a recent pattern of weak returns. The department will implement additional commercial salmon fishery restrictions this season to reduce commercial king salmon harvest. An expanded inside waters closure area is expected to remain in place through the entire king salmon run timing. Upriver sport, personal use, and subsistence fisheries have already been closed or restricted for the season. These actions are being taken to ensure the achievement of the 24,000 or more king salmon sustainable escapement goal.

The Copper River District will open at 7:00 am on Monday, May 22 for a 12-hour commercial fishing period. Waters within the expanded Chinook salmon inside closure area will be closed during this period.

The expanded Chinook salmon inside closure area is defined as waters north of a line connecting the following points (see map below):

The grass bank markers, defined in 5AAC 24.350(1)(A), form a closure line with the following points:

Waters north of this line, within sloughs, and in Boswell Bay within the bay (5 AAC 24.350 (1)(A)) are closed to commercial and subsistence salmon fishing during all periods.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent in time and area with commercial fishing periods until the Copper River District is closed at the end of the season. **Additionally, waters west of 145° 33.50' W. longitude will open to subsistence fishing during commercial fishing periods unless superseded by emergency order.** Subsistence users may obtain subsistence permits during regular business hours. The

Cordova ADF&G office is open to the public Monday - Friday, 8:00 am - 12:00 pm and 1:00 pm - 5:00 pm. **Subsistence permits are not available outside of regular office hours.**

Miles Lake sonar is currently operational on both banks. Cumulative sonar count through 5/19 was 3,460 fish whereas the anticipated range for this date is 575–900. The 0600 count for 5/20 was 744 fish. Preliminary harvest estimate from the 12-hour period that occurred on Monday, May 18 was 1,900 Chinook and 36,000 sockeye salmon. This compares to an anticipated harvest of 37,200 sockeye salmon for this period.

BERING RIVER DISTRICT: Bering River District, west of a longitude line at 144° 28.20' W., will open at 7:00 am on Monday, May 22 for a 12-hour commercial fishing period. The intent of this opening is to target Copper River sockeye salmon that are traveling through the western portion of this district. **As overlap with the Bering River sockeye salmon run timing increases, the likelihood of future early season opening in the Bering River District will diminish. Additionally, future openings of the Bering River District will be contingent on accurate reporting of harvest from within this district.**

COGHILL DISTRICT: The Coghill District, excluding waters of the WNH SHA inside a line of buoys in front of the barrier seine, will open for the 2017 season to commercial drift gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 1. A total of 1.09 million WNH onsite released chum salmon are anticipated to be available for common property harvest. Historical harvest timing for these chum salmon is from June 1 – July 27. A total of 44,000 Coghill Lake sockeye salmon are anticipated to be available for common property harvest. The harvest timing for these sockeye salmon is from June 1 – August 1. The Coghill River weir is expected to start operations during the second week of June.

ESHAMY DISTRICT: The Eshamy District will open for the 2017 season to commercial gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 1. A total of 1.1 million MBH sockeye salmon are anticipated to be available for common property harvest. The historical harvest timing for these sockeye salmon is from June 1 – August 1.

MONTAGUE DISTRICT: The Port Chalmers Subdistrict will open for the 2017 season to purse seine fishing for 84 hours beginning at 8:00 am on Thursday, June 1 with an additional 60-hour period at 8:00 am on Monday, June 5. A regular schedule of two fishing periods per week is anticipated to remain in effect until further notice. The western boundary of the Port Chalmers Subdistrict is defined by lines from 60°20.00'N., 147°26.59'W. to 60°14.75'N., 147°35.35'W. to 60°02.50'N., 147°44.41'W. **Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect until further notice.** A total of 383,000 chum salmon are forecast to return to Port Chalmers. The historical run timing for these chum salmon is from June 1 – July 27.

SOUTHWESTERN DISTRICT: The AFK Hatchery THA and SHA will open for the 2017 season to purse seine fishing for 84 hours at 8:00 am on Thursday, June 1 with an additional 60-hour period at 8:00 am on Monday, June 5. A regular schedule of two fishing periods per week is anticipated to remain in effect until mid-June. **Anadromous stream closures within the AFK Hatchery THA and SHA will not be in effect until further notice.** A total of 456,000 chum salmon are forecast to return to AFK Hatchery. The historical run timing for these chum salmon is from June 1 – July 27.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the

MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. All MMPA category fisheries are liable for incidentally taking ESA listed species.

Please reference http://www.nmfs.noaa.gov/pr/pdfs/esa_factsheet.pdf for a list of marine mammals currently listed under the ESA (you should periodically check with the National Marine Fisheries Service for any changes in listed species).

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals.
