2018 CARROLL INLET TERMINAL HARVEST AREA FISHERY ANNOUNCEMENT

Ketchikan. . . The Alaska Department of Fish and Game announced today the following information for the Southern Southeast Regional Aquaculture Association (SSRAA) concerning the Carroll Inlet Terminal Harvest Area (THA).

During the January Board of Fish (BOF) meeting in Sitka, the board adopted regulations re-creating the Carroll Inlet THA at the head of Carroll Inlet. The Carroll Inlet THA consists of those waters of Carroll Inlet north of Nigelius Point at 55°33.50′ N. latitude.

Troll:

Salmon may be taken in the Carroll Inlet THA by troll gear from 12:01 a.m., Friday, June 1, through 11:59 p.m., Saturday, June 30.

Net Fisheries:

From 12:00 noon, Friday, June 15, through 12:00 noon, Saturday, June 30, salmon may be taken in the Carroll Inlet THA by drift gillnet and purse seine gear as follows:

Drift Gillnet:

12:00 noon, Friday, June 15, to 12:00 noon, Saturday, June 16;

12:00 noon, Tuesday, June 19, to 12:00 noon, Wednesday, June 20;

12:00 noon, Saturday, June 23, to 12:00 noon, Sunday, June 24;

12:00 noon, Wednesday, June 27, to 12:00 noon, Thursday, June 28;

Purse Seine:

12:00 noon, Sunday, June 17, to 12:00 noon, Monday, June 18;

12:00 noon, Thursday, June 21, to 12:00 noon, Friday, June 22;

12:00 noon, Monday, June 25, to 12:00 noon, Tuesday, June 26;

12:00 noon, Friday, June 29, to 12:00 noon, Saturday, June 30.
