## Prince William Sound Salmon Fishery News Release #7

**<u>COPPER RIVER DISTRICT</u>**: The Copper River District will remain closed to commercial fishing. **The Copper River District will open to <u>subsistence fishing</u> at 7:00 am on Thursday, June 7 for a 12-hour fishing period.** Waters within the Chinook salmon expanded inside closure area will be CLOSED during this subsistence fishing period. To date, the sonar count is the 9th lowest on record (1978-2017). Cumulative commercial harvest this year is the 2<sup>nd</sup> lowest harvest todate in the last 50 years. Miles Lake sonar passage has declined since June 4. Cumulative sonar count through June 5 is 95,515 fish whereas a minimum of 175,559 fish are projected by this date. The 0600 count for June 6 is 2,484 fish. Fishermen are advised that the Copper River commercial fishery may open on short notice should indices of sockeye salmon abundance support fishing. A minimum of 17 hours advance notice of a fishery opening is anticipated.

The expanded Chinook salmon inside closure area is defined as waters north of a line connecting the following points (see map below):

Waters north of this line, within sloughs, and in Boswell Bay within the bay (5 AAC 24.350 (1)(A)) are closed to commercial and subsistence salmon fishing <u>during all periods</u>.

During the commercial fishing season, subsistence harvest may occur in the Copper River District concurrent in time and area with commercial fishing periods until the Copper River District is closed at the end of the season. Additionally, waters of the Copper River District, excluding the Chinook salmon expanded inside closure area, will open to

subsistence fishing from 6:00 am to 10:00 pm on all Saturdays between May 15 and October 31. Subsistence users may obtain subsistence permits during regular business hours. The Cordova ADF&G office is open to the public Monday - Friday, 8:00 am - 12:00 pm and 1:00 pm - 5:00 pm. Subsistence permits are not available outside of regular office hours.

BERING RIVER DISTRICT: The Bering River District will remain closed to commercial fishing.

**<u>COGHILL DISTRICT</u>**: Waters of the Coghill District, excluding waters of the Esther Subdistrict west of 148° 00.00' W. longitude and waters of the WNH THA and SHA, will open to commercial drift gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 7. Preliminary harvest estimates from the 36-hour period that started on Monday, June 4 are 900 sockeye and 30,100 chum salmon with 491 deliveries reported.

**ESHAMY DISTRICT:** The Eshamy District will open to commercial gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 7. **The AGZ will open to DRIFT GILLNET permit holders only during this fishing period.** Preliminary harvest estimates from the 36-hour period that started on Monday, June 4 are 6,600 sockeye and 1,400 chum salmon with 109 deliveries reported.

As a reminder, the Main Bay Subdistrict line was changed at the 2017 PWS BOF meeting. The updated subdistrict line regulatory language is as follows: 5 AAC 24.200 (h)(1) **Main Bay Subdistrict:** waters of Main Bay west of a line from  $60^{\circ}$  33.36' N. lat., 148° 02.35' W. long., to  $60^{\circ}$  32.77' N. lat., 148° 02.06' W. long.;

**MONTAGUE DISTRICT:** The Port Chalmers Subdistrict, **north of 60°12.56' N. lat. and east a line from 60° 12.56'N.**, **147° 20.25'W. to 60° 20.00'N., 147° 14.30'W.,** will open to purse seine fishing for 48 hours beginning at 8:00 am on Thursday, June 7. Due to increasing harvest of salmon likely destined for other areas of Prince William Sound within the Port Chalmers Subdistrict, an area adjustment is necessary to focus efforts on enhanced chum salmon returning to Port Chalmers. A regular schedule of two fishing periods per week is anticipated to remain in effect until further notice. **Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect until further notice.** Preliminary harvest estimates from the 48-hour period that ended on Sunday, June 3 are 9,084 chum with 5 deliveries reported.

**SOUTHWESTERN DISTRICT:** The AFK Hatchery THA and SHA will open to purse seine fishing for 48 hours at 8:00 am on Thursday, June 7. A regular schedule of two fishing periods per week is anticipated to remain in effect until further notice. **Anadromous stream closures within the AFK Hatchery THA and SHA will not be in effect until further notice**. Preliminary chum salmon contributions from the AFK from the 48-hour period that began on Friday, June 1 were 76% AFK, 18% WNH, 3% Port Chalmers, and 3% wild fish. Preliminary harvest estimates from the 48-hour period that began on Friday, June 1 are 5,159 chum with 11 deliveries reported.

The next scheduled salmon fisheries announcement is anticipated to be at 12:00 pm Saturday, June 9.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For
non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in

combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.

- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit <a href="http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap\_reporting\_form.pdf">http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap\_reporting\_form.pdf</a> for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. All MMPA category fisheries are liable for incidentally taking ESA listed species.

Please reference http://www.nmfs.noaa.gov/pr/pdfs/esa\_factsheet.pdf for a list of marine mammals currently listed under the ESA (you should periodically check with the National Marine Fisheries Service for any changes in listed species).

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.

• Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals. For further questions concerning marine mammal regulations call NMFS at 907-271-5006.
