SOUTHEAST ALASKA/YAKUTAT SPRING TROLL FISHERY

Sitka . . . The Alaska Department of Fish and Game announced today the following information concerning the commercial spring troll fishery.

The following terminal and special harvest areas (THA/SHA) **opened at 12:01 a.m., May 1, and will remain open until further notice:**

Neets Bay THA (101-95), Port Armstrong SHA (109-11), Hidden Falls THA (112-22), and Silver Bay THA (113-35).

Additional THA openings are as follows:

Deep Inlet THA (113-38) opened May 1, see troll gear schedule in April 4 Deep Inlet news release
Anita Bay THA (107-35) opened May 15, see troll gear schedule in April 3 Anita Bay news release
Carroll Inlet THA (101-48) opened June 1 to troll gear, see May 4 Carroll Inlet news release

South Passage (114-23) June 15–30 *closed to Chinook salmon retention*

Homeshore (114-25) June 15–30 *closed to Chinook salmon retention*

Point Couverden (114-25-01) June 25-28 *pink and chum retention only*

Northern Chatham Strait (112-16) June 25-28 *pink and chum retention only*

Yakutat area:

Yakutat Bay (183-10) June 28

Maps and further details are provided in the 2018 Spring Troll Management Plan, which is available in area offices and online.

It is extremely important to keep fish caught in different fishery areas separated so that accurate dockside sampling can occur by department personnel. If more than one area is fished, each troller and tender is required to keep and report these catches separately on **separate fish tickets** [5 AAC 29.090(k)]. The fishery name and the fishery area number must be reported on all fish tickets.

SILVER BAY THA

As previously announced in the troll news release June 14, within the waters of the Silver Bay THA, the waters of Bear Cove east of a line from a point on the south shore at 57°00.63' N. lat., 135°09.80' W. long., to the north shore at 57°01.07' N. lat., 135°09.93' W. long. are closed to commercial troll gear.

ICY STRAIT/KEKU STRAIT TROLL LOGBOOK PROGRAM

The department is soliciting participation in a troll logbook program that will be conducted during the 2018 spring troll fisheries in the Homeshore, Point Couverden, Northern Chatham Strait, and Keku Strait areas. This program is being implemented to help estimate encounter rates of juvenile Chinook salmon in the directed troll chum fisheries in Icy Strait and Keku Strait. Participants are asked to document all salmon caught in any of these spring troll areas. Port sampling staff will be available for logbook collection and distribution in Sitka, Petersburg, Wrangell, Ketchikan, and Juneau. Logbook participants will be compensated \$100 for three days of catch information. Trollers interested in participating may contact program coordinators Rhea Ehresmann (747-6688) or Anne Reynolds Manney (465-2444).

The 2018 Summer Troll Management Plan and a news release concerning fishery plans for the first summer Chinook retention period will available in area offices and online during the week of June 24.
