### Prince William Sound Salmon Fishery News Release #14

**COPPER RIVER DISTRICT:** The Copper River District will remain closed to commercial fishing. Fishermen are advised that the Copper River commercial fishery may open on short notice should indices of sockeye salmon abundance support fishing. A minimum of 17 hours advance notice of a fishery opening is anticipated. **The Copper River District will open to subsistence fishing at 7:00 am on Thursday, June 28 for a 12-hour fishing period.** Waters within the Chinook salmon expanded inside closure area will be **OPEN** during this subsistence fishing period. **Additionally, waters of the Copper River District, including the Chinook salmon expanded inside closure area, will open to subsistence fishing from 6:00 am to 10:00 pm on all Saturdays between June 16 and October 31.**

To date, the sonar count is the 5th lowest on record (1978-2017). Cumulative commercial harvest this year is the 2<sup>nd</sup> lowest harvest to-date in the last 50 years. Cumulative sonar count through June 26 is 305,466 fish whereas a minimum of 402,480 fish are projected by this date. The 0600 count for June 27 is 3,060 fish. For the week ending June 16, the actual Copper River Delta survey count was 11,110 sockeye salmon versus an anticipated range 14,273 – 33,736.

**BERING RIVER DISTRICT:** The Bering River District will remain closed to commercial fishing.

**PRINCE WILLIAM SOUND GILNET FISHERIES:** Gillnet depth restrictions, as specified in 5 AAC 24.331(b)(6), **WILL NOT BE IN EFFECT** in the Coghill, Eshamy, and Unakwik District fisheries starting 8:00 am, Monday, June 25.

**COGHILL DISTRICT:** Waters of the Esther and Granite Bay subdistricts, excluding waters of the WNH THA and SHA, will open to commercial drift gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 28. As of June 16, 1,900 sockeye salmon had passed the Coghill River weir. Currently the weir is not operational due to high water. Otolith contribution estimates from sockeye salmon harvest will be the primary management tool in the absence of the weir, which is scheduled to be redeployed by Sunday, July 1. Preliminary chum salmon contributions from the Coghill District 36-hour period that began on Thursday, June 21 were 98% WNH, 1% AFK, and 1% wild fish. Preliminary harvest estimates from the 36-hour period that started on Monday, June 25 are 406,000 chum and 18,200 sockeye salmon with 1,303 deliveries reported.

**ESHAMY DISTRICT:** The Eshamy District, excluding waters of the AGZ inside a line of buoys in front of the barrier seine, will open to commercial gillnet harvest for a 36-hour period starting at 8:00 am on Thursday, June 28. **The AGZ will open to SET GILLNET permit holders only during this fishing period.** Preliminary harvest estimates from the 36-hour period that started on Monday, June 25 are 152,000 sockeye and 24,300 chum salmon with 581 deliveries reported.

**UNAKWIK DISTRICT:** The Unakwik District will open to commercial drift gillnet and purse seine harvest for a 24-hour fishing period beginning at 8:00 am on Thursday, June 28.

**SEINE FISHERIES:** VFDA made four test sets in Port Valdez on Tuesday, June 26, with a total catch of nine pink salmon. Test fishing is expected to continue Wednesday, June 27.

The second aerial survey of portions of the Eastern and Northern districts was conducted on Tuesday, June 26. Stream escapements were minimal during this survey, which is to be expected for the date. The next aerial survey for the Eastern and Northern District is scheduled for Tuesday, July 3.

**SOUTHWESTERN DISTRICT:** The AFK Hatchery THA and SHA will open to purse seine fishing for a 12-hour period at 8:00 am on Thursday, June 28 and Saturday, June 30. Due to increasing sockeye salmon harvest, shorter duration periods are

necessary to focus efforts on enhanced chum salmon returning to AFK. A regular schedule of three fishing periods per week (Monday, Thursday, and Saturday) is anticipated to remain in effect until further notice. Preliminary harvest estimates from the 12-hour period that started on Monday, June 25 are 42,000 chum and 5,500 sockeye salmon with 43 deliveries reported. **Anadromous stream closures within the AFK Hatchery THA and SHA will not be in effect until further notice.**

**MONTAGUE DISTRICT:** The Port Chalmers Subdistrict, **north of 60°12.56' N. lat. and east a line from 60° 12.56'N., 147° 20.25'W. to 60° 20.00'N., 147° 14.30'W.,** will open to purse seine fishing for a 36-hour period at 8:00 am on Thursday, June 28. A regular schedule of two fishing periods per week is anticipated to remain in effect until further notice. Preliminary harvest estimates from the 36-hour period that started on Monday, June 25 are 40,000 chum and 2,000 sockeye salmon with 73 deliveries reported. **Regulatory closed waters and anadromous stream closures within the Port Chalmers Subdistrict will not be in effect until further notice.**

**As a reminder, inseason management is heavily dependent upon accurate and timely catch and effort data. Please remember to accurately report the location of harvest when delivering, particularly if you are fishing multiple districts.**

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit [http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap\\_reporting\\_form.pdf](http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf) for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All** MMPA category fisheries are liable for incidentally taking ESA listed species.

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals.
