Prince William Sound Salmon Fishery News Release #21

COGHILL DISTRICT: This announcement supersedes previously announced time and area in the Coghill District. Waters of the Coghill District, excluding waters of the Esther Subdistrict and waters of WNH SHA and THA, will open to commercial drift gillnet harvest for a 36-hour period starting at 8:00 am on Monday, July 9. **Waters of the Esther Subdistrict west of a longitude line at 148° 07.87' W. (point west of Culross Light) will open to commercial drift gillnet harvest for a 24-hour period starting at 8:00 am on Monday, July 9. Waters of Port Wells and College Fiord, north of a line from Pakenham Point (61° 00.45' N., 148° 04.85' W.) to 60° 55.81' N., 148° 05.89' W. (north outer point of Granite Bay Subdistrict) and continuing along a latitude line at 60 55.81' N. to the north shore of Esther Pass, will open to commercial drift gillnet harvest for a 60-hour period starting at 8:00 am on Monday, July 9.** Effective from 8:00 am, Monday, July 9 to 8:00 pm, Wednesday, July 11, regulatory closed waters pertaining to the Coghill River, as specified in 5 AAC 24.350(6)(B)), will not be in effect. Commercial fishing will not be permitted within the bed or channel of the Coghill River at any stage of the tide. Beginning Sunday, June 17, Coghill weir was inoperable due to high water and structural damage. The weir was reinstalled and fish-tight on Saturday, June 30. Passage to date is 29,760 sockeye salmon versus an anticipated range of 10,241–30,722 fish.

SEINE FISHERIES: This announcement will provide time and area specifics for commercial purse seine fishing opportunity in eastern PWS on Tuesday, July 10. VFDA began its cost recovery sales program on Monday, July 2 and has collected approximately 42.21% of the assigned pink salmon revenue goal through July 7. VFDA reports that cost recovery pink salmon harvest in Port Valdez on Friday, July 6 resulted in an average weight of 3.56 pounds per fish and 13% female.

An aerial survey was conducted in the Eastern and Northern districts on Saturday, July 7, and indicated that chum and pink salmon escapements are currently below the anticipated ranges for the date within the Eastern District. The department does not anticipate that these stocks will sustain a consistent schedule of openings at this time. The next aerial survey of Eastern and Northern Districts is scheduled for Thursday, July 12.

EASTERN DISTRICT: Waters of the Eastern District, north of a latitude of 60° 54.00' N., will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Tuesday, July 10.

Waters of Port Valdez east of a line from 61° 05.00' N, 146° 21.50' W to 61° 06.00' N, 146° 21.50' W and south of a line from 61° 06.00' N, 146° 21.50' W to 61° 06.00' N, 146° 15.10' W will be CLOSED to commercial salmon fishing during this period.

Waters within 200 yards of the AMHS Valdez Ferry Terminal are closed to commercial fishing when the ferry is arriving and departing. All waters of the Valdez small boat harbor and within 50 yards of the entrance to the harbor are closed to commercial fishing. Waters within the Alyeska Marine Terminal (Trans-Alaska Pipeline System) Security Zone are closed to commercial fishing. **Regulatory closed waters and anadromous stream closures north of a line from Potato Point to Entrance Point will not be in effect during this fishing period.**

Waters inside of the following Eastern District Salmon Harvest Task Force (SHTF) markers will be CLOSED for these periods to ensure early season escapement:

- (1) **Galena Bay:** waters east of a line from a shore marker at approximately 60°56.87' N. lat., 146°39.87' W. long. to a shore marker at approximately 60°56.55' N. lat., 146°39.65' W. long.;

- (2) **Jack Bay:** waters south and east of a line from a shore marker at approximately 61°02.34' N. lat., 146°35.27' W. long. to a shore marker at approximately 61°02.17' N. lat., 146°39.77' W. long.;
- (3) **Sawmill Bay:** waters north of a line from a shore marker at approximately 61°02.71' N. lat., 146°46.44' W. long. to a shore marker at approximately 61°02.58' N. lat., 146°47.07' W. long.

The next scheduled salmon fisheries announcement is anticipated to be at 2:00pm Wednesday, July 11.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All** MMPA category fisheries are liable for incidentally taking ESA listed species.

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals.
