**KODIAK COMMERCIAL SALMON FISHERY ANNOUNCEMENT #26
For Emergency Order #4-FS-K-26-18**

The **Izhut Bay Section south of a line from Haystack Rock** (at 58° 10.58' N lat., 152° 17.36' W long.) **to Pillar Cape** (at 58° 08.90' N lat., 152° 06.77' W long.) will now be extended from **9:00 p.m. Monday, August 6 and remain open until further notice.**

As Previously Announced:

There will be a **33-hour** commercial salmon fishing period from noon **Tuesday, August 7 to 9:00 p.m. Wednesday, August 8** in the **Dog Salmon Flats Section** of the **Alitak District**.

Closed Water Adjustments:

Closed waters are reduced from **noon Tuesday August 7 to 9:00 p.m. Wednesday, August 8** in the following areas of the **Dog Salmon Flats Section**:

- To the ADF&G markers located at the stream termini of **Dog Salmon Creek** (stream #257-403); and,
- To the ADF&G markers located near **Horse Marine Lagoon** (stream #257-402).

There will be a **48-hour extension** to the current commercial salmon fishing period from **9:00 p.m. Monday, August 6 to 9:00 p.m. Wednesday, August 8** in the following areas:

- The **Cape Alitak, Alitak Bay, Moser Bay, and Olga Bay sections** of the **Alitak District**.

There will be a **24-hour extension** to the current commercial salmon fishing period from **9:00 p.m. Monday, August 6 to 9:00 p.m. Tuesday, August 7** in the following areas:

- The **Humpy-Deadman Section** of the **Alitak District**;
- The **Outer Karluk Section** of the **Southwest Kodiak District**;
- The **Central, North Cape, Uyak Bay, Spiridon Bay, Inner Uganik Bay, and Anton Larsen Bay sections** of the **Northwest Kodiak District** (the Sheratin Bay, Kizhuyak Bay, Terror Bay, and Zachar Bay sections remain closed); and,
- The **Southwest Afognak Section** of the **Afognak District**.

The following areas will close at **9:00 p.m. Monday, August 6:**

- The **Raspberry Strait, Northeast Afognak, and Duck Bay sections** of the **Afognak District**.

The following areas will remain **open** to commercial salmon fishing **until further notice**:

- The **Izhut Bay Section north of a line from Haystack Rock to Pillar Cape** in the **Afognak District**; and
- The **Spiridon Bay Special Harvest Area** (Telrod Cove).

Until further notice, in that **portion of the Northwest Kodiak and Southwest Kodiak districts south of the latitude of Cape Kuliuk, Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear** in the commercial fishery and must be returned to the water unharmed.

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350).
