Prince William Sound Salmon Fishery News Release #46

ESHAMY DISTRICT: The Eshamy District will open to commercial drift gillnet harvest for a 14-hour period starting at 6:00 am on Friday, August 10. The Eshamy District will open to commercial set gillnet harvest for a 12-hour period starting at 6:00 am on Friday, August 10. **The AGZ will open to SET GILLNET permit holders only for the first 12 hours of this period, and then it will switch to DRIFT GILLNET for the remainder of the period.**

SEINE FISHERIES: This announcement will detail PWS purse seine fishing periods commencing on Friday, August 10. PWSAC recommends a commercial fishing opener for Friday, August 10 in some hatchery subdistricts due to improved broodstock acquisition. PWSAC currently estimates there are approximately 120,000–140,000 pink salmon within the AFK SHA and needs approximately 350,000 pink salmon for broodstock; 80,000–90,000 pink salmon within the CCH SHA and needs approximately 360,000 pink salmon for broodstock; 100,000–120,000 pink salmon within the WNH SHA and needs approximately 300,000 pink salmon for broodstock.

Preliminary contribution estimates from the 14-hour period that began on Saturday, August 4 in the Northern District are 93% CCH, 2% WNH, and 4% wild pink salmon. Preliminary contribution estimates from the 14-hour period that began on Monday, August 6 in the Southwestern District are 61% AFK, 7% CCH, 9% WNH, and 22% wild pink salmon; Eshamy District 9% AFK, 14% CCH, 16% WNH, 2% SGH, and 58% wild pink salmon.

Aerial surveys of all districts are expected to be conducted this week, weather depending, to further assess the strength of wild stock returns throughout PWS. Aerial surveys of the Eastern and Northern districts flown on Wednesday, August 8; escapement indices were within the projected range for the date.

All regulatory closed waters and all anadromous stream closures are in effect unless otherwise stated. Additionally, fishermen are prohibited from driving or attempting to drive salmon from closed waters as stated in 5AAC 39.190.

EASTERN DISTRICT: Waters of the Eastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Friday, August 10. **Waters of Port Valdez north of a line from Entrance Point to Potato Point will be closed to commercial fishing during this period.**

NORTHERN DISTRICT: Waters of the Northern District, **excluding waters of the Perry Island Subdistrict, Cannery Creek Subdistrict north of 60°58.00' N., and CCH SHA and THA,** will open to commercial purse seine fishing for a 14-hour fishing period, from 6:00 am until 8:00 pm, on Friday, August 10.

Waters inside of the following Northern District Salmon Harvest Task Force (SHTF) markers are closed to commercial fishing during this period:

- (2) **Granite Bay:** north and east of a line from a shore marker at approximately 60°55.02' N. lat., 147°27.61' W. long. to a shore marker at approximately 60°54.66' N. lat., 147°26.72' W. long.;
- (3) **Cedar Bay:** north and east of a line from a shore marker at approximately 60°56.46' N. lat., 147°27.03' W. long. to a shore marker at approximately 60°56.03' N. lat., 147°26.39' W. long.;
- (4) **Wells Bay:** north of a line from a shore marker at approximately 60°56.75' N. lat., 147°29.92' W. long. to a shore marker at approximately 60°57.08' N. lat., 147°28.14' W. long.;

- (5) **Siwash Bay:** west of a line from a shore marker at approximately 60°58.26' N. lat., 147°37.32' W. long. to a shore marker at approximately 60°56.96' N. lat., 147°36.02' W. long.;

COGHILL DISTRICT: Waters of the Coghill, **excluding the Esther Subdistrict, WNH THA, and SHA**, will open to **commercial drift gillnet and purse seine** fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Friday, August 10.

NORTHWESTERN DISTRICT: Waters of the Northwestern District will open to commercial purse seine fishing for a 14-hour fishing period, from 6:00 am until 8:00 pm, on Friday, August 10.

SOUTHWESTERN DISTRICT: Waters of the Point Elrington Subdistrict and **waters of eastern Knight Island, east of Point Helen at 147° 46.27'W. and south of 60° 20.00'N.**, will be open to commercial purse seine fishing for a 14-hour period from 6:00 am until 8:00 pm on Friday, August 10. **The Southwestern District Priority Stream list will be in effect within waters of the Point Elrington Subdistrict.**

MONTAGUE DISTRICT: Waters of the Montague District will open to purse seine fishing for a 14-hour period from 6:00 am until 8:00 pm on Friday, August 10. **Anadromous stream closures within the Port Chalmers Subdistrict are in effect.**

SOUTHEASTERN DISTRICT: Waters of the Southeastern District will open to commercial purse seine fishing for a 14-hour period, from 6:00 am until 8:00 pm, on Friday, August 10.

The next salmon fisheries announcement is scheduled for 2:00 pm Saturday, August 11.

Unless otherwise specified, all openings are clock openings based on Alaska Daylight Time, which is based on Coordinated Universal Time and may be obtained by calling 303-499-7111.

The department encourages commercial permit holders to renew their licenses early and to check their CFEC vessel registration stickers to make sure they are current.

The department also encourages permit holders to report observed violations to Wildlife Safeguard at 800-478-3377. Reports are anonymous and cash rewards may be paid for successful prosecution of violations.

PWS commercial fishers are reminded that area fisheries often necessitate fishing in close proximity to marine mammals. Under the Marine Mammals Protection Act (MMPA), the PWS drift gillnet fishery is classified as a Category II fishery. Participants in Category I and II fisheries must be registered in the Marine Mammal Avoidance Program (MMAP) to be authorized for lawful incidental, but not intentional, marine mammal takes during fishing. However, this authorization explicitly does **not** exempt holders of commercial fishing permits from the MMPA prohibition on takes of marine mammals listed as endangered or threatened under the Endangered Species Act. As a participant in the PWS drift gillnet fishery, you are automatically registered in the Marine Mammal Authorization Program (MMAP) by the National Marine Fisheries Service (NMFS). As a participant in a Category II fishery, you must:

- Maintain an MMAP Authorization Certificate, or a photocopy, on board the vessel while engaging in any of the fisheries identified on the reverse side of the certificate. For non-vessel or set net fisheries, the enclosed Certificate, or a photocopy, must be in the possession of the permit holder during fishing operations. This Certificate, in combination with a current, valid state or Federal fishing permit, will serve as your authorization to incidentally take non-endangered or non-threatened marine mammals in the course of commercial fishing operations.
- Report all injuries and mortalities of marine mammals within 48 hours of returning from the trip during which these takes occurred using the MMAP Mortality/Injury Reporting Form (visit http://www.nmfs.noaa.gov/pr/pdfs/interactions/mmap_reporting_form.pdf for a copy).
- If so requested, take an observer aboard your vessel.

Purse seine and set gillnet gear are classified as a Category III fisheries under the MMPA. Category III fishery participants are automatically exempted from the incidental take prohibition in the MMPA. Therefore, you do not need to maintain the MMAP certificate aboard your vessel, but must report any incidental takes of marine mammals within 48 hours of the incident or your return to port. Such reports must be made on the Marine Mammals Authorization Program Mortality/Injury Reporting Form.

Because some marine mammals are also listed under the Endangered Species Act, incidental takes are also regulated under that act and are not authorized. **All MMPA category fisheries are liable for incidentally taking ESA listed species.**

Please reference http://www.nmfs.noaa.gov/pr/pdfs/esa_factsheet.pdf for a list of marine mammals currently listed under the ESA (you should periodically check with the National Marine Fisheries Service for any changes in listed species).

Under the ESA, "take" means to "harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect, or to attempt to engage in any such conduct." (16U.S.C. 1532(19)); and "harass" means an "intentional or negligent act or omission which creates the likelihood of injury to the wildlife by annoying it to such an extent as to significantly disrupt normal behavioral patterns which include, but are not limited to, breeding, feeding, or sheltering." (50 C.F.R. 17.3).

To reduce the possibility of incidentally taking an ESA listed species and its associated liability ADF&G recommends that:

- Fishermen participating in area fisheries remain vigilant in monitoring gear when marine mammals may be present.
- Fishermen use avoidance measures (e.g., not fishing or relocating fishing activities when marine mammals are present or likely to be present) to minimize interactions with marine mammals.
- Avoid fishing in areas where marine mammals are likely to be present at night or when visibility or weather conditions make it difficult to spot marine mammals.
