#### YAKUTAT COMMERCIAL SET GILLNET FISHERY EXTENSION ANNOUNCEMENT

Yakutat...The Alaska Department of Fish and Game today announced the following information concerning the Yakutat Area commercial set gillnet fishery.

**Situk-Ahrnklin Inlet:** is extended one day and will remain open through 12:00 noon, Thursday, September 13, with the following exceptions:

**Mouth of Situk River:** Commercial set gillnet fishing is prohibited upstream of a line from the ADF&G regulatory marker located on the western bank of the Situk River mouth near the Yakutat Seafoods buying station at 59°26.66' N. latitude, 129°34.43' W. longitude, **to an ADF&G regulatory marker buoy** anchored in the channel directly off the mouth of the Situk River at 59°26.28' N. latitude, 139°34.08' W. longitude, and to an ADF&G regulatory marker on the cut bank on the eastern side of the mouth of Johnson Slough at 59°26.73' N. latitude, 139°33.25' W. longitude.

**Mouth of the Lost River:** Commercial set gillnet fishing is prohibited near the mouth of the Lost River east of an ADF&G regulatory marker located at 59°27.38' N. latitude, 139°36.55' W. longitude (approximately 500 yards upstream from the Lost River terminus) and west of the Lost River at 59°27.82' N. latitude, 139°37.46' W. longitude (approximately 500 yards downstream from Lost River terminus).

**Yakutat Bay:** is extended one day and will remain open through 12:00 noon, Thursday, September 13.

**Manby Shore-Outside Waters:** is extended one day and will remain open through 12:00 noon, Thursday, September 13.
