2018/2019 SOUTHEAST ALASKA WINTER FOOD AND BAIT HERRING FISHERY

Sitka. . . The Alaska Department of Fish and Game announced today the following information concerning the 2018/2019 Southeast Alaska winter food and bait herring fishery.

Section 3-B and District 4 (Craig/Klawock): will open at 12:00 noon, Thursday, October 18, 2018, in those waters of Section 3-B west of a line from Blanquizal Point to Point Santa Rosalia to Tranquil Point and in those waters of District 4 north and east of a line from Lontana Point to Diver Point. The guideline harvest level (GHL) is 2,344 tons. This GHL is based on a forecasted mature spawning biomass of 22,810 tons and a harvest rate of 17.1 %. The forecast indicates that the predominant age classes in the spawning stock will be age-4 and age-5 herring.

The total GHL for the Craig/Klawock area is forecasted to be 3,906 tons. Regulations state that 60% of this GHL goes to the winter food and bait fishery and 40% goes to the Section 3-B spawn-on-kelp pound fishery (5 AAC 27.185 (h)). Additionally, any portion not taken by the winter bait fishery is allocated to the spawn-on-kelp fishery and will be announced by March 5, 2019.

<u>District 7 (Ernest Sound)</u>: **will be closed**. Minimal herring spawn was observed, and a spawn deposition survey was not conducted in 2018. Therefore, a forecast for the 2018/19 season was not generated.

<u>District 10 (Hobart Bay/Port Houghton)</u>: **will be closed**. Minimal herring spawn was observed, and a spawn deposition survey was not conducted in 2018. Therefore, a forecast for the 2018/19 season was not generated.

<u>District 12 (Tenakee Inlet)</u>: **will be closed**. Minimal herring spawn was observed, and a spawn deposition survey was not conducted in 2018. Therefore, a forecast for the 2018/19 season was not generated.

Fishermen and operators of tendering vessels must obtain an ADF&G permit to participate in the Southeast Alaska Winter Food and Bait Herring Fishery (5 AAC 27.179). Permit applications are available at ADF&G area offices in Ketchikan, Sitka, Petersburg, Wrangell, and Douglas free of charge.

For the 2018/19 season, the department is requiring that permits be issued by ADF&G 72 hours prior to commencing fishing operations. Terms of the permit stipulate: 1) the amount of herring harvested and delivery location be reported to the Ketchikan office for Section 3-B and District 4 by 12:00 noon on the day after fish were harvested; 2) logbook forms must be completed and submitted with fish tickets; 3) one 5-gallon bucket of herring is to be provided to the department from each delivery for catch sampling purposes.
