EXPLANATION:

This emergency order closes the resident and nonresident goat hunting seasons in that area bounded by West Creek on the north side, Taiyasanka Harbor on the south side, Ferebee River/Glacier on the west, and the Taiya Inlet and River on the east, in Game Management Unit 1(D). This order takes effect at 11:59 pm, Friday, November 7, 2014.

REGULATORY TEXT:

Therefore, the provisions of 5 AAC 85.040, HUNTING SEASONS AND BAG LIMITS FOR GOAT, are superseded by this emergency order, and the following provisions are effective for hunting goat in Unit 1(D):

The remainder of Unit 1D mountain goat seasons, other than those previously closed by emergency order, are not affected by this emergency order.

JUSTIFICATION:

A guideline harvest objective of 2 points (male goats = 1point, female goats = 2point) was established by ADF&G for the area described above. As of Thursday morning, November 6, 2014 one female goat has been harvested for a total of 2 points. Due to the vulnerability of goats in this area and the likelihood of additional harvest an emergency order has been issued effective Friday, November 7, 2014. Those portions of Unit 1D not affected by this emergency order, and not previously closed by emergency order, will remain open until the harvest guidelines are reached or the seasons come to their scheduled conclusions.
