## **EXPLANATION:**

This emergency order closes the State of Alaska resident and non-resident hunting season for bull (antlered) elk in registration permit hunt RE755 on all portions of Afognak, Kodiak, and adjacent islands at 11:59 PM, October 22, 2014. Elk hunting for the remainder of unit 8 including Raspberry Island is not affected.

### **REGULATION:**

Therefore, the provisions of **5 AAC 85.035** (a) (2), **Hunting Seasons and Bag Limits for Elk**, are superseded by this emergency order, and the following provisions are effective:

#### **JUSTIFICATION:**

This emergency order closes the bull elk hunting season throughout all portions of Afognak, Kodiak, and adjacent islands that encompass registration permit hunt area RE755. Following back-to-back harsh winters in 2010-11 and 2011-12 the bull:cow ratio on Afognak Island is low with an estimated 10 bulls per 100 cows. An extensive road system built to accommodate expanded logging activity provides increased hunter accessibility raising concerns regarding elk vulnerability. This emergency order reduces bull harvest rates to ensure an adequate bull:cow ratio while still

providing harvest opportunities for female elk. Harvest of female elk will be closely monitored to ensure overharvest does not occur.
