EXPLANATION:

This emergency order closes the state of Alaska resident and nonresident mountain goat hunting season in the Mt. Kluchman area. This order takes effect at 11:59 pm, Friday, October 9, 2015.

REGULATORY TEXT:

Therefore, the provisions of 5 AAC 85.040, HUNTING SEASONS AND BAG LIMITS FOR GOAT, are superseded by this emergency order, and the following provisions are effective for hunting mountain goats in Unit 1(C):

Resident Open Season

(Subsistence and Nonresident General Hunts) Open Season

Units and Bag Limits

(1)

Remainder of Unit 1(C); that portion west of the US/Canada Border to East Twin Glacier,

and north of the Taku River;

commonly referred to as Mt. Kluchman

Aug.1-Oct. 9 (General hunt only)

Aug.1-Oct.9

1 goat by registration permit only, the taking of nannies with kids is prohibited

The remainder of Unit 1(C) mountain goat seasons, other than those previously closed by emergency order, are not affected by this emergency order.

JUSTIFICATION:

Aerial surveys conducted by ADF&G in September 2013 resulted in a total of 22 goats (19 adults, 3 kids) observed on Mt. Kluchman. Based on the survey information a guideline harvest of 1-2 goats (males=1 point & females= 2 points) were established for the area. As of Thursday, October 8, 2015, the reported harvest is 1 female goat for a total of 2 points. Because the guideline harvest has been met and any additional harvest of goats in this area could have long term, negative impacts to the health of this goat herd an emergency order has been issued to close this area at 11:59 pm, on Friday October 9, 2015.
