EXPLANATION:

This emergency order closes the resident and nonresident goat hunting seasons in the Lutak Inlet-Chilkoot Lake portion of hunt area RG023 between Taiyasanka Harbor and the northern end of Chilkoot Lake. This order takes effect at 11:59 pm, Saturday, October 10, 2015

REGULATORY TEXT:

Therefore, the provisions of 5 AAC 85.040, HUNTING SEASONS AND BAG LIMITS FOR GOAT, are superseded by this emergency order, and the following provisions are effective for hunting goat in Unit 1(D):

JUSTIFICATION:

Based on survey information collected in September of 2013 a guideline harvest objective of 2 points (male goat=1 point & female goat=2 points) was established for the Lutak Inlet-Chilkoot Lake hunt area between Taiyasanka Harbor and the northern end of Chilkoot Lake. As of Friday October 9, 2015, 1 female goat has been harvested in this area, for a total of 2 points. Due to the vulnerability of goats in this area, and because the guideline harvest level has been met, an emergency order (01-13-15) is being issued effective at 11:59 pm, Saturday, October 10, 2015.
