EXPLANATION:

This emergency order changes the bag limit for all state Nelchina caribou hunts in Game Management Unit 13 (i.e., RC561, RC562, CC001, and DC485) from one either sex caribou to bull-only and changes the reporting requirements for all caribou hunts in Unit 13 to three days beginning on August 10, 2018. This emergency order does not affect any other caribou hunting regulation in Unit 13.

REGULATION:

Therefore, the provisions of **5AAC 85.025** (a) (8), **Hunting Seasons and Bag Limits for Caribou**, are superseded by this emergency order, and the following provisions are effective:

JUSTIFICATION:

To maintain the population objective of 35,000–40,000 Nelchina caribou, harvest quotas are modified annually. Information collected from collared caribou during the winter and spring indicate that the herd experienced higher than anticipated winter mortality. When the herd returned to the Nelchina Basin, fewer calves were produced further impacting herd size. Additional information suggests that a few animals also wintered with the Fortymile Caribou Herd and did not return. The July 2018 post-calving survey of the herd estimated approximately 35,700 caribou which is near the lower end of the population objective. The department believes that harvest of approximately 1,400 bull caribou from the state season and additional federal harvest can be taken sustainably while allowing for modest growth and providing for subsistence opportunity. A three-day harvest reporting requirement online or by phone will provide managers the necessary information to closely track in season harvest and to close hunts by emergency order ensuring that individual harvest quotas arenot exceeded.
