EXPLANATION:

This emergency order closes the state of Alaska resident and nonresident moose hunt for the Gustavus Forelands, moose hunt RM049.

REGULATORY TEXT:

(Juneau) – Prior to the season ADF&G set a harvest quota for the Gustavus area registration moose hunt, RM049, of 8 bulls for harvest in this hunt. This quota was met on the morning of October 3, 2020. We are instituting an Emergency Order closing the season at 11:59 pm October 3, 2020 because this year's quota has been filled.

An Emergency Order (01-14-20) was issued that closes RM049 moose season in this area on Saturday, October 3, 2020 @ 11:59 pm.
