# **EXPLANATION**:

This emergency order closes the State of Alaska resident and nonresident hunting season for mountain goats in registration hunt areas RG472 (Crown Mountain), and RG473 (Hidden Basin-East Terror Lake), RG476 (Kiliuda Bay), RG478 (South Road System; bow and arrow-only), RG479 (North Road System; bow and arrow-only) and archery/crossbow/muzzleloader-only hunts RG488 (South Road System) and RG489 (North Road System) areas of Kodiak Island, at 11:59 p.m., October 31, 2020. These registration hunt areas are located within Game Management Unit 8. This emergency order does not affect the goat hunting regulations in the remainder of Game Management Unit 8.

#### **REGULATION:**

Therefore, the provisions of **5 AAC 85.040** (a) (4), **Hunting Seasons and Bag Limits for goat**, are superseded by this emergency order, and the following provisions are effective:

1 goat by registration permit only; by bow and arrow only; the taking of nannies with kids is prohibited; or

1 goat by registration permit only; by bow and arrow, muzzleloader, or crossbow only; the taking of nannies with kids is prohibited

Unit 8, all lands enclosed by a line beginning at the mouth of Ugak Bay continuing to the second unnamed stream west of Saltery Creek, then continuing north along that stream to the watershed divide, then connecting to the watershed divide of Russian Creek and following Russian Creek to its mouth at Womens Bay, then northeast through the middle of Womens Bay, then straight east through Chiniak Bay south of Refuge Island to the 3-mile limit, then following the 3-mile limit back to the mouth

# **JUSTIFICATION:**

This emergency order closes the State of Alaska resident hunting season for mountain goats in Kodiak Island registration permit hunts RG472 (Crown Mountain), RG473 (Hidden Basin-East Terror Lake), RG476 (Kiliuda Bay), RG478 (South Road System; bow and arrow-only), RG479 (North Road System; bow and arrow-only) and archery/crossbow/muzzleloader-only hunts RG488 (South Road System) and RG489 (North Road System). The Department estimated a herd size of 40 goats in the Crown Mountain area; as of October 26, 2020, 4 goats were reported harvested out of a target harvest level of 4 goats. A herd size of 79 goats was estimated in the Hidden Basin-East Terror Lake area; as of October 26, 2020, 4 goats were reported harvested out of a target harvest level of 4 goats. A herd size of 163 goats was estimated in the Kiliuda Bay area; as of October 26, 2020, 14 goats were reported harvested out of a target harvest level of 16 goats. A herd size of 258 goats was estimated in the South Road System area; as of October 26, 2020, 34 goats were reported harvested out of a target harvest level of 39 goats. A herd size of 165 goats was estimated in the North Road System area; as of October 26, 2020, 31 goats were reported harvested out of a target harvest level of 25 goats.

Registration goat hunts may be utilized to meet predetermined harvest quotas for each hunt area. For this year, harvest quotas for these areas have been reached or nearly reached. Harvest that exceeds objectives could lead to reduced future hunting opportunity. Therefore, no registration hunts will occur in these areas this year.
