ALASKA BOARD OF GAME

Statewide Regulations Meeting Pike's Waterfront Lodge, Fairbanks, Alaska March 4-10, 2022

Meeting Summary

The Board of Game (board) convened the Statewide Regulations meeting on Friday, March 4, 2022 in Fairbanks, Alaska at Pikes Waterfront Lodge. Seven board members were present: Chairman Jerry Burnett, Vice-Chairman Stosh Hoffman, Orville Huntington, Allen Barrette, Lynn Keogh, Jake Fletcher and James Cooney.

The meeting opened with introductions and board member ethics disclosure statements, followed by agency reports. The list of agency reports is provided on page 10. Public testimony began Friday, March 4 at 1:30 p.m. and concluded Monday, March 7 at approximately 9:30 a.m. The board heard from 106 testifiers which included 34 remote testifiers, 22 advisory committee representatives, and one regional advisory council representative. (See Record Copy #60 for the complete list).

Board deliberations began Monday morning, following the conclusion of public testimony. The board considered 118 proposals, adopting 51. Thirteen of the adopted proposals were annual reauthorizations for antlerless moose hunts and brown bear tag fees. Board action for each proposal is provided below as: C = carried; A = amended; CA = carried as amended; F = failed; and NA = no action.

Definitions

- F (0-7) **Proposal 101:** Change the definition for bows to include crossbows.
- <u>F (0-7)</u> **Proposal 102:** Establish a definition for "primitive weapons" to include crossbow, longbow, shotgun, and muzzleloader.
- F (0-7) **Proposal 103:** Clarify whether hay and grain are considered as "hunting gear".
- $\underline{F(0-7)}$ **Proposal 230:** Change the definition for "full-curl horn".
- <u>CA (7-0)</u> **Proposal 231:** Change the definition of edible meat for cranes, geese, and swans. *The board amended the proposal to allow salvage for human use in addition to human consumption.*

- \underline{F} (0-7) **Proposal 107:** Add unconfined and unrestrained domestic cats to the definition of "deleterious exotic wildlife".
- <u>CA (7-0)</u> **Proposal 271:** Establish a definition for "position" as it applies to using a snowmachine totake game. *The board amended the with RC 38 which states: "a snowmachine may be used to approach and pursue wolves and wolverine, but may not come in in contact with a live animal;".*

Falconry

- <u>C (7-0)</u> **Proposal 108:** Increase opportunity for nonresident take for certain eyas raptors for falconry.
- <u>C (5-2)</u> **Proposal 109:** Modify the microchip requirements for live raptors exported from Alaskaby nonresidents.
- <u>C (7-0)</u> **Proposal 110:** Extend the nonresident season for acquiring passage raptors.
- <u>C (7-0)</u> **Proposal 111:** Limit nonresident take of raptors to one bird every four years and limit unsuccessful permittees from applying the following year.

Hunter Education

- <u>CA (7-0)</u> **Proposal 117:** Require hunters to possess proof of completion of required educational certifications in the field. *The board amended the proposal to allow a cited hunter to provide proof of possessing certification to the authorities within 30 days.*
- <u>C (7-0)</u> **Proposal 118:** Add a new paragraph requiring completion of crossbow hunter certification course at time of permit application.

Proxy Hunting

- <u>C (7-0)</u> **Proposal 119:** Include muskox on the list of species that can be taken under a proxy permit.
- <u>C (7-0)</u> **Proposal 120:** Allow proxy hunting for moose.

Unlawful Methods

- $\underline{F(0-7)}$ **Proposal 121:** Allow the use of dogs to hunt big game.

- <u>F (0-7)</u> **Proposal 166:** Amend the requirement for licenses and tags to include game legally taken with dogs and cats.
- F (0-7) **Proposal 122:** Lower the minimum draw weight for bows for hunting big game.
- <u>NA</u> **Proposal 233:** Eliminate the requirement for peak draw weight of bows or establish peak draw weight for taking species. *The board took no action due to the action and discussion on Proposal 122.*

- F (0-7) Proposal 134: Allow the use of cameras or sensory devices to monitor trap locations for trapping.

- \underline{F} (0-7) **Proposal 135:** Repeal the restriction on the use of aircraft for locating Dall sheep for hunting.

Permits for Bear Baiting

<u>C (7-0)</u> **Proposal 142:** Add emu to the to the list of animals allowed to be possessed without a permit.

- <u>NA</u> **Proposal 143:** Add emu to the to the list of animals allowed to be possessed without apermit. *The board took no action due to the action on Proposal 142.*
- <u>F (0-7)</u> **Proposal 144:** Exempt "sterilized community cats" from the list of species prohibited from being released into the wild.
- <u>NA</u> **Proposal 145:** Classify *F. catus* as deleterious exotic wildlife and prohibit their release into the wild, feeding, and maintaining unconfined populations. *The board took no action due to the action and discussion on the previous proposals.*
- <u>F (0-7)</u> **Proposal 238:** Modify the regulations to recognize Czechoslovakian Vlcak as a standard dog breed to be possessed in Alaska without a permit.

- <u>C (5-2)</u> **Proposal 147:** Allow the sale of prepared game trophies under a permit. *The board reconsidered the proposal on Thursday, 3/9 at 08:38:44.*
- <u>NA</u> **Proposal 148:** Allow persons over the age of 65 to sell trophies and rugs. *The board took no action because the board cannot discriminate based on age.*
- F (0-7) **Proposal 240:** Allow the sale of a game skin or trophy from a revokable trust.
- <u>C (6-1)</u> **Proposal 149:** Create separate Dall sheep permit draw for second-degree-kindred hunters in areas that limit the number of nonresident hunters.
- <u>F (0-7)</u> **Proposal 150:** Increase the number of times a hunter may apply for drawing permit hunts for each species.
- <u>F (0-6-1)</u> **Proposal 151:** Require all hunters to apply for permit hunts and pay the application fee during the application period.
- $\underline{F(0-6-1)}$ **Proposal 241:** Remove allocations between guided and non-guided nonresident hunters.
- $\underline{F(0-7)}$ **Proposal 153:** Establish a bonus point system for bison and muskox drawing hunts.
- <u>CA (7-0)</u> **Proposal 154:** Direct ADF&G to issue an additional permit when a party application is drawn as last permit. *The board amended the proposal to allow ADF&G to exceed the total number of permits allocated for hunts in 5 AAC Chapter 85.*

- <u>CA</u> **Proposal 242:** Allow hunting permits to be reissued for military personnel under "anyofficial military deployment". *The board amended the proposal with RC 52 which allows the transfer of hunting permits for deployed military for specific orders including humanitarian aid, peace-keeping, increased security, and homeland defense. - <u>C (7-0)</u> **Proposal 243:** Update 5 AAC 92.050 to recognize changes made by the Alaska Legislature regarding the transfer of drawing permit hunts.
- <u>CA (7-0)</u> **Proposal 155:** Establish a protocol for ADF&G to issue "any bull" resident moose permit inselective harvest hunts. *The board amended the proposal to replace "shall" with "may"*.

- <u>CA (7-0)</u> **Proposal 265:** Change the Unit 22E registration moose hunt to a drawing hunt with specific application conditions. *The board amended the proposal to allow up to 25 permits to be issued.*

- 1. The board discussed the Bear Conservation, Harvest & Management Policy (#2016-214-BOG) and the Wolf Management Policy (#2016-215-BOG), both of which expire March 31, 2022. The board agreed to revisit the policies at the January 2023 Work Session. Revisions will be worked on during the interim and will include updated trend information for bear harvest, acknowledgement of customary and traditional uses for wolves and bear, substituting "harvestable opportunity" for "trophy", and acknowledgement for the uniqueness of certain species found only in Alaska.
- 2. The board agreed to send a letter to the ADF&G Commissioner Vincent-Lang to request an informative sheep work session be scheduled for the summer of 2022 at which ADF&G can present recent survey data and management recommendations to the board.
- 3. The board confirmed the location for the 2023 Southcentral Region meeting originally requested to be held in Kenai, can be expanded to include Soldotna.
- 4. The board agreed to send a letter to the Big Game Commercial Services Board (BGCSB) expressing concerns for sheep populations around the state to the BGCSB and guides, and the importance of practicing discretion.
- 5. The board agreed to open future meetings with stating the pledge of allegiance.

The board adjourned the meeting at approximately 12:15 p.m.
