Subsistence and Personal Use Salmon Fishing Permit Conditions

In addition to the general permit conditions listed on and issued with the 2025 Southeast Alaska Subsistence and Personal Use Salmon Fishing Permit, the following permit conditions apply to the Haines Management area. SUBSISTENCE SALMON FISHING GENERAL PERMIT CONDITIONS

- 1. The freshwater subsistence fishing area is within the Chilkat River from mile 4 of the Haines Highway to a point 1 mile upstream of Wells Bridge.
- 2. The saltwater subsistence fishing area includes Chilkat Inlet north of the latitude of Glacier Point and Lutak and Chilkoot Inlets north of the latitude of Battery Point, excluding waters of Taiya Inlet north of the latitude of Taiya Point (see map on page 2 for boundaries).
- 3. The possession limit for Chinook salmon harvested incidentally in the subsistence fishery is 2 fish; however, due to continued poor Chilkat River Chinook salmon production, the department requests **ALL LIVE**

CHINOOK SALMON BE RELEASED IMMEDIATELY.

^{*}Household annual limits are for the entire season from any combination of areas.

CHILKAT RIVER PERMIT CONDITIONS

- 1. Legal gear is set or drift gillnet. Maximum net length is 50 feet.
- 2. The permit holder must be physically present at the net while it is fishing.
- 3. Open dates and area:
 - a) From June 1 through June 14 and from August 1 through September 30, open area is from 4-mile Haines Hwy to 1 mile upstream of Wells Bridge.
 - b) From June 15 through July 31, open area is from 19-mile Haines Highway to Wells Bridge, and weekly open periods are Wednesday through Saturday (4 days per week).

SALTWATER PERMIT CONDITIONS

- 1. Legal gear is drift gillnet with a maximum net length of 300 feet (50 fathoms).
- 2. Open time and area:
 - a) Saltwater subsistence salmon fishing is closed during closed periods to the District 15 commercial salmon drift gillnet fishery, except that subsistence salmon may be taken on the Saturday before, starting at 12:01 am, and the day before any period that the commercial salmon net fishery is open in the waters of Section 15-A. For weekly opening dates, the permittee should monitor posted Advisory Announcements online at www.adfg.alaska.gov/index.cfm?adfg=cfnews.main (select the "Southeast/Yakutat" Management Area, "Gillnet" Gear Class, then click the "Search" button) or call the Haines Office (if after hours, select option 5).
 - b) Beginning June 14, only Lutak and Chilkoot Inlets, north of Battery Point are open.
 - c) All waters of Chilkat Inlet north of Glacier Point will remain closed through July 11.
 - d) Beginning July 12, Chilkat Inlet north of Glacier Point and south of a marker at Letnikof Point light will be open.
 - e) Beginning July 19, all waters of Chilkat Inlet north of Glacier Point will be open.



PERSONAL USE SALMON FISHING PERMIT CONDITIONS

- 1. Pink and chum salmon may be taken for personal use in Taiya River.
 - a) The possession limit is 10 pink and chum salmon combined, with an annual limit of 20 pink and chum salmon combined, per household.
 - b) The possession limit of incidentally harvested Chinook and coho salmon in **Taiya River only** is 2 Chinook salmon and 6 coho salmon.

LUTAK INLET AND CHILKOOT INLET NORTH OF BATTERY POINT OPEN TO SUBSISTENCE FISHING WEEKLY STARTING JUNE 14.

CHILKAT INLET NORTH OF GLACIER POINT AND **SOUTH OF LETNIKOF POINT** LIGHT WILL OPEN TO SUBSISTENCE FISHING WEEKLY STARTING **JULY 12**.

ALL WATERS OF CHILKAT INLET NORTH OF GLACIER POINT WILL OPEN TO SUBSISTENCE FISHING WEEKLY STARTING JULY 19.
