At the spring 2005 meeting we briefed the Board of Game on sheep management activities in 14C and commented on 4 public proposals to change sheep hunts in Unit 14C (one was adopted and 3 failed, as we recommended). We also attended 3 public meetings sponsored by the Anchorage Fish and Game Advisory Committee to discuss sheep proposals.

Activity: Monitor the sheep harvest through field observations, hunter harvest reports and contact with hunters.

We analyzed harvest records for 374 drawing hunt permits. The preliminary Unit 14C 2004–05 harvest was:

Delta Controlled Use Area

Activity: Mail a questionnaire to hunters and quantify their satisfaction with aesthetics of Dall sheep hunting in the DCUA

Did not complete a hunter questionnaire because of budget constraints.

Tanana Hills

Activity: Conduct an aerial survey to estimate initial productivity and lamb survival (operating costs funded by BLM).

Conducted an aerial survey and compositioned 166 sheep in the Mount Harper/Glacier Mountain area, finding 48 lambs and 60 rams:100 ewes.

Eastern Brooks Range

Activity: Conduct aerial surveys in western Unit 25A (operating costs funded by BLM).

Conducted an aerial survey in western Unit 25A, counting 1099 sheep, including 214 lambs, 636 ewes, and 247 rams, with a total of 3.8% full curl rams.
