



# SEND US YOUR VIDEO!

**ADF&G is hunting for video of bull moose in the field. Please read on for more info:**

**BACKGROUND:** The Alaska Department of Fish & Game's Division of Wildlife Conservation is seeking video footage of moose in the field. This footage may be used in an educational video to assist hunters in harvesting legal moose in antler-restricted hunts. Hunters and outdoor enthusiasts are often presented with wonderful wildlife viewing opportunities. We hope this call for video of bull moose will be another way to showcase not only Alaska and its resources, but also the talent of its residents.



## WHAT WE ARE LOOKING FOR:

- High definition (HD), GoPro, or 4K raw video footage of bull moose in the field.
- Sharp focus, clean lens, proper lighting and frame composition.
- A variety of antler configurations.
- Footage obtained in varying regions of the state. Interior, Southcentral and Southeast, for example.
- Clips not longer than 3-5 minutes in length for ease of editing.
- "B-Roll" or filler video footage of common moose habitat in Alaska.

## PLEASE DO NOT:

- Send us video you do not own the rights to.
- Embed a watermark on the footage
- Include additional audio in your content.

## HOW TO SEND IT TO US:

First, please save HD or 4K footage as an .MOV file. Then, upload the video file at <https://drop.state.ak.us/drop>. Simply, click the "drop-off" button and use the email: [abby.lowell@alaska.gov](mailto:abby.lowell@alaska.gov). Once your files have been "picked up," you'll receive a confirmation email.

# MOOSE FOOTAGE SHOT LIST

**The following shots are those ADF&G is seeking to re-make "Is this Moose Legal?"**

- Person looking at moose from tree stand vs. ground
  - Person getting above the brush to get a good view of the moose
  - Person calling in a moose to illustrate benefit vs. chasing one (get a better look at the rack when it's coming towards you).
  - Front view then turns to side
  - Cow's ears that look like spikes
  - Cow from the back (showing white inner thigh patches)
  - Feeding from back
  - Bull moose in dim light
  - Far shot, move in closer
  - Side view, then turns to front
  - Moose in water
  - Moose in brush, obscured by brush
  - Male calf
  - From or on boat or road
  - Hunter glassing and/or getting ready to shoot
  - Habitat
- Moose with following antler configurations:**  
(various angles, different habitats)
- Spike
  - Fork
  - 2 brow tines
  - 3 brow tines
  - 4 brow tines
  - Moose with mid-antler point
  - Moose with drop point ("eye guard")
  - Under 50 inches
  - Well over 50 inches
  - Main palms either thin or short
  - Main palms either wide or very tall
  - Yearling with small paddles
  - Moose with antlers in velvet
