This is an application for a Catcher-Seller Permit. A catcher-seller is defined in 5 AAC 39.130(o)(4) as "a commercial fisherman who sells or attempts to sell unprocessed fish that were legally taken by the catcher-seller

- A) to the general public for use for <u>noncommercial</u> purposes;
- B) for use as bait for commercial or noncommercial purposes;
- C) to restaurants, grocery stores, and established fish markets;

D) by shipping the fish to a licensed buyer, processor, or exporter within this state;"
