



Fish Transporter Permit Application

A commercial fish transporter is an individual who transports commercially caught salmon, herring, or pacific cod on behalf of the commercial fisherman to the buyer. Fish can be transported anywhere within the state through any means - truck, plane, four-wheeler, etc. to any licensed buyer or private party. If you are using a vessel to transport the fish, the vessel must be licensed through the Commercial Fisheries Entry Commission.

A \$25 application processing fee must be submitted to ADF&G with this application for permit approval.
