Undersubscribed Black Bear Drawing Permits Available for Game Management Unit 3

For Fall 2015/Spring 2016

HUNTS: DL030 and DL031

The nonresident black bear drawing hunts in Unit 3 were undersubscribed during the drawing process. Permits for these hunts are available on a first-come first-served basis via either a faxed or hand-delivered ***Undersubscribed Hunt Application*** (attached below) to the Alaska Department of Fish and Game (ADF&G) office in Petersburg.

DL030—Season dates: September 1, 2015- June 30, 2016; Nonresidents only.

DL031—Season dates: September 1, 2015- June 30, 2016; Nonresidents only.

A hunter may possess only one undersubscribed black bear permit at a time. Hunters are limited to one black bear per regulatory year in Southeast Alaska.

If you are awarded a permit before June 15, 2015, it will be mailed to you with an estimated arrival time of July 1-15, 2015. If you are awarded a permit after this time, your permit will be mailed to you within approximately two weeks after we receive your application.
