## Permits Available for Interior Alaska Moose Hunts

Surplus drawing permits for moose hunting in Interior Alaska will be issued on a first come–first served basis to hunters who submit their applications via email. Applications will be accepted from 8:00 am Alaska time on March 11, 2024 until 5:00 pm May 15, 2024.

### Emails received before 8:00 am Alaska time on March 11 will not be considered.

Applications for surplus permits are available from any Fish and Game office, and on the internet at <u>https://www.adfg.alaska.gov/index.cfm?adfg=huntlicense.undersubscribed</u>, but the website does not allow hunters to apply online. Applications must be downloaded, completed, signed, and then **emailed to** <u>dfg.dwc.region3permits@alaska.gov</u>. Hunters must complete and sign the application themselves.

Drawing permits are usually issued by random lottery, but we received fewer applications for these particular hunts this year, so not all of the permits were awarded. The Board of Game allows us to issue unused drawing permits, and this year we will again make them available.

Those who are issued a permit will be contacted within one week of submitting their application.

Access into some of these hunt areas can be difficult and expensive. Hunters should understand accessibility and other limitations before applying for these drawing permits. Antler restrictions, requirements to leave meat on the bone, and other limiting conditions also must be met in some of these hunts.

Specific information for these hunts can be found in the 2024–2025 Alaska Drawing Permit Hunt Supplement available at Fish and Game offices, or online at <u>www.hunt.alaska.gov</u> at Undersubscribed Draw permits available. ## Undersubscribed Hunt Application Instructions

You must answer all required questions (1-14, 19) for the application to be accepted. Questions 15-18 are required to be answered only if the hunt you are applying for requires them.

#### 1. State Issued Driver's License/ID

Enter the state abbreviation and number of your state issued driver's license/ID. If you do not have one, check the box indicating "I DON'T HAVE A STATE ISSUED DRIVER'S LICENSE/ID".

#### 3-12. Personal Information

#### 13. Residency

Check the box for the appropriate option:

- Resident: If you are a current resident or will complete your residency requirement (see below) before the first day of the hunt, **OR**
- Nonresident: United States citizen who is not a resident of Alaska. Nonresident Alien: Citizen of a foreign country who is not a resident of the U.S.

**Resident**: A person (including an alien) who is physically present in Alaska with the intent to remain indefinitely and make a home here, and who has maintained a domicile in Alaska for the 12 consecutive months immediately preceding the start of the hunt, and who is not claiming residency or obtaining benefits in another state, territory or country. (AS 16.05.940(27))

#### 14. Alaska Hunting License

Choose one option and fill in the required information

- Enter your Alaska hunting license number. It can be either the current year's license or next year's license, OR
- If you are an Alaska resident 10-17 years of age and do not require a hunting license, enter your current age. You must be 10 years old by the starting date of the hunt.

#### 15. Bowhunter Certification Number

You must have obtained your International Bowhunter Education Program (IBEP) certification in order to apply for hunts that have been restricted to bowhunting (archery) only. If you are applying for these hunts, enter your certification number.

#### 16. Crossbow Certification Number

You must have obtained your Crossbow Certification in order to apply for hunts that have been restricted to Crossbows only. If you are applying for these hunts, enter your certification number.

#### 17. Muzzleloader Certification Number

You must have obtained your Muzzleloader Certification in order to apply for hunts that have been restricted to Muzzleloaders only. If you are applying for these hunts, enter your certification number.

#### 18. Guide Information - ATTENTION NONRESIDENTS!

Some nonresident hunts require you to have a signed guide-client contract before or at the time of application. This contract is available through your guide. If you apply for one of these hunts (marked in the supplement with the handshake symbol above) you must first indicate if you are using an Alaska-licensed guide or a resident relative within second-degree kindred, then provide the name of the person. If using an Alaskalicensed guide, you must also provide their Unique Verification Code (UVC). If you do not supply this information, your application will be rejected.
