**ALASKA RESIDENT** AS 16.05.415 & AS 16.05.940: "resident" means, 1) a person (including an alien) who is physically present in Alaska with the intent to remain indefinitely and make a home here, has maintained that person's domicile in Alaska for the 12 consecutive months immediately preceding this application for a license, and is not claiming residency or obtaining benefits under a claim of residency in another state, territory or country; 2) a member of the military service or U.S. Coast Guard who has been stationed in Alaska for the 12 consecutive months immediately preceding this application for a license; or 3) a dependent of a resident member of the military service or U.S. Coast Guard who has lived in Alaska for the 12 months immediately preceding this application for a license. A person who does not otherwise qualify as a resident may not qualify by virtue of an interest in an Alaska business. A person who establishes residency as outlined above remains a resident during an absence for from the state unless during the absence the person (1) establishes or claims residency in another state, territory, or country; or (2) performs an act, or is absent under circumstances, that are inconsistent with the intent to remain indefinitely and make a home in Alaska. A person who establishes residency as outlined above remains a resident during an absence from the state unless during the absence the person (1) establishes or claims residency in another state, territory or country; or (2) performs an act or is absent under circumstances that are inconsistent with the intent to remain indefinitely and make a home in Alaska.

**PERSONS EXEMPT FROM LICENSE REQUIREMENTS**

- Residents or nonresidents under the age of 16 years for sport fishing.
- Residents under the age of 16 years for hunting and trapping.
- Residents 60 years of age or more who have been residents for one year or more. (Note: A Permanent ID Card, which must be in possession while sport fishing, hunting, or trapping, is available without charge from the Department of Fish and Game.)

**Waterfowl Conservation Stamp** \$5.00 (Stamps expire Jan. 31st. Current year's stamps may not be available until April 1.) This stamp is required for anyone who hunts waterfowl except for residents under the age of 16, and persons who have these license types: Class 5A \$5.00, Permanent Identification Card, or Disabled Veteran's License.

**Harvest Information Program (HIP)** If you hunt migratory birds, you must first register in the HIP program through a license vendor who sells waterfowl stamps or via our internet site.
