Other actions

C 318 Move Prince of Wales area shrimp regulations to correct subsection. (*This housekeeping proposal was previously listed for February 2009 finfish meeting. The board addressed it at the January shellfish meeting.*)

The board adopted regulatory findings regarding onboard observers in the red sea urchin fishery.

The board accepted a petition from the Cook Inlet Aquaculture Association and scheduled the petition for possible regulatory action during the March 16-20, 2009 meeting.
