Proposal 361

Action: Support

Description: Shrimp pot fishing seasons for Registration Area E. Close the commercial shrimp pot fishery in PWS

Discussion: This proposal is supported in an attempt to head off what seems to be an inevitable destruction of the fishery by a commercial interest that is many for a return that is negligible. It does not make sense to allow a commercial fishery (80 commercial interests) for a gain of \$200,000 dollars. \$2500 net gain and a negligible profit for the "commercial interest" is risking the sustainability of this resource to Alaska citizens who are simply utilizing the shrimp to help feed their household. The fishery appears to be sound enough to sustain the relatively minimal impact of personal use and it does not appear to be able to sustain the much greater impact of the commercial fishery.

Opposing the proposal feel there may be alternative ways to manage the fishery such as close certain days to commercial fishing rather than simply close it.

Proposal 371

Action: Unanimous Support

Description: Personal use shrimp fishery. Extend the eastern boundary for the North Gulf Coast Personnel Use Shrimp Fishery to Cape Fairfield.

Discussion: The committee supports this proposal with the caveat that there is sufficient evidence that there are enough shrimp stocks to support a harvest. There seems to be little data available on this particular section of real estate and while data from hosting the fishery would be helpful it would seem there should at least some evidence of a harvestable stock before it is opened.

Proposal 372

Action: Support

Description: Subsistence miscellaneous shellfish fishery. Waters; seasons; bag, possession, and size limits; and special provisions for Cook Inlet-Resurrection Bay Saltwater Area – Personal Use Clam Fishery.

Discussion: Limits the aggregate bag and possession limit for littleneck clams and butter clams to 80. The current regulation allows an aggregate limit of 1,700 clams. Given the pressures that are mounting in these areas regarding the taking of clams there seems no justification to allow a literal commercial harvest level by every individual who clams these waters. Eighty (80) clams seems more than sufficient to provide for the needs of individuals utilizing this resource. Everyone who has utilized these clamming areas has noted the decline in numbers of clams and it seems the appropriate time to curtail the rape of this resource.

One opposing viewpoint wants to be able to fly in and get all of the clams they want for the year on one trip.

The meeting was called to order by Tom Sims, Committee Chair at about 7 PM. Introductions were made in the room and for the videoconference. To set the tone for the meeting, Tom stated that although many proposals may allocate resources among user groups, he expects all participants to be civil when making their points, and remember we are all neighbors.

Following are the results of the Wrangell Advisory Committee's actions on the proposals presented in the Alaska Board of Fisheries, 2011/2012 Proposal Book. Listed here are the Southeast and Yakutat Finfish proposals the Wrangell Committee chose to act upon during its meeting. Actions on other proposals in that Book will be considered at a meeting planned for January 5, 2012.

Robert Larson addressed the AC and requested proposal 249 submitted by the Southeast Alaska Subsistence RAC be considered first.

Amendment to Proposal 249: The annual limit for nonresidents is one daily bag limit (of 6 fish) per salmon species; with no more than 10 salmon overall combined total, excluding King salmon. (King salmon were first included, but later excluded.)

Number opposed to amendment: 0

Number abstaining: 0

Comments: Robert explained to the AC that the proposal was submitted with "XX" for the annual nonresident salmon limits, with the expectation that the ACs will recommends different numbers to the BOF. Two possession limits have been recommended by other ACs.

Doug shared with the AC it is typical to take other steps, such as reducing bag and/or possession limits, before setting an annual limit.

Discussion on Proposal: It could be ok to set an annual limit tor Coho salmon, but not other salmon. Setting the annual limit on Kings has caused a shift to silvers, and the sport take of silvers is now very large. SSRAA is trying to raise more Cohoes, because there is not enough Cohoes in the water. Other salmon such as pinks, dogs and sockeye are generally targeted for charter fishing. With the current limits on halibut take,

placing limits on salmon take would result in an unmarketable charter fishing opportunity to non-residents. There are too many sport caught salmon leaving the state: with an example of a yacht having to buy another freezer, prior to heading south, to hold their sport catch. SSRAA is working hard to put more salmon in the water and the commercial gear groups are fighting for those fish. It is OK to have a yearly bag limit for nonresident salmon take, and two bag limits is plenty of salmon for a non-resident. All AC members favor Proposal 374 Brennon/Brian PASSED 10-0. This AC has been supportive of this in Southeast and feels it should be put into Statewide Regulation. If the guide is providing their personal or sport caught fish to clients then they are selling it and this is a commercial venture and needs to be illegal.

Proposal 375 Otto/Alan PASSED 10-0. We are supportive of this but want to make sure that regulations are not changed in regard to the current view of a commercial Dungeness pot that is webbed using stainless wire and using the cotton on the door hook for the escape mechanism.

Report

Salmon; Salmon and related fishery report at:

Through our efforts, some progress was made in the area of equity and distribution of these resources for *commercial use*. There still remain inequity, the imbalance remain in favor of the drift net fleet. It was my intention to bring this issue to light, strike a unified effort to bring a balance, and to increase harvest opportunities through change in fishing gear to the time allotted.

I would suggest pushing more proposals as we have done in the past, as the TAC continue to be a voice in the ADF&G, you will be heard and let the Department know that their reports indicate the problem.

Subsistence fishing is also slow to change, change has taken place since 1981, but the balance on resources, specifically the king salmon we use has been taken away from us, for the most part on the restriction of gear and time.

I believe the TAC should continue to push for gear and time to adequately harvest the resources to meet our needs

Subsistence clams; As of this report our proposal to reinstate our area on the Polly Creek as Tyonek Subsistence area (proposal 373). The BOF in Juneau this week, I have no report.

Hooligan harvest, reports indicate, during the past recent years the fishery has harvested over 100,000 pounds a season. One year the report indicates a harvest of 126,000 pounds.

It is my suggestion that TAC make a concerted effort to bring this harvest to an end. This resource is vital for the salmon, seals and beluga and other species.

Moose, ADF&G and other report att;

The tier II is slated for elimination for the 2013 season.

There are no scientific reasons for this proposal but I speculate that other special interests are involved, and I would suggest a battle plan for this move.

Predator control, No report, on brown bear, black bear, I believe this practice has gone on long enough, there are no control measures in the harvest. Reports of carcasses left on side of road, snaring area unmarked, again no control measures.

5. LEGISLATIVE BOARD SEAT ELECTIONS

Nominations asked for Seat H a three year advisory seat, we had two candidates for the seat; they included Reid Brewer he wasn't present at the meeting, but he had verbally expressed interest in severing on the committee. The second candidate was Kristjan Laxfoss, he told the committee why he wanted to serve, and gave us some background information on his commercial fishing and processing experience in the BSAI region. There was some discussion of expanding the committee to accommodate both candidates, or to have and alternate position appointed, the committee decided to vote on the two candidates they had before them. Voting was held by secret ballot, the first vote was a tie 3-3 ballots were counted by the Chairman. Another vote was held and

Mr. Laxfoss won by a count of 4-2 and he joined the committee at the table.

6. ADFG UNALASKA OFFICE FISHERIES UPDATE,

a. Heather Fitch, the ADF&G Unalaska regional biologist gave update on Crab Plan team meeting to be held in Seattle next week. She updated the committee on the Brown King Crab assessment model and the crab stocks under review for the NPFMC Safe Document. She stated: it would be at least two weeks before the TAC amounts would be announced by Fish & Game for the October 15, 2011/12 crab seasons. ADFG staff member Britta Baechler, give and overview of the following fisheries; the Eastern Aleutian Bairdi Tanner fishery, the survey work completed by ADFG showed very few Bairdi Tanner Crab in the Eastern Aleutians districts. Of the three Eastern Aleutian districts, Makushin Bay area looked the best and would possibly open. The Aleutian Island Golden King crab fishery was discussed with the most current harvest results were given fishery is performing well with a high CPUE per pot lift. Unalaska Food & Bait Herring fishery, and Unalaska Island Pink Salmon fishery numbers where discussed as well why theses fisheries are managed out of the Sand Point office and not in Unalaska. The McLees Lake Red Salmon subsistence harvest was discussed and escapement levels are estimated at about 40,000 fish thru the weir for that system in 2011. ADFG has announced that ADFG Comfish division has taken over the weir operation from US Fish and Wildlife for 2012 salmon season.

7. OLD BUSINESS

Sportfish issues were addressed, with Don Tracy Sportfish biologist for the westward area based in the Kodiak office. Don discussed many issues with the committee; his concern with budget cuts the sportsfish division is taking that he doesn't have allotted of resources available to assist us. He was pleased to here that Comfish had money to run the weir at McLees Lake in 2012. Salmon stream baseline survey work needs to be continued on the local streams, especially for the Coho and Red salmon stocks. He urged us to contact are legislators about the situation in the Aleutians and ask for support for the sportfish budget.

Don also thought, we should look into some enchantment grants that could help the Unalaska Schools District hatchery program to enlarge to assist the Red and Coho runs. We discussed the Dungeness Crab Sport Fish bag limit and the concern with poor catches in the Unalaska Bay. Discussion centered on weather we should change the bag limit, not allot of information on the Dungeness situation the catches aren't tracked, and it would have to be taken up out of cycle ACR request in October of 2012. The committee reviewed the response to letters from Jeff Regnart, Director Com Fish, Charles Swanton Director Sport Fish, and Aaron Potter, Alaska Peninsula Area Management Biologist. The Committee's priorities and continued concerns will to be relayed to ADFG Kodiak, Sand Point and Juneau headquarters on various Unalaska ADFG commercial and sportfish needs, which include staffing, salmon stream survey work, enchantment and habitat issues in the Unalaska area.
