Board Generated Proposals:

1. The board voted to create and passed (6-0) a board-generated proposal to close sport fishing for king salmon in the Big Creek drainage, including the outlet of Big Creek on the Naknek River as referenced in RC 135.
2. The board voted (6-0) to create a board-generated proposal to consider allowing permit stacking for set netting in the Egegik and Ugashik districts. This proposal will be deliberated at the Alaska Peninsula/Aleutian Islands Finfish meeting in February/March 2013.
3. The board took no action on a motion to create a board generated proposal to develop a Bristol Bay OEG based on the approved mission statement outlined in *RC #148* as follows:  
*Purpose: ADF&G has agreed to suspend the adoption of various recommended sockeye salmon escapement goals for two years, meaning that the goal will go into effect for the 2015 salmon season. The recommended escapement goals being deferred are Ugashik, Egegik, Naknek, Wood, Igushik, and Nushagak river sockeye salmon. The Nushagak River SEG and OEG will change in 2013, but only to account for the sonar conversion from Bendix to DIDSON. This delay in implementation is intended to give the industry time to meet, discuss, and analyze economic information that would assist the Board in developing OEGs.*

*It is the intention of the Board that a committee be formed with Board member Webster, an ADF&G designee, and a representative of BBSRI (Micheal Link). The commercial fishing industry has pledged a commitment to integrate a professional scientist and an economist in the discussion.*

Miscellaneous Business:

1. Board members Kluberton provided an update on the Upper Cook Inlet Task Force (Task Force). The Task Force met on November, 16, 2012 to discuss the mission statement and better define the purpose of the committee. The December 14, 2012 Task Force meeting was cancelled to wait for more data from the department. Board member Kluberton submitted a refined purpose statement listed below and identified in *RC #146* which the board approved to move onward.

**PURPOSE OF THE TASK FORCE:**

- *To identify and discuss alternative management strategies that allow set gillnetting for sockeye salmon in the East Side Set gillnet fishery (ESSN) and*

*inriver use of Kenai River king salmon during times when the department projects the abundance of late-run king salmon will be below the escapement goal*

- *Input from the public is imperative.*
  - *To bring forward a set of recommendations to the Alaska Board of Fisheries (BOF) at the March 2013 Statewide Finfish meeting.*
    - *Should have a board generated proposal several weeks in advance of the March BOF meeting.*
    - *Town hall style meetings with the focus on task force members similar to BOF committee meetings. Consensus on alternatives is preferred but not necessary for the BOF to discuss changes.*
    - *Management alternatives would likely be reflected in the Late Run King Salmon Management Plan 5AAC 21.359.*
2. Chairman Johnstone led the discussion regarding notice to the public on substitute language. He asked fellow board members to inform him as quickly as possible when a record copy (RC) is generated to provide the public as much notice as possible to review and comment.
  3. Executive Director Wellard provided the board a brief update of the 2014/2015 Prince William Sound and Upper Copper/Upper Susitna River Finfish meeting scheduled to be held in Cordova. Bids have been received from three businesses in Cordova, but more time is needed to evaluate the accommodations being suggested.
