The Department of Law has the following comments on the agenda change requests (ACR's) to be considered by the Board of Fisheries (Board) at its work session on October 9-11, 2012. We have not commented on whether ACRs appear to meet the criteria for accepting ACRs under 5 AAC 39.999(a)(1).

ACR 7. ACR 7 proposes to define and allow a lead for commercial fish wheel gear. The proponent says that the Department of Law has determined that a commercial fish wheel cannot have a lead because it is not in regulation. This is a correct statement of our views on the matter. "Fish wheel" is defined in 5 AAC 39.105(d)(9) (types of legal gear) as "a fixed, rotating device, with no more than four baskets on a single axle, for catching fish which is driven by river current or other means," and the Yukon Area regulation for fish wheel specifications and operations cited by the proponent, 5 AAC 05.333, does not provide for the use of leads. "Lead" is also defined in 5 AAC 39.105(d)(18) as "a length of net employed for guiding fish into a seine or set gillnet," with no mention of fish wheels. We note that the use of leads while subsistence fishing is authorized by 5 AAC 01.010(a)(4), which provides that "a lead which is a length of net employed for guiding fish into a seine, or a length of net or fencing employed for guiding fish into a fish wheel, fyke net, or dip net." We also note in some areas leads are allowed

Fish wheel baskets must be stopped from rotating in the water during periods closed to commercial and subsistence fishing. The fish wheel registrant is responsible for the operation of the fish wheel.
