New Business

Regarding negotiations with Area M. The AC recommended four members for the negotiation committee for Chignik and the Area M Committee demanded that we remove one of the permit holders or they would not negotiate. In order to compromise we removed that member and replaced him with an alternate. Motion by Ben to adopt RC 171 in the spirit of compromise. Seconded by Al. Passed unanimously in support.

Although the Chignik AC Subcommittee still holds the beliefs and reasoning of the previous AC meetings as a whole held on January 19th submitted as AC 10 and February 16th2016, submitted as RC33; in the spirit of compromise, as recommended by the Board of Fish, we have voted to support the terms of R.C. 171. It is essential to the welfare of the Chignik River system and its many tributaries as well as the local residents to include the 300,000 sockeye and 600,000k harvest preference in any further actions by the Board of Fish.

An underlining issue that was not presenting to the Chignik negotiating committee during negotiations was the second portion to RC 167. RC 176 was submitted as a correction to RC 167 and its misconceptions and errors.
