Sitka Community Members,

Board of Fisheries meetings will be held starting on the 14th of January to discuss a number of regulation changes regarding Southeast Alaska Finfish. Among those changes brought before the board are proposals to downsize, and or shut down our local herring sac roe fishery. As we all know the herring fishery is the first financial breath of fresh air in the spring and a huge boost to both small business and the large businesses in this town. Everyone from local restaurant owners and employees, cannery workers, truck drivers and shippers, gas station operators, bartenders and bar owners, hotel and B&B operators, and a number of other goods and services providers will be affected to a detrimental level by the loss of this influx of money and industry. I will be testifying on behalf of the town and supporting the scrutiny and attention to detail in data collection and the record provided by the Sitka branch of the Alaska Department of Fish and Game in their continuous effort to manage a fluctuating resource.
