9. Public Testimony
  - a. Richard Persons:
    - i. Proposal 216 - Sportfish users are allocated 60% of the use and commercial 40% (developed/based on historical use). In-season fisheries management is difficult at best and not well regulated to the best potential. This proposal would allow for better management during the fishery. There are 3 different areas for the commercial fishery only which are rotated each year. This is to reduce conflict with sport users and allow shrimp populations to rebuild. The ADF&G's fishery management activities fall into two categories: in-season management and applied science. For in-season management, the department deploys a cadre of fishery managers near the fisheries. These individuals have broad authority to open and close fisheries based on their professional judgment, the most current biological data from field projects, and fisheries performance. The tools that ADF&G sport fish division have to manage the non-commercial harvest are not enough and not flexible enough.
      1. ADF&G responses to discussion: ADF&G has a joint management plan for the shrimp populations in PWS. Currently, ADF&G are slowly progressing towards registration for permits is online; 2018 will be online. Last year, permits were available at select locations. Permits are available starting in late March each year (typically). Total allowable harvest has only been exceeded one time in 2016. ADF&G would like to see more information but there will be a large burden on the sport fisheries user groups to implement this proposal.



- ii. Proposal 218 and 219 – think that there are serious allocative issues regarding these proposals. This a quota fishery and if there are gill net fisheries and pot fisheries, conflicts will arise.
    - iii. Proposals 223 and 234 – Under current regulations, non-commercial fisheries are allowed to continue if no more than 110,000 pounds of spot fishery by round weight when the commercial fishery is closed. The burden of conservation is not being shared between user groups and should be borne by all participants. Very few non-residents participate in this fishery.
  - b. Brett Wilbanks: Proposal 222 and 225 – the 60% to 40% split between sportfish and commercial use, respectively history is not well-defined. The ADF&G commercial division gets really close to the projected amount of harvest because they have in-season management and reporting. The ADF&G sportfish managers are potentially managing reactively. There is a big risk surrounding the consistency of fishing this resource and that there is no equity is conserving the resource. Would like to see allocation directed more towards the commercial fishery as it is better managed. Not all shrimp live in one administrative area (Areas 1, 2, and 3 [Area 3 being the least productive area by 1/3]) each year and would like to see different allocation between the three areas. The harvest needs to be more equal each year for consistency in the commercial harvest.

  - b. RC 409 – Policy regarding the location of the Upper Cook Inlet Finfish meeting (2020 Upper Cook Inlet Finfish meeting location). The board discussed and agreed to review its consideration of the 2020 Upper Cook Inlet Finfish meeting location.
    - i. Discussion: support because all communities are on the road system and travel is easy and if there aren't flights available, driving is an easy option. These meetings must be in the communities where the resources are used. Opposed because the travel costs to Kenai are high and there are additional costs put on the traveler/interested parties that may inhibit them from traveling to the meeting. We are representing the Anchorage constituents and it is our duty to keep these meeting close to our constituents.
    - ii. Vote: 7 Support; 3 Opposed; 1 abstain. See comments above.
  - c. Possible future proposals for the BOG Southcentral Region and BOF proposals. Deadline is May 1<sup>st</sup> for the BOF and April 10<sup>th</sup> for the BOF.
  - d. Representative to speak at the March 6-9 BOF meeting in Anchorage was suggested to be Kevin Taylor. Dino Sutherland will be the second representative should Kevin not be able to go.

	Support	7	3	<b>Support</b> because there is no other in-season reporting and support the conservation of the resource. If the commercial fishery data is well-managed and quickly analyzed, then the sport fishery can be as well. Suggest not requiring reporting but that the ADF&G strongly urges reporting. Managing 'conservatively' under the current management plan is risky and done by luck rather than biology. Don't see any burden being put on the sport fish users to register shrimp permits. <b>Opposed</b> because there is not a conservation concern from ADF&G and suggest that the overharvest two years ago may have been a survey anomaly. Thought that the May 1 <sup>st</sup> deadline was way too early. Know several users that are opposed to this proposal as they thought the timing of registering and reporting would burden their ability to fish. 1 abstain.

	Opposed	0	11	Allow for harvest of octopus with additional gear while participating in the Prince William Sound noncommercial shrimp fishery. <b>Opposed</b> because this would allow the noncommercial shrimp fishery to have additional pots in the water. Do not support attaching an additional pot to existing shrimp lines; it gets complicated. People are already allowed to retain octopus that are caught in shrimp traps.

	Opposed	0	11	Modify the start date for the Prince William Sound Area sport shrimp pot fishing season, as follow. <b>Opposed</b> because ADF&G has no evidence that there are a large number of females with eggs April 15 <sup>th</sup> . The surveys in October yield a lot of females with eggs. There is no biological reasoning, this is simply an allocative proposal.

	Opposed	0	11	Modify the Prince William Sound Area commercial shrimp pot fishing seasons to separate commercial and noncommercial seasons. <b>Opposed</b> because this would extend the fishery into the fall when shrimp surveys show females with eggs, suggesting that there is biological concern to this proposal. Would limit the number of small boats to access the resource.

This will modify the statistical analysis between Areas 1, 2 and 3. The original lines were likely defined by lack of concrete reasons, and if shifting these lines will enhance the fishery this AC supports this proposal. This will provide stability to the fishery. It is hard to build markets when fishermen cannot predict harvest. Those <b>opposed</b> because there are some areas that are not as productive as others (i.e. Area 3), and if those areas are less productive then fisherman can choose not to fish. 1 abstain.

	Support	7	2	Modify the fishing area rotation system in the Prince William Sound Area commercial shrimp pot fishery.  <b>Support</b> because this would allow less time in less productive areas and more time in more productive areas. Those <b>opposed</b> because there are some areas that are not as productive as others (i.e. Area 3), and if those areas are less productive then fisherman can choose not to fish. 2 abstain

	Opposed	0	11	Remove the total allowable harvest threshold for the Prince William Sound Area commercial shrimp pot fishery.  <b>Opposed</b> because this would remove the Department's tools to manage the fishery.

	Support as amended	7	4	Modify the guideline harvest threshold for the Prince William Sound Area commercial shrimp pot fishery.  <b>Support</b> because the burden of conservation is on the commercial fishery. This proposal would give the Department the latitude to lower the threshold level to allow equal allocation between sport and commercial fisheries. <b>Option A</b> is the preferable alternative, AC unanimously amends to strike Option B. <b>Opposed</b> because historically we have never failed to reach the trigger point and the current number of 110,000 harvestable pounds.

<b>227</b> Repeal Prince William Sound Area commercial winter shrimp trawl fishery fishing season provisions allowing a fall/winter fishery.				
	Opposed	0	11	<p><b>Opposed</b> because this would eliminate the fall fishery, there is no biological concern (i.e. not reaching the GHL).</p>
<b>238</b> Require all anglers to use deep water release mechanisms when releasing rockfish in Prince William Sound				
	Support	10	1	<p><b>Support</b> the implementation of this proposal could increase cost (note that deep water releases are anywhere from \$5 - \$60) so the Department began ADF&amp;G passes out deep water release mechanisms for free (via grant money). Deepwater releases have been shown to be effective – there is a 98% success rate in releasing the fish not at the surface. Are glad the Board suspended adopting this proposal to allow for more public comment. Suggest including enforcement in the development of the regulation to ensure that it's enforceable and written such that the angler is protected from officer discretion. Would rather have the language indicate that the release be on board and be able to be used at the anglers' discretion based on circumstances.</p> <p><b>Opposed</b> because are in favor of the deep-water release but do not like the language suggesting is must be used each and every time a bottom fish is caught because during king trolling there is often pelagic fish that are caught and it is a hassle to stop trolling and release these fish.</p>

One member said 14 days might be tricky for a fisherman to achieve when considering breakdowns and long runs to deliver.

**Election of Galena seats**

Paddy noted that he thought this last term would be his last, it is getting harder and harder to hear, but he will serve one more unless someone else wants to step up.

It was voted that Paddy Nollner, Fred Huntington (who was absent but who had said he wished to continue to serve), and Dick Evens would sit for Galena. Mark Huntington was elected into Charlie Greens seat. Alternates were chosen as Charlie Green and Patrick Lumba.

Committee would also like to change the makeup of the committee; they had opted to only have an AC of 13 while the board authorized them for 15, per notes at the bottom of their roster. Committee would like to fill all seats, so have a full committee of 15.



\* election results then change the members present & the number of members in attendance to 11 members and 15 members would need a quorum of 8. As there are 11 members present, quorum is still met.

### **Concerns of the AC members & public**

Committee members are concerned with their ability to meet more often like the more urban ACs do; Orville Huntington via the TCC was looking into alternative ways for rural ACs to meet more often. Nissa brought up the OWL system (video conferencing typically through libraries) via the State of Alaska's library system and members directed her to look further into this for them.

Lengthy conversation about wolves coming into Nulato and Galena and what can/should be done. Members thought that wolf control through the state should be done with alternative viewpoints is that it was a local issue and that local trappers and hunters should be better supported so that they could take care of the issue themselves.

Concern about required antler cutting as one cannot make crafts out of the cut ones. Glenn noted the reason that the regulation was in place and the committee moved on.

### **Game/ Board of Game Items**

#### **Updates to Age and Antler Data in GMU 21 Presentation; Sara Longson ADF&G**

Members asked several questions and expressed concern that hunters target the younger, more fit bulls.

#### **2018 Harvest Information Presentation; Glenn Stout, ADF&G**

Climate change has done a lot to the population and their habitat, the lakes are drying up where the moose used to feed.

### **Federal Issues**

Discussion of the FWS and ADF&G working closely together to offer a winter antlerless season.

Discussion of having a joint state and federal winter moose hunt. Previously the moose population could not handle this, but the data is showing that the population could withstand the additional pressures. Used to have one on the books but it was taken off because it hadn't been used in a while. Discussion of who should put it in, if it should be put in by the AC or by the Department and the refuge. Would need to ensure that the proposal is written very exactly so to ensure what needs to happen happens. No action item created at this time but should be brought up at next meeting.

### OLD BUSINESS:

- **Draft Proposal:** Moose antler sales
  - Bill Alstrom reported that [the sale of moose antlers] was a problem that was brought up regarding a certain person coming to the villages and buying moose antlers. Some people had antlers stolen out of their yard. Mostly targeting young adults who were going out to make cash. Another issue was the harassment of game. Incidence where moose were being targeted, running them, in hopes they would shed [their antlers] and also people taking the moose for only antlers. Mr. Alstrom commented that he didn't see much activity last summer [2017]. The person who is buying antlers has moved to another community in the lower Yukon. People did address it during a City Council meeting in St. Mary's but it was and they wanted to hear the local tribal governments and ADFG comments.
  - Margaret Guidry commented that her husband got a call from Mt. Village and was encouraged to drive around looking for moose antlers, some were close to \$3,000. Young kids will see the money and see our moose going to waste. Support this proposal draft.

- Bill Alstrom commented that some people are concerned about the harassment. Some question the money people are making and antlers getting stolen...what is that money being used for? He commented that it is a big concern.
- Mathew Waskey reported that he wrote a letter several years ago because of lots of theft, animals were harassed. Wrote a letter that antler sales must be stopped.
- George Beans was favor of this draft proposal. Would like to see the board pass this proposal for all the reasons stated. He commented that a lot of this stuff has been going on. Don't need more reasons to harass or waste the game we depend on. He would support prohibiting all sales.
- Trooper Blajeski commented antler buyers are not a regulated industry. Currently in this region [Mid-Lower Yukon] there were 2 active investigations. One antler buyer tried to sell 6 cutoff antlers. AST was following up. He commented that it was hard from an enforcement standpoint. There was no regulation saying they need to record who they get it from. There can be a lot of cash. ATS does get reports that people shoot 4-6 moose to harvest to sell the antlers.
- Mathew Waskey commented that it increases wanton waste. He provided observations.
- Bill Alstrom commented that part of the reason for this proposal was to address the people who go out just for the antlers. People may just target the bulls for monetary value. He was in support of the proposal.
- Peter Tyson- options may not do any good. One of the options may be to have regulations of the buyers.
- Patrick Jones commented that the board would like to see the ACs preferred options and then point out other options as possible compromises. Unit 23 had a similar social issue with caribou antlers. Mr. Jones explained the Unit 23 process regarding the sale of antlers.
- Bill Alstrom didn't see a problem with carved antlers, but didn't like to see this in bulk. Possible 4<sup>th</sup> option, regulate all antlers except those that have been carved or made into the artwork.

- George Beans commented that he was in favor of this proposal. There is legitimate reasons for this and it has been discussed. If shooting with a smaller caliber, it is just harassment. If you are just popping shots at it, it gets wounded and goes into trees where you are unable to catch it; that is harassment.



**Nenana Elections**

Donald Charlie was elected to fill Ray Stevens seat as he appears to no longer be interested in sitting as he hasn't made the last several meetings. Conrad McManus was voted to be the alternate for Nenana.

**Proposal to be submitted for AYK BOF**

Marv Hassebroek had concerns with the changes in the Winter Subsistence Chatanika Pike Fishery. He originally drafted and submitted a proposal to the BOF with his concerns at the last AYK BOF meeting. This committee supported the proposal. The board chose to pass his proposal with an amendment that there was a three-mile closure around the road. Then the Fairbanks AC submitted an ACR this year to undo this three-mile closure and institute a one-mile closure. After talking to the Division of Sports Fish, he does not think that this closure is sufficient to protect the pike that are overwintering in such a small area and he has concerns that the larger pike, which happen to be the spawning females, are being targeted. The committee did not have the funds to meet prior to the Fairbanks ACR turned proposal



being taken up and wanted to then draft a proposal to submit to the BOF for the AYK BOF meeting to help protect the wintering pike.

After thanking Marv for being concerned and attending the meeting, the committee voted unanimously to draft and submit a proposal requesting protection for overwintering pike. It was noted that people from Minto no longer go to fish at that location, called Four Cabins due to the cost of fuel to get there and that it is too heavily utilized, but they do depend on the fish in the summer that overwinter there for their subsistence needs.

### Commercial Fishing Update

Christy Gleason gave an update on the 2018 winter pike fishery to date and also mentioned to members that to fish through the ice that everyone needs a permit. Even the schools, and they can get an Educational/Cultural permit.

AC member asked that ADFG not collar animals until all hunting seasons are closed to avoid drugs in the meat. Neil assured meeting that all agencies are highly aware of this concern.

Audience member asked AC to report to the Board opposing ADFG funded/operated predator control - he prefers to see all harvest done by locals or public. Control activities should be a public opportunity not an agency activity. ADFG money should not be spent this way but should be spent on research.

AC member regarding 17C winter moose shut down would prefer to shut down fall hunt, very concerned if this goes to Tier 2 hunt but opposed to shutting down winter hunt when that is more a local and subsistence hunt. Neil said about 15% of the fall hunt was nonlocal; we have a lack of data problem. This winter 21 moose were taken. Neil discussed a zone hunt concept due to distribution of moose, some places sparse and some places pretty concentrated. He hopes these studies will provide much better population information.

Another AC member said he is not eager to lose fall hunt, that's when he and his partners get most of their moose. The meat is better and doesn't beat up his snogo and he just doesn't like winter hunt as much.

There was a discussion of the Choggiung land program, and man use days seems the same as 20 years ago but last year they issued 1400 use permits.

AC member would like more discussion on managing moose in areas smaller than GMU subunits but at a later date, no time to get into details here.

AC member - " the current fall hunt regulations took a lot of work to get to what we have. But regulations may not reflect actual hunting pressure - but don't want to see a big rift among locals. Looking forward to new and better data from these studies". "We need to be consistent and unified before the BOG."

AC member: would zones only be for winter hunting? Neil yes.

Upriver AC Member: there is too much hunting pressure in fall and with these winters we can't get out much. But we can't sustain this fall pressure compared to 25 years ago.

END of Barten's presentation

#### Short Break in Discussion.

Dan spoke up to ask the AC to acknowledge the passing of Togiak elder, leader and refuge staff, Peter Abraham 75 yrs old. Several members spoke to Abraham's presence and leadership. The AC offers their condolences to the Abraham family.

#### USFWS Togiak Refuge

Biologist Aderman: reviewed Nushagak Peninsula Caribou, same day airborne dates, Jan 1 to March 31. So far 18 animals taken in Federal Hunt. Since there was a personnel change at



Curyung Tribal office, any remaining permits will be issued only at the Togiak Refuge office in Dillingham.

Aderman noted that last year the caribou planning committee had set a harvest goal of 300 caribou for the Nushagak Peninsula federal hunt. "The goal was too high and should be 218. He announced that USFWS was in the process of issuing a notice officially changing (reducing) the harvest goal for the season. If harvest approaches 200 we may take action. Aderman reiterated harvest reporting requirements. Total caribou harvest for season: 22 since opening in August, 4 in the Nushagak/Mulchatna portion of the hunt and 18 in the Federal Hunt area. Statewide harvest limits and what may be harvested on the Nushagak Peninsula was reviewed. Federal "Designated Hunter" and State Proxy hunts were reviewed.

Chris Maines now of BBNA complimented Andy Aderman for working very well with Tribal agents to keep everybody clear and informed.

AC member suggested adding time to the meeting to discuss BOG strategy, testimony, and the BBNA sponsored class.

Gayla Hoseth, BBNA Natural Resources director invited all interested people to attend the BOG Training class to be held at the local UAF BBC campus. Also mentioned other planning and work done to be ready for the BOG Feb 16-23.

More discussion among AC members regarding consistency in testimony. We need to maintain a professional informed group.

BOARD SUPPORT: Taryn explained Open Meeting Act regarding taking any action or decisions beyond this meeting. Need to have reasonable public notice. Also she announced that ADFG Board will offer a training session Friday on how to be effective at Board meetings.

Audience member reminded all present that the AC is bound by the meeting minutes.

BREAK 10:20 TO 10:30

As meeting resumed Chair asked for public comments. None offered. He reminded all that On Time Comments are due February 23.

## VIII New Business Continued

### AC Response to Board Process regarding proposal 236:

Chairman Frank said he would like to see the AC write a letter that such out of cycle proposals interferes with the normal proposal cycle or ACR proposal processes.

Other AC members stated it was wrong for the Board Chair to apparently circumvent their own process. Speaker said to emphasize "Circumvent".

A board proposal like this shouldn't override the public process. This issue should come up in the normal cycle where other fleets could be expecting and aware of the proposal.

Another comment, this is not a proper Board Proposal. "Thousands of hours have been spent developing the Togiak Herring fishery and for the Board chair to convert a late letter into a BOF generated proposal is out of line."

Numerous AC members expressed concern for process by which this proposal was generated: this does not appear to be a proper ACR, numerous objections for it coming out of cycle, especially as it is an allocative proposal. Opposed on process alone. Appears it was not properly submitted to ACR process. BOF did not go through due diligence process to create a Board proposal.

Dunaway strongly opposed on lack of proper process 1) apparent failure to observe board's own criteria; 2) its allocative and out of cycle; 3) does not address who is helped or hurt like normal proposals and may only favor a very few fishermen.

AC member read out loud, Joint Board's policy on Board Generated Proposals. In her opinion NONE of the Boards' own criteria were met by the original letter to the BOF.

Another AC member noted that the letter writers made some effort by attending the Work shop and the board may have felt that effort deserved attention.

Several commenters asserted the original letter did not amount to a proper ACR and missed the deadline to become an ACR.

Board and letter did not address potential impacts to the Togiak Herring Plan or fishery.

**\*\*\* Dan moved and Joe 2nd for the AC to write a letter to the Board of Fish** objecting to the apparent circumventing of the Board's own process for creating ACR, disregarding impacts to other fisheries and other Board policies and practices. Letter to be delivered to the Board of Fisheries by February 23 to be included in the On Time Comments.

"Include in the letter all the points that have come up in the AC discussion so far." "Go right down the Board Criteria" but realize that most of the BOF voted in approval. Possibly they overlooked or didn't realize the potential impacts / allocative aspects to other fisheries. A committee of Susie Brito, Dan and Frank were selected to write the letter. Input welcomed from local herring fishermen and local former Board of Fish Members.



Motion should include sending copies to the Commissioner and Fisheries Board Director in addition to the Board of Fish.

**Motion Carried 12-0** to include copies to Commissioner and Director.

**2) Board of Fisheries 2018-2019 Call For Proposals. April, 10, 2018 submission deadline.**

Board of Fisheries will meet in Dillingham November 28-December 4, 2018 to consider Bristol Bay fin fish fisheries.

Board will meet in Anchorage at the Sheraton to deal with Alaska Peninsula (Feb 20-27 2019) and Statewide (March 8-11 2019) proposals.

Chair invited everyone to bring forth ideas for proposals.

1) Some fishermen want clarity how the Department allocates salmon among commercial gear groups in the Wood River Special Harvest Area after the July 17 emergency order period ends. ADFG explained how they have been doing it following the Wood R. Management Plan. Some fishers disagree with ADFG interpretation and think allocation should end with the EO period. All allocation in Bristol Bay is supposed to go away July 17 and all gear should be allowed in the Wood River when it is opened for surplus fish.

Sands 2 reasons to go and the 3 drift openers to each 1 set opener was for 1) an orderly fishery in river when there are enough fish in Wood River but Nushagak River reds need protection. 2) To harvest surplus fish in times of abundance and the guidelines are to first allow opportunity to the gear group that is behind in allocation. Nothing is said about the July 17 period ending this. In 2014 the situation favored drifters and in 2017 the set nets.

Lack of market in Wood River is a problem - it might not be fished if there is no place close to sell the fish.. Its been more likely that set nets are willing to go into the Wood R.

It shouldn't be up to interpretation on how the allocation and Wood River runs after July 17. Need to clarify what happens July 17.

*Discussion postponed for later in the meeting.*

2) There was a discussion of the regulations and enforcement regarding the extent to which a set net permit holder must be physically present on the site and or net. It appears that commonly fish are being picked and even delivered yet the permit holder is not on site. Consistency in interpretation and enforcement is desired. Current regulations were reviewed: Drifters much be present on the boat. It appears Set permit holder is to be on site but not necessarily at the net: 5AAC 39.107(d). These regulations may be getting stretched by set nets and even buyers.

There may have been abuses and it should be tightened up.  
Some set fisheries support sites may be miles from the location of the net site.  
Comment: "My cabin is 6 miles from my nets, be careful with this issue."



Current regulation is vague.

There have been cases where the permit holder was the only person able to take a sick crewmember to the hospital in Dillingham and left the site while the nets were fishing and fishing was open. Others go get supplies while fishing open.

Comments that permit holder should be physically present while the net is being worked but maybe not needed when the net is legally fishing.

Each site and operation is different, the nets are anchored so very different from drifting boats and nets. Vagueness allows the flexibility needed for these unique sites.

For multiple site holders, requiring permittee to be present on a net would be very complicated.

Some permit holders and fish buyers allowing crew to deliver fish and permit holder not at point of sale.

### **12:05 to 13:07 Lunch Break**

#### **ENFORCEMENT**

Chair invited Fish and Wildlife Trooper to discuss his work.

Joe Wittkop said there were substantial violations in excess offshore distance for set nets in Togiak and it appeared there were a lot of fishers misunderstanding the regulations.

Regulations appear widely misunderstood or ignored and public education may be a way to address this problem. He expects to review the regulations with users to help compliance.

There are 3 areas where set nets can only fish out 500 feet while the rest of the district the limit is 1,000 feet.

Togiak AC rep said he thinks many don't understand the regulation.

Trooper was encouraged to work with the Togiak AC to improve understanding.

#### **SPORT FISH**

Lee Borden assistant Sport Fish Biologist discussed their guide log book and statewide harvest survey data for 2017 has not been analyzed yet - due out in June.

There is no King Salmon forecast.

#### **COMMERCIAL FISH CONTINUED**

Tim Sands was asked to outline the State's Bristol Bay Sockeye salmon forecast for 2018.

Forecast is very large at 37.6 million. Nushagak forecast is 21.79 million total run with 18.5 harvest predicted. 2017 total run was over 20 million raises questions how 2018 will pan out.

Togiak Herring is forecast of 136 tons.

There is public interest and desire expressed for a directed commercial King Salmon opening in the Nushagak.

Sands, since there is no forecast (since 2014) management is done based on escapement data in-season and the Nushagak King Salmon Plan is still functional. Tim explained ADFG is not comfortable using the sonar data for scientific forecasts but its still sufficient as an index for management.



**WOOD RIVER SPECIAL HARVEST AREA DISCUSSION resumed.**

After much discussion in all aspects:

Could be a mess to throw both gear types in Wood River at one time what about alternating gear types after 17th ?

A proposal to change any part of the Wood River plan opens entire plan to changes - several other items could be addressed.

Question whether the 2017 situation was a one time thing. Need to get more input from others to justify AC spending more time on this.

Originator of the discussion just want to define or clarify the allocation situation and may submit a proposal seeking to clarify this issue.

Another AC member thinks this needs attention and its the job of the AC, and it would be better for the AC to create a proposal rather than trying to insert AC concerns into some unknown proposal that may come along.

What about opening Wood River "old School Style" if there is a surplus and after the allocation period? No allocation. Usually fishing drops off pretty fast and so would effort, reducing safety concerns while providing a little more harvest opportunity for a few.

Extended discussion on this and meddling in allocation made some uncomfortable, looking for clarity and consistency. Safety issues, original intent of fishery. Wood River special area originated to protect Nushagak Coho.

**\*\*\* Tom Moved Susie 2nd:** The AC will write a proposal to end gear allocation considerations in the WRSWA July 17; if escapement is exceeding goal the WRSWA will open to all gear types at the same time.

Discussion. Some prefer to let public bring proposals forward.

Need to address gear use and operation.

We seem to be addressing a concern of one individual, it doesn't appear to be a widespread issue.

**Motion Failed: Yes 2 Oppose 9 \*\*\* see motion to reconsider further in these minutes.\*\*\***

More discussion on purpose of meeting and when / what issues should AC write a proposal vs leaving the public to initiate them.

The Nushagak King Salmon Plan was brought up. One person wanted to change the word "projected" to "documented" so all users understand there is a clear target; wants the plan totally clear and unambiguous. What does "projected mean".

ADFG would still have to "interpret" and use their judgment.

We have good attendance its good to discuss this here.

More discussion how Com Fish uses Pan with available data, interpretation of the lanuage.

What is the problem here? Are we afraid of what might happen?

Maybe there is a concern how a different manager would interpret the plan.



**\*\*\* Susie Move and Joe / Gayla 2nd:** to amend the Nushagak King Salmon Management Plan wording as referenced by Robert Heyano from "projected" to some word more definitive such as "documented".

More discussion on role of AC and whether it needs to write such a proposal.  
Others did not want to open the Plan.

**Motion Failed Yes 1 Opposed 9**

Break 2:58 - 3:06.

Susie brought up her experiences of needed to contact subsistence salmon fishers in Dillingham area where their nets needed attention. She would like to see phone numbers required on signs of unattended nets.

**\*\*\* Susie Moved Gayla 2nd** to: Add to subsistence site marking requirements, the permittee's phone number.

Every year she finds nets that need some sort of attention, floating away in an extra high tide and catching fish, tangled nets or other problems. It would be nice to contact owner vs calling enforcement or making a big deal.

Privacy concerns were quickly raised. Many people have unknown phone numbers and are NOT eager to display them to the public. Could also precipitate controversies. And not everybody has a phone.

**Motion Failed Yes 0 Opposed 10**

Cody Larson BBNA asked the AC to consider a proposal to eliminate the 3 day per week subsistence salmon closures in the vicinity of Dillingham.

There is no conservation issue, there are many other controls including 10 fathom requirement, permit required, site sign with permit required.

ADFG says the 3 day per week rules are their most commonly asked question and its very confusing to much of the public. Its very burdensome on the department in a very busy time of year.

Troopers agree, there is lots of confusion. when there is little conservation concern and no harvest limits. It may help avoid waste since there is no mandatory net checks,.

Comments that the regulation amounts to a mandatory net check.

Another AC member said it can be very hard to get good fishing conditions on those particular days, especially if you have an 8-5 job. Very frustrating especially if you fish up toward Lewis Point or across the river. "I would love to get rid of that rule."

Most people know how to handle and manage their gear.



A public comment: It [conservation / waste] is a problem and will be a problem. There is plenty of opportunity with current regulations and plenty of fish.

**Curt departed meeting approximately 2:50** Still have a quorum.

**\*\*\* Gayla Moved Dan 2nd:** To write a proposal to eliminate the 3 day per week subsistence salmon closures in the Dillingham area [??? 5AAC 01.310 (d) ?? needs verification].

Gayla spoke to reasons already discussed.

Dan supported for Todd's concerns and as competition for sites increases, more open days may reduce crowding. He does have concerns as there are always a few sloppy fishers who may waste fish and not attend their nets carefully.

AC member, the whole closure problem is mostly on Dillingham beaches and does not favor this idea.

What if WRSMA is open commercially then the area available to subsistence close to Dillingham is greatly reduced forcing people to head toward Lewis Point.

There is no leeway for ADFG to adjust the WRSMA. This is an obstruction for the priority use. Subsistence is the priority and should be minimally restricted.

This meeting was to bring up ideas for proposals not necessarily to write proposals.

Cody was hoping for AC support on this, BBNA will be submitting such a proposal. More discussion on writing proposals.

**Motion Carried 5 yes 4 opposed**

Committee appointed to write the proposal: Dan Gayla Todd.

**Susie departs meeting 3:42 quorum still present at 9 members.**

**\*\*\* Gayla moved Dan 2nd to:** write an AC proposal to allow drift net salmon subsistence fishing in the Dillingham area.

This went before the BOF in 2009 and was rejected.

The problem was in 2009 it was for the whole drainage not just close to Dillingham and Nushagak River lodges were very opposed.

Potential for excess harvest and its ok to have some reasonable restrictions on subsistence. We have plenty of opportunity already, plenty of fish.

Some felt it would be a safety issue and interested in allowing safer fishing.

What's works drifting and attending net or leaving it out overnight and getting overloaded with fish?

Subsistence drifting at night could be really dangerous especially near peak of commercial fishery and all the boat traffic.

**Curt rejoined meeting 4:00**

Some drifting goes on already though its illegal, especially from Tule or Lewis Point on up to Black Point.



People just do it to get their smoke houses filled efficiently and don't take more than they need and then they are free to pursue commercial season.  
If adopted it should be only in the subsistence area close to Dillingham from Lewis Point down to a short way below Dillingham.

**Motion Carried Yes 7 Oppose 3**

Writing committee Dan Todd Gayla with assistance from Cody.

**Motion Gayla moved Joe 2nd to:** reconsider the Wood River allocation issue previously discussed in this meeting.

Joe, part of the process of the AC is to bring things to the Board, especially allocative concerns. I suggest the AC should write a proposal .

AC member, its better to start with our own proposal vs hoping a proposal "floats up" that we can try to squeeze our issues into it - that can be messy.

What is the problem we are trying to address? How many people really care about this?

It doesn't matter how many people, our job is to try to address it.

**Motion To Reconsider Carries Yes 8 Opposed 2**

**Tom Moved, Joe 2nd to:** the effect "When escapement warrants and after July 17m the ADFG may open by Emergency Order the WRSHA to both gear groups. The justification will be to prosecute a commercial fishery after July 17 and provide additional harvest opportunity.

Aleknagik AC rep says Aleknagik is adamantly opposed to Any in-river commercial fishery in the Wood River.

**Motion Carries Yes 6 Opposed 3**

Tom Joe and Frank assigned as proposal writing committee.

**OTHER NEW BUSINESS**

1. Approval of minutes for the March 2017 Statewide BOF meeting and Proposal 236 response.

**Tom move Gayla 2nd:** Dan to write up minutes and submit to Frank for review and approval and submission on time February 23.

**Motion carried unanimous.**

2. AC representation at the March 6 -9 BOF meeting.

Given the AC's concerns on 236 it would be important to have an AC rep at the board. Unanimous consent, Frank should go. Dan might be able to attend but uncertain.

3. Reminders:

Fish proposals due to Boards April 10

"On Time" comments on proposals will be due November 14.



Comment: the AC should meet to review proposals later in the year, preferably once ADFG positions and comments are available.

4. Joint Boards meeting expected next spring. This may be decided at the BOG meeting here in February.

Dear Chairman Jensen and Members of the Board,

We are writing in regards to the Board Generated Proposal #236 amending the Bering Sea Herring Fishery Management Plan. As an Advisory Committee (AC) we feel due public process has been circumvented in the creation of this proposal and that it does not meet the four criteria outlined in October of 2013 by the Alaska Joint Boards of Fisheries and Game for development of Board Generated Proposals.

Proposal #236, if passed, will effectively do two things, first it will change the opening dates of the Alaska Peninsula-Aleutian Islands Area herring seine fishery, and secondly it will amend the allocation plan of the Bristol Bay Togiak District herring harvest. The Dutch Harbor herring fishery currently harvests a mixed stock of herring with a large portion of that coming from herring that spawn in the Togiak District of Bristol Bay. If the change in allocation that is proposed is passed, it will reallocate additional herring from the Togiak herring fishery to the Dutch Harbor herring fishery out of cycle and increase quota in a Mixed Stock Fishery. These aspects are concerning to the Nushagak AC and we feel stakeholders have not had adequate notice of this proposed change nor do we feel this proposal is warranted as outlined below with the Board's own criteria for generating proposals.

Criteria 1 states that the proposal be in the public's best interest. This proposal was generated in response to one letter submitted to the Board of Fisheries Work Session as Public Comment 026. As it was not received as an Agenda Change Request there was not adequate response time by Advisory Committees or members of the public at the Work Session. The proposal was generated within a few moments of on the record discussion and it did not seem to be adequately vetted.

Criteria 2 states there be an urgency in considering the issue. As it is within the authority of the Commissioner's Office to Emergency Order date changes to this fishery it is the AC's opinion this proposal should be taken up in cycle for discussion. There is no urgency to the allocative aspect of this proposal nor should this discussion be undertaken outside of the regular board cycle as it disenfranchises Bristol Bay Area Advisory Committees who are unable to travel to applicable Board meetings, receive adequate feedback from ADF&G managers, and speak with community members on potential impacts within the region.

Criteria 3 stipulates that the current process be inadequate for bringing the subject to the board's attention. The Bristol Bay and Alaska Peninsula-Aleutian Island Area's Board of Fisheries cycle will occur 2018-2019 with the call for proposals being currently out. It is our AC's opinion that this proposal needs



to be submitted through the regular board cycle, this system adequately allows interested parties to participate in the creation and amending of regulations.

Criteria 4 mandates there be adequate and reasonable opportunity for public comment. Taking into consideration that this proposal has been generated out of cycle alone creates barriers to adequate response. Advisory Committees in the Bristol Bay Area that would be affected by the allocation change in the Togiak Herring fishery would not be able to cover the costs incurred to travel to and attend the Statewide Board of Fish meeting. Nor is it reasonable to expect that individual users would be able to pay their own way to attend for this proposal when the next Bristol Bay Finfish meeting will be held in Region next November.

It is the Nushagak Advisory Committee's opinion that the Alaska Board of Fisheries should not be addressing allocative issues out of cycle and that this proposal jeopardizes the Alaska Board of Fisheries public perception of a fair and just process. We urge the Board to take no action on this proposal and encourage the proponents of the initial Public Comment to submit an In-Cycle proposal by the April 10, 2018 deadline to have this issue heard at both the Bristol Bay Finfish and the Alaska Peninsula Aleutian Island Finfish meetings in 2018/2019's BOF cycle. In addition to this letter the Nushagak AC will be submitting our meeting minutes as comment to the 2017/2018 Statewide BOF meeting outlining AC discussion and action taken on Board Generated Proposal 236.

We are writing in regards to the Alaska Board of Fisheries Board Generated Proposal #236 amending the Bering Sea Herring Fishery Management Plan. As an Advisory Committee (AC) we feel due public process has been circumvented in the creation of this proposal and that it does not meet the four criteria outlined in October of 2013 by the Alaska Joint Boards of Fisheries and Game for development of Board Generated Proposals. In recent history the Board of Fisheries has faced criticism regarding it's use of the Board Generated Proposal avenue for creating regulations and our AC feels the Board is misusing its authority in this instance with Proposal 236.

It is the Nushagak Advisory Committee's opinion that the Alaska Board of Fisheries (BOF) should not be addressing allocative issues out of cycle and that this proposal jeopardizes the Alaska Board of Fisheries public perception of a fair and just process. We are urging the Board to take no action on this proposal and encourage the proponents of the initial Public Comment to submit an In-Cycle proposal by the April 10, 2018 deadline to have this issue heard at both the Bristol Bay Finfish and the Alaska Peninsula Aleutian Island Finfish meetings in 2018/2019's BOF cycle. In addition to this letter, and one directly to the Alaska Board of Fisheries, the Nushagak AC will be submitting our most recent meeting minutes as comment to the 2017/2018 Statewide BOF meeting outlining AC discussion and action taken on Board Generated Proposal 236.

In response to the criteria set forth by the Alaska Joint Boards of Fisheries and Game we as an AC found the following:

Criteria 1 states that the proposal be in the public's best interest. This proposal was generated in response to one letter submitted to the Board of Fisheries Work Session as Public Comment 026. As it was not received as an Agenda Change Request there was not adequate response time by Advisory Committees or members of the public at the Work Session. The Bristol Bay and Alaska Peninsula-Aleutian Island Area's Board of Fisheries cycle will occur 2018-2019 with the call for proposals being currently out. It is our AC's opinion that this proposal needs to be submitted through the regular board cycle as this system adequately allows interested parties to participate in the creation and amending of fisheries regulations.

Criteria 4 mandates there be adequate and reasonable opportunity for public comment. Taking into consideration that this proposal has been generated out of cycle alone creates barriers to adequate response. Advisory Committees in the Bristol Bay Area that would be affected by the allocative change in the Togiak Herring fishery would not be able to cover the costs incurred to travel to and attend the Statewide Board of Fish meeting. Nor is it reasonable to expect that individual users would be able to pay their own way to attend for this proposal when the next Bristol Bay Finfish meeting will be held in Region next November.

We appreciate your attention in this matter and feel our regulatory process allows for public participation in a unique way. We are proud to be a part of the discussion and want to see our Boards held to a standard that allows for fair and equitable participation by all user groups.

Dear Chairman Jensen and Board of Fisheries Members,

The Petersburg ADF&G Advisory Committee has the following comments and suggestions concerning Miscellaneous Agenda items scheduled for the March Statewide meeting.

*North Pacific Fishery Management Council Gulf of Alaska Chinook salmon Prohibited Species Catch Limit Increase.*

In February the NPFMC asked for an additional Initial Review of the proposed increase of Chinook salmon PSC in non-pollock trawl fisheries for further analysis. While Chinook stocks are being rebuilt in Southeast, we believe PSC fisheries need to share the burden of conservation. We ask the Board of Fisheries urge the Council to take no action for the following reasons:

-January Board of Fish actions regarding the directed Chinook subsistence, personal use, and commercial fisheries.

-Designation of the Chilkat River, Unuk River, and King Salmon River in Southeast Alaska as 'Stocks of Concern.'

-According to the staff analysis and the most recent available data on GOA PSC caught Chinook stock genetics, *'roughly 15% come from Southeast Alaska'* (C3 GOA Chinook PSC February 2018 page 14).

- Several rivers in Southeast have pre-season forecasts for 2018 below escapement goals including the Situk River, Chilkat River, Taku River, Stikine River, and Unuk River (December 22, 2017 Southeast Chinook Forecasts).

-Chinook salmon stocks have remained below average throughout the state of Alaska since 2007. And Chinook runs along portions of the West Coast outside of Alaska have declined similarly.

-Amendment 103 gave NMFS the authority to reapportion Chinook salmon PSC inseason, between trawl sectors, on their own discretion. This action was implemented in 2017 as a management tool to prevent a situation where a sector could not meet an unexpected need for Chinook PSC. NMFS should be given more time to use this



program to determine if it is sufficient before increasing the cap.

### *Sea Otter Depredation*

As you know, sea otter predation has been an increasing problem and recurring theme at board meetings in Southeast. We request the board write a letter to Secretary Zinke, Alaska's Congressional Delegation, and Governor Walker expressing the need for a sea otter management plan and the impacts of the expanding biomass on shellfish resources managed by the board.

Points for the board to consider regarding the sea otter population in Southeast Alaska:

-Between 1965 and 1969 ADF&G released 400 sea otters in six locations in Southeast, in the absence of a management plan, the biomass has grown to an estimated 11,000 in the last survey conducted by the United States Fish and Wildlife Service in 2010 and 2011.

-USFWS further estimates the growth rate of Northern sea otters in Southeast is 13% per year.

-They further estimate the potential biological removals in Southeast are 2,147 animals per year, while human removals only account for 447.

- The Southcentral and Southeast Alaska stocks are neither listed as "depleted" under the MMPA or listed as "threatened" or "endangered" under the Endangered Species Act, nor are they likely to be listed as such in the foreseeable future according to USFWS.

-The growing sea otter population has created an ecosystem imbalance resulting in declining subsistence and commercial harvests of shellfish.

The Marine Mammal Protection Act governs the harvest and use of sea otters. Possible amendments to the MMPA to increase the profitability of harvest of sea otters and shellfish resources for coastal communities:

-Request ADF&G be given authority to establish a plan for sea otter management that will maintain a sustainable ecosystem-based harvest of sea otters and shellfish resources.

-Allow the sale and foreign export of sea otter pelts.

-Allow Non-Native Alaskans to assist in the harvest of sea otters through transportation or other guide services.

-Allow Native Alaskans to assign their right to harvest sea otters to any individual with a ADF&G hunting license.

-Lower the blood quantum for Coastal Native Alaskans eligible to harvest from 1/8 to 1/16 or allow Native Alaskans outside of Coastal communities to harvest sea otters.

**PROPOSAL XXX – 5 AAC 27.XXX. New Section.** Establish a commercial open pound herring spawn on kelp fishery in Sitka Sound as follows:

The Petersburg Advisory Committee **opposes** proposal EF-F17-067 to establish a commercial open pound herring spawn on kelp fishery in Sitka Sound. Our committee deliberated on this proposal and its related agenda items to be discussed during the miscellaneous business portion of the board of fish statewide meeting, and we opposed this proposal for the following reasons.

We believe there is a reasonable expectation of fishing a designated area when a fisherman purchases the Northern Southeast spawn on kelp permit. Also, the Northern Southeast spawn on kelp permit should be used for all spawn on kelp fisheries in all of the northern districts. The proposed change in regulation to allow the Sitka sac roe permit holders to choose open pound spawn on kelp as an alternative to seining was seen by our advisory committee as harmful to the Northern Southeast spawn on kelp permit holders. This proposal does not acknowledge the current regulatory areas designated for the Northern Southeast spawn on kelp permit. In 2015 the CFEC held a hearing to consider this regulatory proposal by looking at new information. After the hearing the CFEC determined that the area designation was correct to have Sitka Sound as part of the Northern Southeast pound permit.

We also acknowledged another overwhelming problem this would create is the introduction of more spawn on kelp product into the market. The effect of the oversupply would lower the price point and cause financial harm to the existing spawn on kelp fisheries. Both the Northern and Southern Southeast spawn on kelp fisheries would be affected by the additional large volume of product produced by an unknown amount of participants in an open pound fishery in Sitka Sound. If all the Sitka sac roe permit holders elected to switch to open pound in one season the market for the spawn on kelp product would



plummet and financially devastate both the Northern and Southern Southeast spawn on kelp fisheries. There would be no continuous financial loss to the Sitka sac roe permit holders because they would elect to switch from open pound back to sac roe. This suggests that an optimum number of permits for the spawn on kelp fishery would also be exceeded by allowing the sac roe permit holders to choose to open pound as an alternative to seining as suggested by this proposal. We believe the effect of this proposal would result in financial loss to the existing Northern and Southern Southeast spawn on kelp fisheries.

Chair Report: ADF&G is forecasting a year like last year as far as Chinook returns; following year, not so good. The ocean forecast by ADF&G researchers using juvenile abundance in the ocean predicts poorer returns in 2020 and 2021. Discussion of the



context that the Chinook run on the Yukon River cannot be considered to be rebuilt at this point.

The Yukon River Tribal Fish Commission has in the past year become potentially a major player in how Yukon River fisheries will be managed in the future. Charlie Wright is a delegate from our area. How we approve and disapprove fisheries proposals from other areas takes on a different meaning based on this new political alignment.

#### Fisheries Issues:

**Concerns of AC Members**

	TNA			Committee was originally planning on opposing the proposal, but ultimately the committee decided they didn't want to take this tool away from the managers so that these valuable fish don't get wasted when the lower river has enough subsistence caught kings. In turn then we would like to trust the managers to realize that there is a concern if a lot of kings start hitting the market. We were told that less than 100 kings were caught last year in this fishery. An increase from this number is concerning for us.

### Federal Issues

#### *Federal Subsistence Proposal WP18-56*

- The proposal requests that the Arctic Village Sheep Management Area (AVSMA) in Unit 25A be open to the harvest of sheep by non-Federally qualified users.
- Copies of the Executive Summary, including the Eastern Interior and North Slope Federal Subsistence Regional Advisory Councils recommendations were shared with the Advisory Committee
- Vince Mathews (Yukon Flats National Wildlife Refuge) gave an overview of the proposal and a summary of the Regional Advisory Councils recommendations and justifications
  - Eastern Interior Regional Advisory Council supported the proposal with the amendment to open only that portion of the AVSMA that is north of Cane Creek to the harvest of sheep by non-Federally qualified users. The amendment was to alleviate some potential conservation concerns to open only a portion the AVSMA.
  - North Slope Regional Advisory Council oppose the proposal
- Advisory Committee Discussion:



- There has not been an increase in the sheep population even with the closure and limited harvest by federally qualified subsistence users. It should remain closed.
- It was noted that the sheep population in the modified area could not support if the 51 people commenting in support of the proposal were to hunt there.
- There was a general discussion about the importance of this area to Arctic Village and the need to maintain the closure.
- The Advisory Committee member from Arctic Village shared the desire of several fellow village sheep hunters to be licensed guides for sheep for this area. The guide service discussion included the difficulties and challenges to become licensed guides.
  - Refuge staff pointed out the issue before them is opening the AVSMA to non-Federally qualified hunters. If the area was opened, then the desires for a guide service could be explored.
- Advisory Committee Action:
  - A motion to oppose the proposal was made and seconded. The motion passed unanimously (VOTE: 9-0-0).

### Other Items

There is a moose meeting in Fort Yukon on April 17<sup>th</sup> and 18<sup>th</sup> but we don't have any current moose counts for the flats. no moose counts there,

The state is mining lands and we need to take care of Chandalar River. There is little oversight happening there and we don't want to see an oil spill like what happened in 1982 in Birch Creek where there was a spill and the fish got whipped out. We would also like a say in BLM land reviews so that these operations do not interfere with fish and moose populations there.

Charles expressed concern with Fortymile caribou herd; he had heard that there was a lot of wanton waste this year and members believe that more hunter education is needed in the area. Nissa Pilcher took his number down to pass along to Jeff Gross, the area biologist for the herd. Also asked about any wolf research projects being done in the flats as they are seeing more wolves in Circle, although he attributed that to also the presence of more caribou from the Fortymile herd. No wolf projects since the last one wrapped up 8 years ago, although Nathan Hawkan (FWS) noted that CATG wanted to hold some trapping clinics and the refuge helped fund some supplies.

Andrew asked about the lynx movement study; Initial efforts last year, more traps being deployed very soon to collar more of them, and trail cameras are out. A presentation is planned by the researcher this spring at the Eastern Interior Regional Advisory Council Meeting.
