- VI. Address Proposals 128-143: Department comments are not published/available at this time. Discussions and comments are listed in the Table below.
- VII. New Business- August Genetics Samples: Staff was asked details of the 8/8-8/9 genetic samples taken in Chignik last summer. The samples have not been turned in to the lab. Dawn Wilburn is still meeting with people and the decision hasn't been made to extract the information yet. Members were concerned that the info would not be available for the 2018 Chignik AMR and that scientific data that could have influence was being omitted.

It was thought that the grantors of this study probably didn't intend for samples to be taken but info not extracted. It appeared to some that the Department is "cherry picking" information. A lack of openness and transparency was sensed. It was suggested a lawyer could help resolve this and it was noted that the Fish and Game in the past always wanted studies for information in Chignik, but now information was being intentionally held back.

Poor quality of escapement was brought up and the fact that fishermen are stretching their catching efforts later, but it was thought this year's late run fish would help mitigate damages to the failed run.

CRAA identified a uniqueness of the August sample dates and that they coincide with the final dates the WASSIP study dates in Chignik. These later dates are of greater importance now as shifts in the runs are identified and a record should be being built. CRAA also mentioned that it pays FRI \$10,000 for analysis of the samples and they aren't getting the data.

It was agreed that CRAA would draft language for a resolution to process the samples for AC consideration at the meeting on Dec. 12<sup>th</sup>.

Needed is the Board of Fisheries to help restore Chignik by limiting the interception of Chignik-bound sockeye salmon in Area M to where enough sockeye salmon are available in Area L waters for escapements and economic sustainability.</li> <li>While Chignik fishermen do not have an interception fishery nor alternative sockeye fisheries, South Alaska Peninsula set net fishermen have a multitude of areas to fish other than the SEDM when Chignik sockeye runs are weak as in 2017 and 2018.</li> <li>Currently, Chignik must forgo harvest opportunity (weeks or more) of other salmon species when waiting for daily escapement to be met. It can not rely on the opportunity of other species on weak sockeye runs to supplement income.</li> <li>SEDM fishery presently is based on prediction rather than fact and can contribute to lengthy closures (waiting for escapement) in Chignik, thus precluding harvest preference in the SEDM fishery is woefully insufficient to ensure economic sustainability in the Chignik fishery and does not offer economic stability to the 60 permits fishing let alone all 100 (approx.). It would equate to disaster levels in Chignik and 600k does not provide a healthy fishery that regulation, when made, would indicate.</li> <li>The 600k is outdated and needs upgrading.</li> </ul>

The target species is sockeye salmon, and it is purely an intercept fishery without any measurable contribution of local SP stocks (&lt;1%). The tide needs to turna conservation assignment and more accountability and control are needed.</li> <li>The current plan does not effectively limit the interception of sockeye salmon to the degree intended. This is because while the 191k sockeye salmon cap is tallied on the entire Dolgoi Island Area catch, once that trigger is reached the fleet is still permitted to fish in about 50% of the Dolgoi Island Area. Originally it was assumed that the area remaining open would be rather unproductive; catches indicated the opposite. Fish from the closed areas move into the areas still open and are susceptible.</li> <li>Needed is for the entire Dolgoi Island Area to be closed once the 191k trigger is reached not just a portion.</li> <li>The proposed Dolgoi Island area fishery changes are in line with the intent of the BOF's Policy for the Management of Sustainable Salmon Fisheries as they call for ensuring Chignik escapement and a harvest preference in the Chignik River system. To survive, Area M interception fisheries need to share in the burden of conservation and limit their take on Chignik-bound sockeye salmon. It is only fair.</li> <li>The Department asked to clarify if the intent was that no terminal area would be closed. This began a lengthy discussion on how the terminal harvest was prosecuted. 2) WHAT IS THE PROBLEM YOU WOULD LIKE THE BOARD TO ADDRESS? STATE IN DETAIL THE NATURE OF THE CURRENT PROBLEM. Address only one issue. State the problem clearly and concisely. The board will reject multiple or confusing issues.

The current disastrous sockeye salmon season in Chignik shows that there is inadequate sharing of the burden of conservation in the South Peninsula and, most notably, in the Shumagin Islands fishery. In particular, there are no windows during which there is no commercial fishing gear in the water during the June 7 - 30 time-period to allow reasonable opportunity for non-local sockeye stocks to pass to their terminal streams.

The Board's July 2018 emergency regulations related to this fishery were highly appreciated and well considered, but did not efficiently or effectively deal with a reasonable sharing of conservation burdens when Chignik stocks need protective measures in Area M waters. Chignik's sockeye early and late run need protective measures in Area M waters most especially in the Shumagins Islands fishery. Board action on this front would be reasonable at this time given the failed 2018 Chignik sockeye runs and the Board's adopted Policy for the Management of Sustained Salmon Fisheries (5 AAC 39.222). While this is an in-cycle issue the issue may very likely not be adequately addressed by the current proposals because the 2018 salmon season had not yet occurred, which highlighted an obvious deficiency in the current South Alaska Peninsula management plans.

3) WHAT SOLUTION DO YOU PREFER? Or, if the board adopted your solution, what would the new or amended regulation say?

Requested is a three-part approach: Part 1 amends the June management plan by establishing concurrent fishing for all gear types with windows during which fishing is closed to all gear types (See Figure 2). Part 2 is triggered if commercial harvests in Chignik are not likely to meet minimum requirements similar to the current Cape Igvak and Southeast District Management Plans (See Figures 3 & 5). Part 3 is triggered if escapement goals are not achieved in Chignik. The regulatory language would be as follows:



#### 5 AAC 09.365 – South Unimak and Shumagin Islands June Salmon Management Plan

- (a) <u>amend to read:</u> The South Unimak and Shumagin Islands June fisheries harvest both sockeye and chum salmon in a mixed stock fishery during June. The sockeye salmon are predominately west-bound Bristol Bay, and east-bound Chignik and other stocks including Upper Cook Inlet and Kodiak fish. South Alaska Peninsula stocks are a minor component. The chum salmon are bound for a number of areas, including Japan, Russia, the Arctic-Yukon-Kuskokwin, Bristol Bay, and Alaska Peninsula, and southcentral Alaska. These stocks have historically been harvested along the south Alaska Peninsula during June. The management plan is intended to be consistent with the Policy for the Management of Sustained Salmon Fisheries (5 AAC 39.222) and the Policy for the Management of Mixed Stock Salmon Fisheries (5 AAC 39.220).
- (g) add to read: Notwithstanding (d) (1)(A)(B) and (d)(2)(A)(B) in the South Central District, Volcano Bay Section of the Southwestern District, and the Southeastern District except as provided in the Southeastern District Mainland Salmon Management Plan under 5 AAC 09.360, the seine and gillnet fisheries will run concurrently and begin on June 10 at 00:00 hours and run 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours; subsequent fishing periods will begin at 00:00 hours three days later and run for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours until 24:00 hours two days later; commercial fishing will then close for 72 hours; the final fishing period will end at 24:00 hours (midnight) on June 30.

- (i) <u>add to read:</u> Notwithstanding any other provision of this section, if the Department projects that Chignik's early sockeye salmon run escapement goal will not be achieved, all commercial salmon fishing periods in the South Central District, Volcano Bay Section of the Southwestern District, and the Southeastern District except for the Southeastern District Mainland, are suspended until minimum escapement is reached.

# 5 AAC 09.366 Post-June Salmon Management Plan for the South Alaska Peninsula

(a) <u>amend to read:</u> The purpose of this management plan is to provide management guidelines to the department for the management of the post-June salmon fisheries along the South Alaska Peninsula, to provide for the harvest of local stocks in terminal harvest areas, identify that non-local sockeye salmon stocks are intercepted including Chignik-bound sockeye salmon, and provide for both Chignik escapement and a Chignik harvest preference in the non-terminal harvest areas of the South Alaska Peninsula in the South Central District, Volcano Bay Section of the Southwestern District, and the Southeastern District salmon except as otherwise provided in the Southeastern District Mainland Salmon Management Plan under 5 AAC 09.360, and to establish fishing periods for the South Alaska Peninsula salmon fisheries outside of terminal harvest areas.



(k) <u>add to read:</u> Notwithstanding (c)(1) and (c)(2), (d)(1),(d)(2), and (c)(2), from July 6 through August 8 in the South Alaska Peninsula South Central District, Volcano Bay Section of the Southwestern District, and the Southeastern District salmon fisheries except as otherwise provided in the Southeastern District Mainland Salmon Management Plan in 5 AAC 09.360, if less than 300,000 sockeye salmon have been projected to be harvested by July 7 in the Chignik Management Area (as described in 5 AAC 15.100) and after July 8 if the Department projects that less than 600,000 sockeye salmon will be harvested in those same waters, commercial fishing periods will begin on July 6 at 06:00 hours and run for 18 hours until 00:00 hours. the next day; commercial fishing will then close for 78 hours; subsequently fishing periods will begin at 06:00 hours and run for 18 hours until 00:00 hours the next day; commercial fishing will then close for 78 hours and reopen at 06:00 hours three days later. Commercial salmon fisheries in designated terminal harvest areas per 5 AAC 09.366 (f) (1) are excluded from 5 AAC 09.366 (k) provisions.

(1) <u>add to read:</u> Notwithstanding any other provision of this section, from July 6 through August 8 in the South Alaska Peninsula South Central District, Volcano Bay Section of the Southwestern District, and the Southeastern District salmon fisheries except as otherwise provided in the Southeastern District Mainland Salmon Management Plan in 5 AAC 09.360, if Chignik sockeye escapement goals are not being met all commercial salmon fisheries in designated terminal harvest areas per 5 AAC 09.366 (f) (1) are excluded from 5 AAC 09.366 (l) provisions.



4) STATE IN DETAIL HOW THIS ACR MEETS THE CRITERIA STATED BELOW. If one or more of the three criteria set forth below is not applicable, state that it is not.

- a) for a fishery conservation purpose or reason:
  - In 2018 there has been no Chignik sockeye fishery and the likelihood of any local-stock alternative salmon fisheries occurring this season is dubious at best. Chignik's early (Black Lake) and late (Chignik Lake) sockeye runs have failed; both runs are substantially below minimum escapement objectives. It is well known that Chignik sockeye have significantly contributed to the South Peninsula fishery in 2018, based on WASSIP data alone (see table below), particularly in the Shumagin Islands where there is no conservation tie limiting the harvest of Chignik-bound salmon or on any other non-local salmon stocks either in June or July. Local South Peninsula Sockeye stocks comprise less than 1% of the sockeye harvested in the South Peninsula. Note also that if WASSIP data had been collected and analyzed for 2018 that it would show virtually 100% of the harvest of Chignik sockeye being harvested in the South Peninsula of Area M. In accordance with the Policy for the Management of Sustained Salmon Fisheries (5 AAC 39.222) it is most warranted that the BOF instate a conservation assignment on the South Alaska Peninsula interception fishery to provide a level of protection and assurance of sustainability on Chignik bound sockeye salmon.

c) to correct an effect on a fishery that was unforeseen when a regulation was adopted: When the current regulations for the South Peninsula of Area M were instated it was unforeseen that Chignik's first and second runs of sockeye salmon would ever be impacted to where minimum escapements would not be reached or that there would be zero harvest opportunity for Chignik fishermen. Because it is known that Chignik bound sockeye stocks are harvested in the South Peninsula in significant numbers based on WASSIP and it were foreseen that minimum Chignik escapements might not be met on some years, expectedly the Board would have assigned a conservation requirement on Chignik sockeye salmon in Area M's South Peninsula fisheries. Because neither the Board nor the Department foresaw this problem, this ACR is necessary.

- VIII. Resolution to the Commissioner: Motion to adopt the resolution made by Alfredo. Seconded by Clinton. CRAA explained that consideration to manage 2019 fishery on the lower end escapement goals would benefit the fishery with some economic relief. Al expressed opposition to using the resolution as a vehicle to use minimum escapement #'s (first component). We would have fished had this been implemented in 2018 and would have jeopardized escapement even more. Alfredo reminded the AC of the inaccuracy of the sonar used in 2018 as witnessed by subsistence and sport users who reported lack of fish in and above the river. Al would like to see the escapement numbers and timing used from the past when the run was built back up successfully. Also, he emphasized the importance of carcass value to the production of the system. Alfredo mentioned a jack sockeye problem with some estimates approaching 20% of returns as having less value to production returns. Concern is shared that the management practices are not showing improvement to the returns. Fish are smaller. Returns are weaker and later. Al shared concern that any cross area genetic studies would show less Chignik composition now that our runs were so weak. Wally remembers fishing three days a week from 6am to 6pm to build up run. Fishing is so much more efficient in all areas now though. Conservative practices are needed. Shared sentiment is minimal escapement will produce minimal returns.

Motion to strike the first component in its entirety from the resolution made by Alfredo. Al seconds. Motion to amend passes unanimously.

Al inquires if the northbound fish at Igvak being counted towards Chignik is being addressed by the department. Jeff answered that it is addressing a lot about Chignik but nothing will be done until after the board cycle. Look for proposals then. Al reminds the department that we rely on predictions and the brood tables are including fish from other areas as Chignik stocks.

Working with the department in the future is looked upon favorably. Ben asked Nick what the reason was to not run the GSI sample in August. Nick responded that it was not part of the designed operational plan in place and that data from the late season would not be used for lack of a mechanism to include it.



Ben asked what is the harm in getting the GSI information when it could be useful in showing a need for extending or increasing the grant that funds the study. It seems absurd to let the information rot. Nick responded partially that samples aren't run for three years in most genetic studies.

Motion to approve the resolution as amended passes unanimously.

 IX. Other Miscellaneous Business: Motion to have Jacob approve the minutes of both December meetings made by Ben. Seconded. Unanimous approval given. An approved copy will be sent to AC members for review.

The "Dolgoi Area" is located in the middle of Area M, making it easily accessible for both King Cove and Sand point fishermen. The local set netters and small seiners from the area depend on this area because of it's protected waters and accessibility. The regulations that limit the fishery are closures that allow opportunity for sockeye to move through the area. The individual gear groups are off the fishing grounds for 1/2 the month of June and 2/3 the month of July. The time closures do not include the days missed due to weather. Our fishing gear has been reduced in depth causing it to be less efficient.

The 2016-2018 regulations which limited the Dolgoi Island Area to a trigger of 191,000 sockeye effected fishing in 2016-17 with complete closure of designated areas. As expected with the low harvest rates of Chignik stocks in the Dolgoi Island area, there was no noticeable increase in Chignik harvest or escapement resulting from the closures in the Dolgoi Island Area.

The yearly stream of fish that pass through and have been historically harvested in Area M are depended on by our communities and residents. Our regulations that limit catches of the state's resources have attempted to be relative to the impact on individual stocks harvested in our area. Further restrictions for the June and July salmon fisheries are not warranted because of the lack of impact to stocks in the fishery.

Chairman Newton ask for volunteers to attend the Anchorage February 21, 2019 board meeting. The volunteers were Warren Wilson, Gary Mack, Herman Samuelson said maybe, and Grant Newton. Craig Bendixen volunteered from the community. All were approved unanimously.

#### VI. ADF&G Staff Updates:

ADFG wildlife update from Dave Crowley:

- Stated that moose composition counts have been completed in units 9b and 9c. Counts show increased calf survival and a bull/cow ratio of 30-35/1. He feels the ratio is biased in favor of bulls due to the difficulty of sighting cows and calfs during snowless surveys, which the state is working to correct in the data collection. Group discussion around warm temps effecting moose movements and makes for difficult hunting.
- Caribou counts completed for unit 9. Data has not been finalized.
- Bear counts completed in unit 9 show a slight decrease in population and decrease in harvest but the animals appeared to be bigger.
- Calf mortality study has been completed but no data available yet.
   Discussion, Bill T questioned if state and feds share survey data, Dave C answered yes and explained further.

ADFG Commercial fish report from Travis Ellison:



- 2018 was the largest ever recorded salmon return to Bristol Bay. All the nushagak district rivers exceeding escapement goals (provided escapement numbers) . Egegik was the smallest relative return but still met escapement goals. Discussion by the group that perhaps the ADFG counting towers were taken down too soon, especially on the Kvichak. Potential late runs going uncounted.
- The state is now funding counting towers on the Alagnak, Togiak, and Igushik Rivers.

ADFG Sport Fish report from Lee Borden:

- All rivers had good reports regarding numbers of sport fishing success, except the Iliamna River which numerous reports were received regarding low numbers of Dolly Varden.
- An emergency order bag limit reduction for sockeye was issued for the Kvichak River during a stretch of low returns but was later rescinded when large numbers of salmon arrived. Critical area closures were also issued and later rescinded for same reasons on the Kvichak River.
- Bag limits for sockeye were liberalized on the Alagnak River after a larger than expected return of salmon arrived.
- ADFG conducted a mortality study on catch and release chinook on the Nushagak River. Data revealed a 7% mortality rate on a sample size of 300 fish caught.

Eric B— If this area were curtailed, how much migration of effort would there be to areas more likely to catch BB stocks?

Lisa F—would push effort to Shumigans and Unimak

Mitch S-Asked about Orinsky (local S Pen system) escapement.

Lisa F–Orinsky lowest esc in 30 years. Other lesser systems all seemed weak.

Average historical total escapements for these combined systems is 78,000. Total in 2018 was 17,000.

Mitch S— Did dept restrict the section?

Lisa F-no direct changes, but no effort due to such low abundance.

Eric B asked Lisa F if this fishery had expanded time-wise over what had been historical.

Lisa F-gave a brief rundown of the fishery dates and it sounded like it had.

Eric B—since the setnet part of this fishery harvests a less % of Chignik stocks than the other user groups, is it fair to penalize them equally?

Chuck Mc—when the CFEC first issued permits, many who were issued seine permits, were also issued setnet permits. They would seine when that fishery was good, and



setnet during the other times. As years progressed, seiners sold off their setnet permits, causing the permits to be fished more often.

Eric B—to Lisa F: after this June fishery is done, when does this area again open? Lisa F—In August.

Eric B—can't imagine people in this area not being able to fish during a large part of the summer.

This was later clarified that the fishery in July is operated on set schedules, and in August it switches to an abundance/escapement management similar to BB and in last August no fishing was allowed in this area and fishing did not re-open until Coho management began in September.

# VII. ADFG and USFWS Staff Updates

#### 1. Commercial Fish Tim Sands:

Togiak Herring Forecast is available. New analysis of long time assessment methods was done. Resulted in much larger biomass estimates for 2019.

2019 Sac roe forecast to be over 26,000 tons.

Noted that the BOF changed the gear allocations at the fall meeting.

Sockeye salmon Forecast: approximately 10 million total run, expect about 8 million harvest. If Nushagak kings look good the commercial red fishery may start when there are 30,000 reds in the Wood River.

#### 2. Sport Fish Lee Borden

State wide harvest and effort data is beginning to be processed and 2018 estimates should be available mid summer.



2019 Field season: Creel survey scheduled for a month on the Nushagak River, count and interview anglers, sample harvested fish.

He noted the King Management Plan has changed and most triggers in the old plan have been removed for the sport fishery. The Plan is scheduled to be re-evaluated by a working group and recommendations will be presented at the 2020 BOF meeting. ADFG is soliciting members for the working group now.

Comment: It seems the man-use days on the Nushagak have really increased as there have been sport king closures across the state.

Concern: yes, with Cook Inlet sport closures already announced what kind of effort will come to the Nushagak in 2019? Fortunate that a creel survey is planned for 2019.

Sport Fish noted that recent annual effort on the Nushagak has been increasing, it's still less than peak use levels seen in the 90's or early 2000's.

#### 3. Wildlife Conservation, Biologist Neil Barten

Aerial wolf permittees waiting for suitable weather and snow conditions. Last year 30 wolves taken by air and about 50 by trappers and on the ground hunting. It appears to have helped as calf survival last summer was the best seen in 20 years.

Mulchatna Caribou harvest to date there are about 130 animals reported harvested but there are rumors that a number of animals have not been reported in the Kuskokwim area. Discussing reporting problems Barten says ADFG is brainstorming how to improve reporting and public education. The Department should consider using social media to help the problem.

17A Winter moose season was extended until the end of February as harvest so far is below desired levels.

#### 4. ADFG Board Support, Taryn Brito:

Alaska Peninsula / Aleutians Board Feb 21-26 in Anchorage was shortened by one day. \* Statewide Finfish and Supplemental Anchorage March 9-12. South Central meeting March 15-19 in Anchorage. \* Joint Boards to address AC issues and Process for adopting regulations March 21-25 in Anchorage. All meetings shortened.

No updates on work groups that were set up by the Board of Fish. News release on Nushagak King Salmon Plan group seeking nominations just went out.



#### AWT, Joe Wittkop:

Fall training prevented him from attending fall meeting and gave a summary of 2018 activities. Trooper Sgt Bump is the new area supervisor and based in King Salmon - formerly AST in Dillingham. Trooper Quist moved to another assignment.
Herring: used 32 foot patrol boat, very few violations and fishery was orderly. Joe participated in a joint patrol with Feds on the spring yellow fin sole fishery near Nushagak Peninsula - found no significant violations. Bear season was hampered by poor conditions, little participation and no violations found.

Sport fishing: for the first time in a while there were funds and staff to make sport fishing patrols. It was a team effort including use of the helicopter. No high rates of violations - typical violations were snagging, no licenses, expired licenses, incomplete log books and failure to record king harvest. Troopers were watching specifically for roe stripping but found none.

Commercial Salmon: Big fleet in the Nushagak and the Stimson was used. Violations proportional to the fleet size. Typical closed waters etc. What seemed an increase possibly due to poor weather, huge run, and big fleet was failure to report lost nets. Also fishing while grounded which may have been due to weather as well as fishermen less familiar with the sand bars and tides, and more jet boats in Nushagak. Wittkop emphasized that its not illegal to lose nets but failure to report is a violation. Fall Hunt: Very few violations, 1 accidental cow shot, 1 undersized moose by nonresident, 1 moose without a permit. There is still confusion regarding the terms for a registration vs General Hunt. Some concern for shooting grouse on the roads. Winter Moose; Trooper was out for training much of the season but hunting conditions were poor and effort seems to have been low.

There was a discussion wishing for better dispatch process for reporting fish and wildlife problems, need a system like the search and rescue dispatch that is excellent.

There was a discussion how illegal king salmon subsistence drifting /"seining" was worse in the middle reaches of the Nushagak River summer 2018. "Really bad" last summer with folks taking 50-80 per drift. Discussion moved to complaints of subsistence competing with sport anglers. Concerns also raised about the impacts of the extra large commercial fleet.

Troopers may try to work with upriver villages on a solution.

6. USFWS Togiak Refuge Superintendent Henry, Biologist Andy Aderman:Back to work recently and relieved to be able to attend the meeting.Aderman reported 2 items. 1) 10 caribou killed in the fall on the Nushagak Peninsula herd. 2) Federal enforcement does not shut down even if the rest of the Refuge staff furloughed. Also explained how Federal and State moose and caribou total bag limits are tied together not additive. Needs more public education.

Short discussion on AYK proposal RC 69 ceremonial king salmon. No action taken.

AC members agreed to address Joint Boards Proposals first and until noon when North Alaska Peninsula Area Commercial salmon Biologist Bob Murphy will be available to help with Area M proposals.

- Crab 179: Rowland/Shockley motion to support. Kelty discusses ongoing attempts at development of Golden King Crab fishery for last 5-6 years, this sets up a harvest strategy. Proposal 179 passes unanimously.
- Crab 180: Rowland/Good motion to support. Sets up king and tanner crab management strategy for under 60s in Adak area. ADFG not in support of way management strategy is written. ADFG and Tribe are both looking for grant money for weir at McLees Lake. Discussion re opportunities for future combo drone-weir work, drone-GIS work. Kathy Whiteside drone surveys not necessarily good for all rivers. Discussion re continuation of drone surveys.
