If non-local jig boats move into the Chignik area and they utilize all the jig quota it would raise the jig percentage for subsequent years, disrupting the local pot fishery. Members believe the super exclusivity must remain to maintain economic security for local boats. Two years ago, Chignik didn't have a salmon fishery and there is need to protect anything left we do have. Ben moves to oppose. Gene seconded.

Increase the guideline harvest level (GHL) for Pacific cod in the Kodiak Area to 17.5 percent of the estimated total allowable harvest of Pacific cod in the Central Gulf of Alaska Area and increase the pot gear allocation of the GHL to 65 percent (Frank Miles)
