

Proposal 41, Bristol Bay BoF 1 Dec 2023. DRAFT

(n) In the Nushagak District, a CFEC salmon interim-use or entry permit holder may not set or operate a set gillnet seaward of set gillnets operated by another CFEC salmon interim-use or entry permit holder. In addition, no part of a set gillnet, anchor, peg, stake, buoy, or other device used to set the gillnet may be seaward of the following offshore locations:

(3) from First Creek at 58 47 03.41 N. 158 30 44.56 W. Log., [58° 47.15' N. lat., 158° 30.57' W. long.] to 58 46 59.47 N. Lat., 158 30 33.56 W. Long., to 58 46 51.94 N. Lat., 158 29 47.71 W. Long., to Third Creek 58 46 37.71 N. Lat., 158 28 09.28 W. Long., 800 [700] feet from the mean high tide mark[, at 58° 46.81' N. lat., 158° 28.10' W. long.];

(4) from Third Creek at 58 46 37.71 N. Lat., 158 28 09.28 W. Long. [58° 46.81' N. lat., 158° 28.10' W. long.] to 58 46 28.11 N. Lat., 158 27 03.26 W. Long., to 58 45 44.89 N. Lat., 158 24 34.22 W. Long., to 58 45 16.95 N. Lat., 158 23 28.21 W. Long., to 58 44 42.64 N. Lat., 158 22 32.71 W. Long., to 58 43 25.02 N. Lat., 158 21 10.28 W. Long., to 58 41 58.31 N. Lat., 158 20 34.73 W.
