management issues, updates on Alaska hatchery research project, wild and hatchery stock
interactions, straying issues, cost recovery, funding and corporate structure, and biological
considerations. Indicate how the Department implements the SSFP precautionary approach and the

- Should independent research be conducted to ascertain what, if any, impact the hatcheries' release of pink salmon may have on other species?
- Is a precautionary approach being implemented when managing hatcheries? If so, is it working?
- Should the Alaska salmon fishery enhancement program be used to rehabilitate depleted king salmon runs across Alaska?
- How can the Department better communicate accurate information about the Alaska Salmon fishery enhancement program?

BOARD DISCUSSION

- How or at what point do we conclude that the goals of the salmon fishery enhancement program have been met or exceeded? How is "enhancement" assessed or quantified?
- Is the Hatchery Committee effectively implementing the Joint Protocol on Salmon Enhancement?
- Should the board limit the call for proposals related to the salmon fishery enhancement program?
