Subject: Emergency Petition – Dutch Harbor Subdistrict State-Waters Pacific Cod

Dear Mr. Nelson,

The purpose of this letter is to formally request an emergency petition be considered by the Board of Fish with the following requests:

Open the Dutch Harbor Subdistrict state-waters Pacific cod season for pot gear vessels less than 60 feet 72 hours after the Federal BSAI closure for this sector. This is a change from the current 7 days that is in regulation.

Increase the pot limit from 60 pots to 90 pots for the Dutch Harbor Subdistrict state-waters Pacific cod season for vessels less than 60 feet.

The above requests come in a time of unprecedented market conditions and are necessary to preserve the general welfare of the fleet. Pacific cod ex-vessel prices are currently half of what they were one year ago. Additionally, markets have limited participation in the under 60 fleet to levels that will likely prevent the 2024 GHL from being met. This has the potential to negatively impact the general welfare of the fleet in years to come.

Alaska Statute AS 44.62.250, Emergency Regulations allows for emergency action be taken to immediately preserve "general welfare". Given the sudden decline in the State of Alaska fisheries it is our opinion that the Board of Fish has the authority to take emergency action to preserve the general welfare of the under 60 fleet.

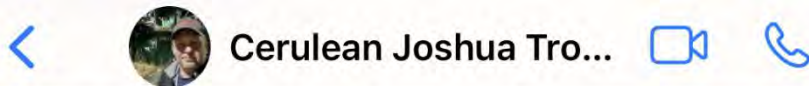
