- 1) This agenda is TENTATIVE and subject to change during the meeting. A list of staff reports and roadmap will be available at the meeting. Schedule updates will be posted at the meeting. An audio of the meeting should be available at the Board of Fisheries webpage (<a href="http://www.adfg.alaska.gov/index.cfm?adfg=fisheriesboard.main">http://www.adfg.alaska.gov/index.cfm?adfg=fisheriesboard.main</a>) during periods when the board is on the record.
- 2) Testimony is expected to be limited to <u>three</u> (3) minutes for individuals and groups and <u>ten</u> (10) minutes for advisory committee representatives and regional advisory council representatives. These times may be changed by the chair in order to manage the volume of the workload. Advisory committee and regional advisory council representatives may present reports either at the beginning or end of public testimony. The representative should notify the board secretary whether he or she prefers the beginning or end of public testimony.
- 3) NEW PUBLIC TESTIMONY PROCESS: The board is setting aside its first weekend, February 24–25, for scheduled public testimony. Scheduled public testimony will be in "time blocks" of the morning or afternoon on either Saturday or Sunday.
  - a. Individuals seeking to sign up for a time block must do so by 3:00p.m. Friday, February 23, at the meeting. If you do not wish to sign up for a time block, the deadline to sign up for public testimony is 10:00a.m. Saturday, February 24.
  - b. Individuals signing up for scheduled public testimony may do so through another individual who is at the meeting facility on Day 1.

- c. Each morning or afternoon time block will allow for between 40-50 testimonies. The blocks will be filled on a first come basis.
- d. If the board does not complete testimonies by everyone signed up for a morning block, it will complete those testimonies after the lunch break of that day. The board will complete all testimony in the afternoon blocks before adjourning for the day.
- e. Individuals scheduled in a time block who miss their first call will be called a second and final time at the end of the day they are signed up to testify.
- f. Individuals who do not sign-up for a time certain slot will be listed separately and called as time remains during the time blocks or once all scheduled testimony is complete. These individuals who receive and miss their first call during scheduled testimony, will receive a second call after all scheduled testimony is complete.
- g. Boards Support will post the lists of the scheduled public testimony time blocks at the meeting hall by 5:00p.m. on Friday, February 23 and on the Upper Cook Inlet Finfish meeting page website at <a href="https://www.adfg.alaska.gov/index.cfm?adfg=fisheriesboard.meetinginfo&date=02-23-2024&meeting=anchorage">https://www.adfg.alaska.gov/index.cfm?adfg=fisheriesboard.meetinginfo&date=02-23-2024&meeting=anchorage</a>
- 4) BOARD COMMITTEES AND PUBLIC PANELS: Committee of the Whole will serve as the committee structure for this entire meeting. Under Committee of the Whole, all board members will join and full audience participation is encouraged. Advisory committee representatives are ex-officio advisors to all board committees. The purpose of the committee process is to: 1) broaden public participation in the regulatory process; 2) provide another forum for stakeholders to discuss resolution of contentious issues; and 3) provide additional detailed information relative to proposals.
- 5) COMMITTEE WORK AND DELIBERATIONS: unless time limitations become a constraining factor, the board does not intend to deliberate the proposals from any committee session on the same day the committee session is held. This gives board members and the public more time to develop amendments or additional written comment. The board plans to conduct the deliberations as the first item of business on the following day.
