Alaska Board of Game Meeting Scheduled March 18, 2021

The Alaska Board of Game (board) will conduct a regulatory meeting on Thursday, March 18, 2021, via web-conference beginning at 9:00 a.m. The purpose of the meeting is to address annual reauthorizations for antlerless moose hunts and brown bear tag fee exemptions for all game management units, and other miscellaneous topics including: 1) sealing requirements for wolves taken in Unit 2; 2) aligning seasons and bag limits for moose in Unit 15B on the Kenai Peninsula; and 3) options for reissuing the Call for Proposals for the 2022 Central/Southwest Region and the 2022 Statewide Regulations meetings.

In addition to proposals, the board will receive reports from the Department of Fish and Game on topics including: Spring brown bear hunts in Units 8 and 9; Mulchatna caribou herd; and Fortymile caribou herd hunt management plans.

The board will not be taking oral testimony during the meeting.

Written comments on proposals must include the proposal number(s) for which the comments pertain, and the submitters first name, last name, and community of residence. Comments submitted by March 5, 2021 are limited to 100 pages/50 double sided pages in length.
