#### HB 201

Jahnke: has an issue with HB 201

Whitehead: thanks to all in attendance and the process we have to affect fish and game regulations. I am the secretary for the three POW AC's.

We have a real problem with seasonal residents and our fish and game.

People are buying property, living on their boats or living in an RV for a short period of time, parking it and being able to claim Alaska residency. It's easy to get an Alaska driver's license, p.o. box and then claim residency. We have done our research, and found multiple individuals who are doing this. Taking advantage of the benefits that being an Alaska resident provides individuals to pursue more liberal bag limits for species, especially in the area of subsistence.

I have spoken with 23 different legislators and highlighted this issue. This is more of an issue in Southeast Alaska with our abundant resources and access compared to communities up north. We also have a larger seasonal influx of people.

I'm looking for the Ketchikan AC to write a simple letter in support of HB 201.

To address Bob's concern, the requirements to receive an Alaska PFD will be the same for obtaining resident fishing, hunting and trapping licenses.

It would be great to be able to not only sign up to receive your PFD but also simultaneously get your fish and game licenses.

Jahnke: It is my understanding that there are allowances for missing time to address health care and other circumstances. I'm in support of this bill but would like to see the number of days one is allowed to be absent to be less.

Tibbles: The 180 days has to be for allowable reasons.

Atwood: I'm concerned that if this is based on a calendar year that if someone isn't here January 1st then they would have to wait a long time to qualify.

Whitehead: We're just trying to ratchet up the requirements and make them easier to enforce.

Bezenek: Moved to AK in 93'. We waited until December of 94' before we qualified as residents. I waited and was willing to wait for the benefits of our resources. I will support HB 201.

I bought a non-resident license my first year and I was willing to do that for the benefit of hunting and fishing, also appreciating I would continue to benefit from our resources as a resident.

Jahnke: I'm concerned how this would affect trapping licenses since they have different season start and end dates.

Dorendorf: When purchasing a combination hunting/trapping license, the hunting license terminates at the end of the calendar year and the trapping license later in the next calendar year. The Bill wouldn't affect this.

Dale: Is this group looking to work up a letter of support? Kurt, is there a deadline we are looking at.

Whitehead: We're looking to get as many letters as possible in support of this HB 201.

Franulovich: We need to decide if we want to support a letter

Franulovich: Move to support

Jahnke: 2nd

McTurner: Call the question

Support: 10, Oppose 1

Jahnke: I'd like to change the wording a bit from the Petersburg letter. Instead of a privilege, I would like to see priority.

Atwood: Or right.

Franulovich: I'd like to keep a letter as simple as possible.

Bezenek: How about for simplicity sake we say the Ketchikan AC supports HB201 and that using the requirements to attain the permanent fund makes good sense for obtaining resident hunting, fishing and trapping license.

Jahnke: I believe that residents deserve to have priority in pursuing our fish and game resources.

Smith: Does this Bill tie a hunting and fishing license to qualifying for a PFD or maintaining your ability to receive a PFD?

Multiple members of the AC make the point that this will be discussed in the legislature and changes may very well be made.

Dale: What jumped out at me is that the Department would stand to get a little bit more money from non-resident licenses. A loophole is closed and maybe if you're new to the State you shouldn't pursue some of the opportunities residents have until you have the experience necessary to do so.

Smith: 12 months seems fair to me but if it turns to 24 months to obtain residency it's a burden.

McTurner: Compared to other states the cost of our licenses is less expensive and we have more opportunity.

Dale: Are we okay firing this off tomorrow? I'll write to Rebecca and would like to thank her for punctuality. The letter will say that we support HB 201 as written.

#### Proposal 211

Dale: Do we support Proposal 211? Looking to clean up the boundary for RG002. My only concern would be if the Department had a concern about the resource and they didn't indicate there was one. In my mind this is house cleaning.

This is a mess we created due to an oversight. I appreciate the Departments efforts to clean it up

Dale: I just wanted to comment that we support the Department and Hatchery efforts to put more fish in the water.

Jahnke: Is Whitman Lake still a SSRAA hatchery? Is it still commercial fishermen that are primarily supporting Whitman Lake. Commercial fishermen pay 3%.

Allen: Yes. Commercial fishermen are still the primary user group that supports our programs through a self-assess tax. However, the Department does provide financial support to some of our programs and they currently own the Crystal Lake Hatchery. We also have a co-operative agreement to rear and release triploid Rainbow Trout into Harriet Hunt and Carlanna Lake.

I would encourage anyone who takes advantage of these resources to support the Department and our non-profit hatcheries so we can continue doing what we do for as long as we can do it.
