Findings: We surveyed this cataloged stream and found that the stream path is incorrectly mapped. The lower reach of the stream should be extended for clarification, particularly in light of potential alternatives identified for eventual construction of a second bridge crossing between Juneau and Douglas.

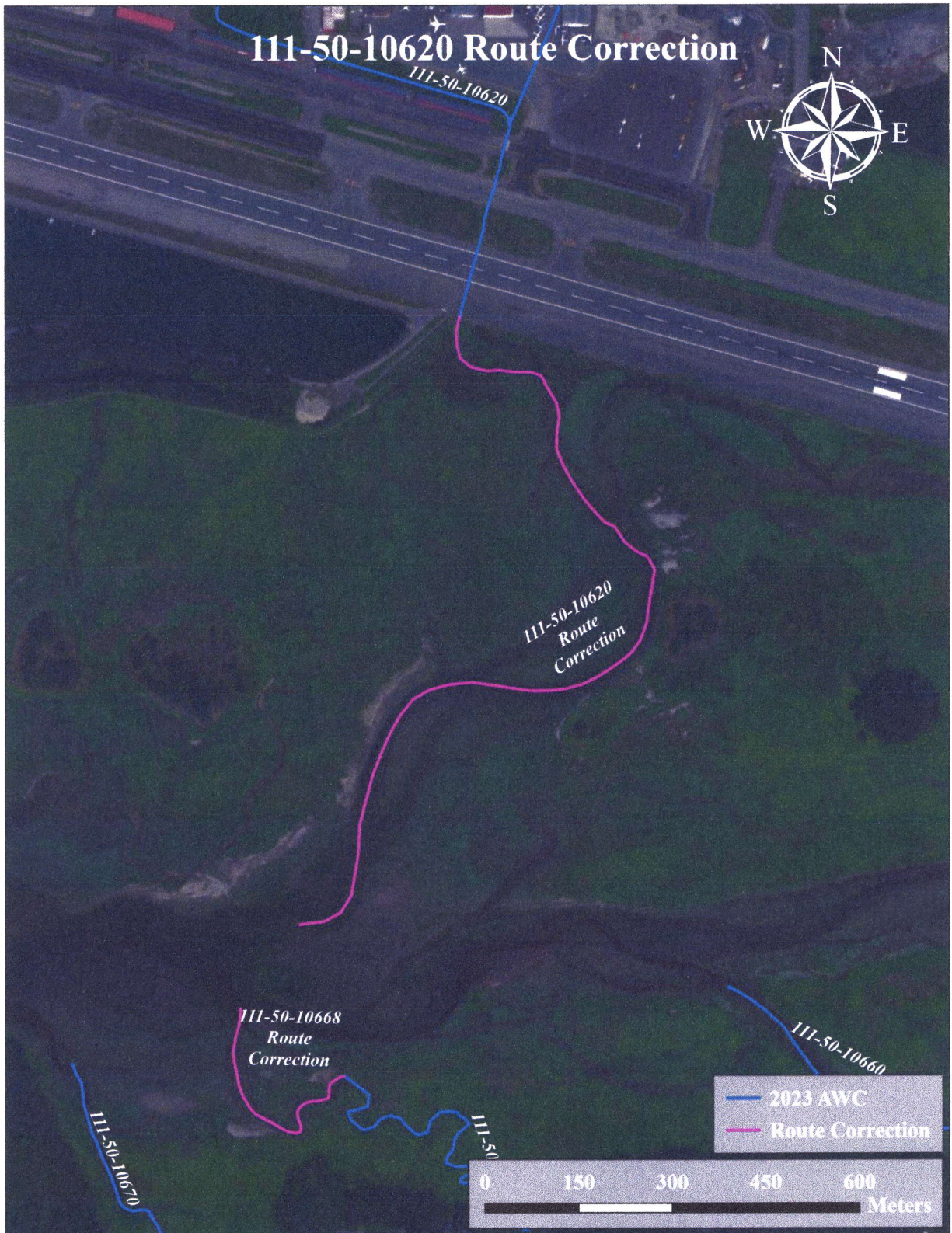


Figure 1.—111-50-10620 route correction map.

Recommendations: Correct Stream No. 111-50-10620 in the anadromous waters catalog to reflect the field verified stream path. Please extend stream into the intertidal (Figure 1).
