




Figure 2.–114-31-10130 tributary 3 addition map.

**Findings:** We surveyed this uncataloged stream using a baited minnow traps and GPS and captured juvenile coho salmon. The tributary stream seeps out of the ground near the road and flows through a fairly undefined channel (Table 1; Figure 1). Coho salmon were returned to the stream prior to obtaining a photo; however, identification was confirmed by a Habitat Biologist. **Recommendations:** Add this uncataloged stream to the anadromous waters catalog for rearing

coho salmon (Figure 2). **Nomination:** Pending
